





Connect the USB-A port to the adapter, and the other end to the device.




USB cable

### Battery Installing

Slide and align the battery into the battery compartment and press the battery firmly. Then place the battery cover back and lock the battery release latch. As shown in the pic:

- Power on: Press and hold the power key until you see a splash screen on the device.
- Power off: Press and hold the power key until the device is shutdown.
- Forced restart: Press and hold the power button for 10 seconds.
- Fast Restart: Powered off the device and replace the main battery within 5 minutes, and then press the power key to restart instantly(spare battery version only).
