





ii) Installation of approved wireless modules

If no integrated wireless LAN Mini-PCI Card or RF CDC module has been preinstalled in your ThinkPad computer, you can install one, provided by IBM as an option. Plug the wireless card option into the Mini-PCI Card slot or CDC slot located under the expansion slot cover of your ThinkPad computer as shown below.




