


Fig.2.1 (Head tissue)




Fig.2.2 (Body tissue)




Fig.2.3 (Head tissue)




Fig.2.4 (Body tissue)






Fig.3 EUT Front side to flat phantom






Fig.4 EUT Back side to flat phantom




Fig.5 Front view of EUT




Fig.6 Back view of EUT


