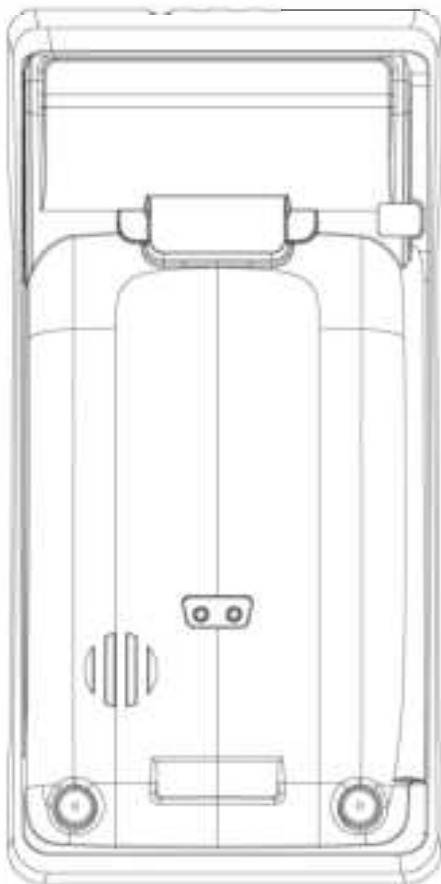

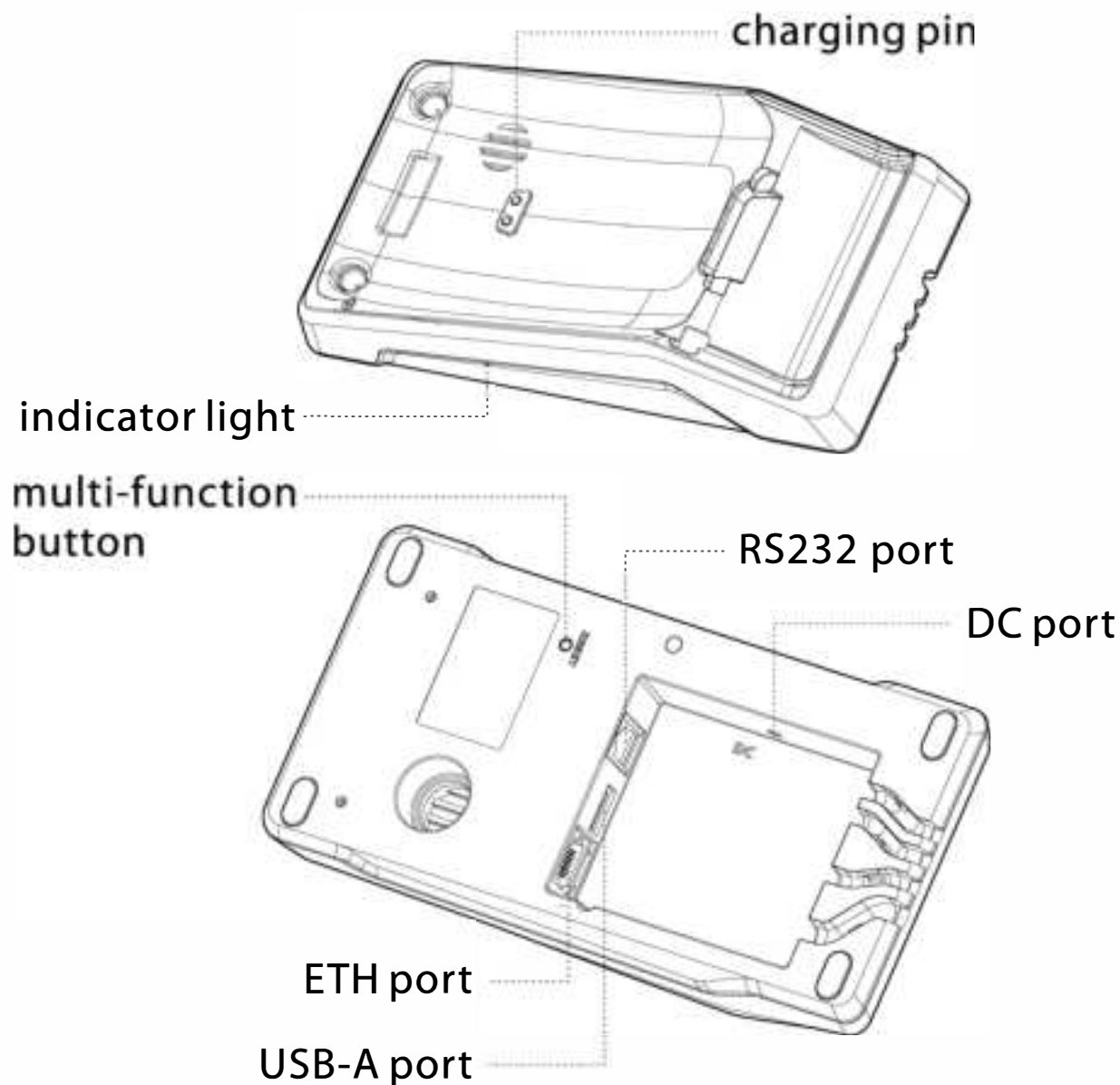

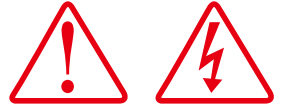

01 / Safety precautions
