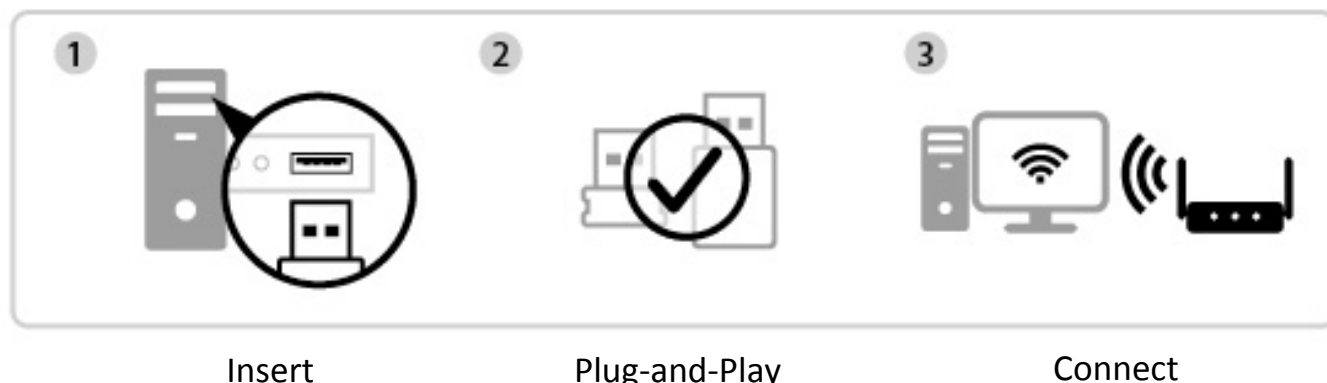

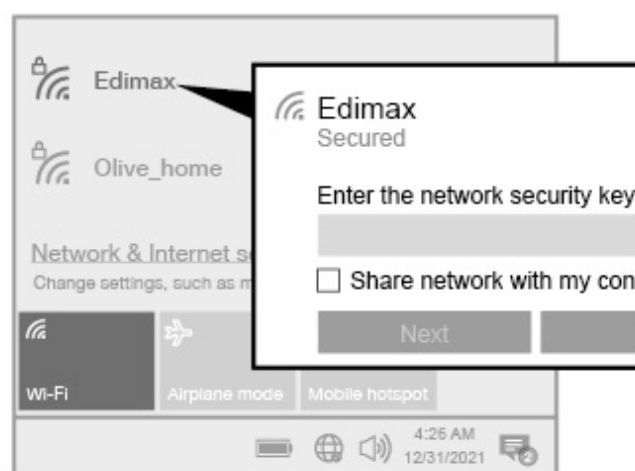
If your Windows OS cannot support Plug-and-Play, please go to section II-2, download and install driver.

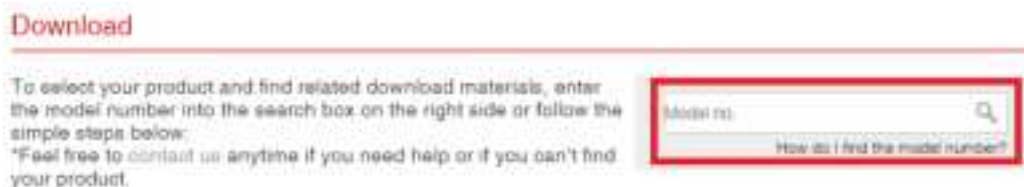


II-1. Insert the USB Adapter

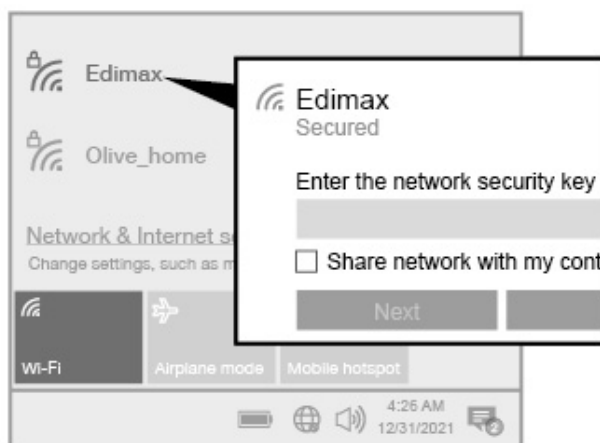

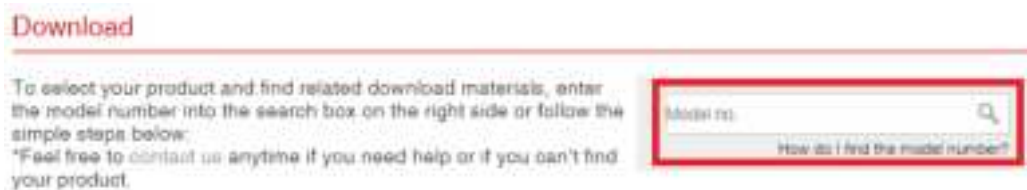


