







#### **General Antenna Parameters and Design**

Electrical Delay (one direction)	1.198 ns

After long term use with 100W radiated power, only a slight warming of the dipole near the feedpoint can be measured.

The dipole is made of standard semirigid coaxial cable. The center conductor of the feeding line is directly connected to the second arm of the dipole. The antenna is therefore short-circuited for DC-signals.

No excessive force must be applied to the dipole arms, because they might bend or the soldered connections near the feedpoint may be damaged.








Figure E1. Right side cheek/touch configuration




Figure E4. Left side tilt configuration




Figure E5. Body worn configuration, keychain holster, headset attached
