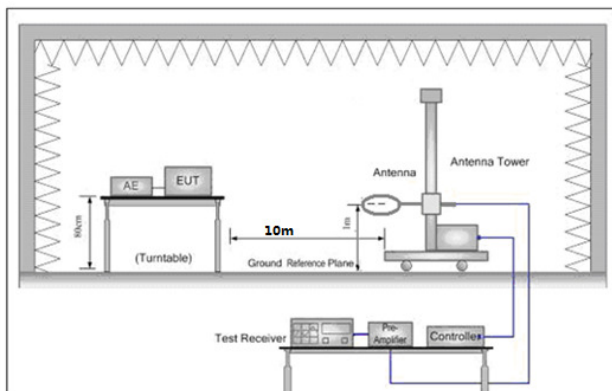


Figure 1. Below 30MHz

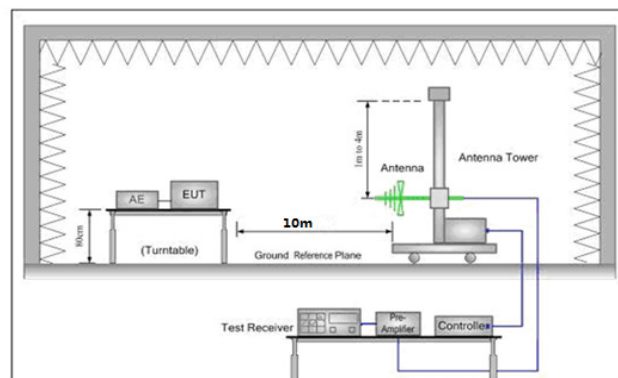


Figure 2. 30MHz to 1GHz

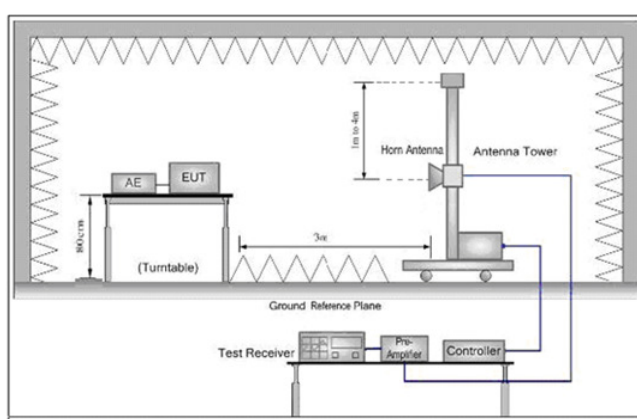


Figure 3. Above 1 GHz

**Test Procedure:**

- The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 10 meter semi-anechoic chamber for below 1GHz test and at a 3 meter anechoic chamber for above 1GHz test. The table was rotated 360 degrees to determine the position of the highest radiation.

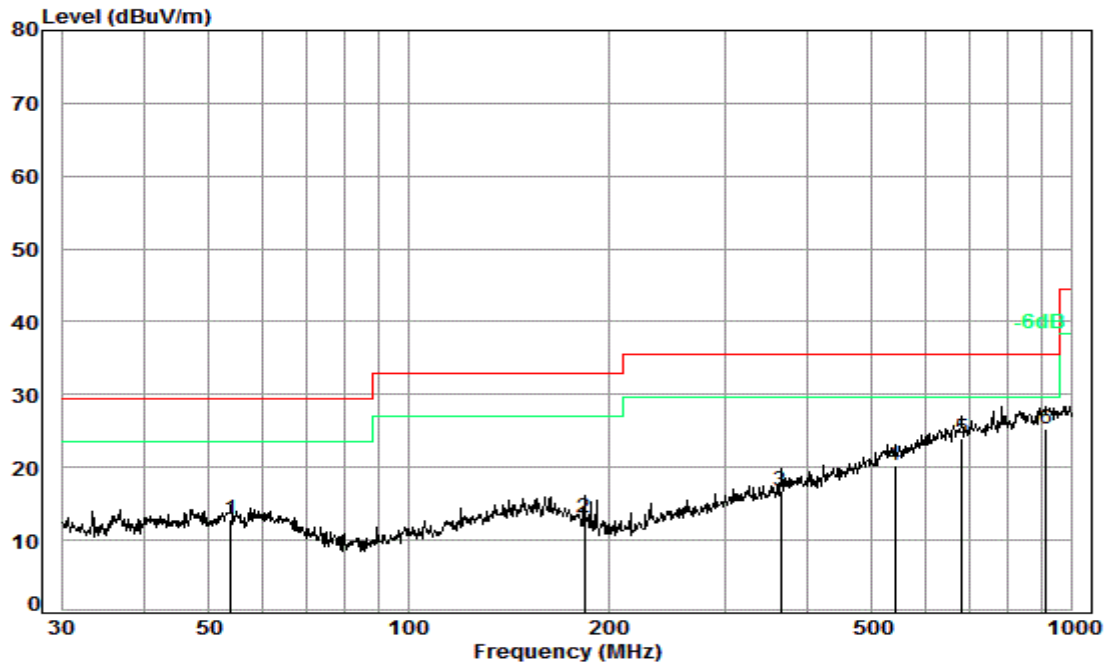

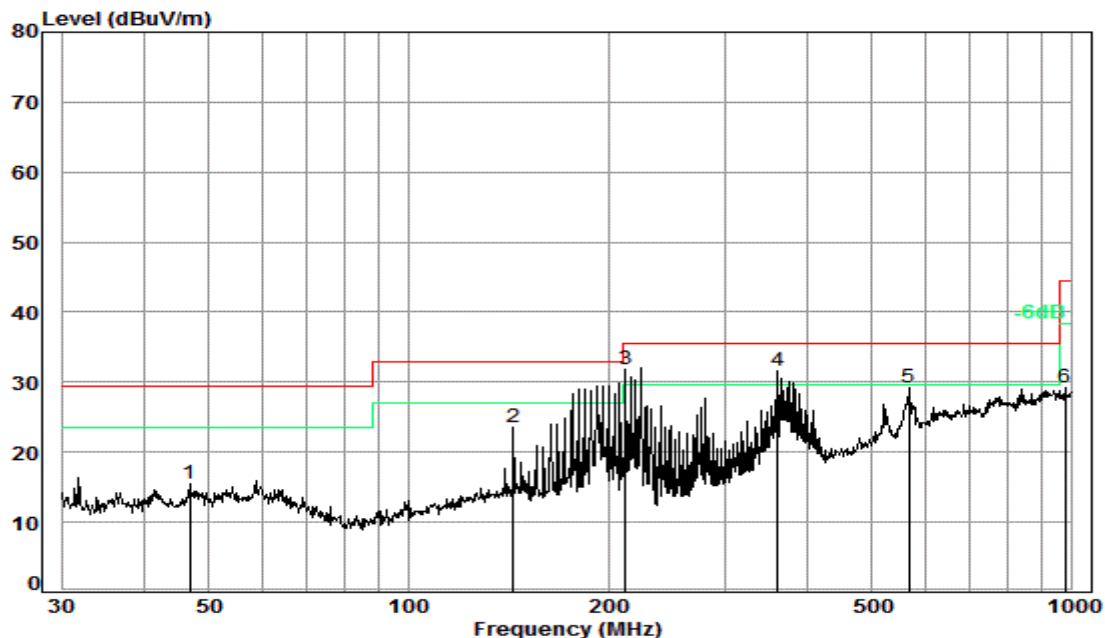

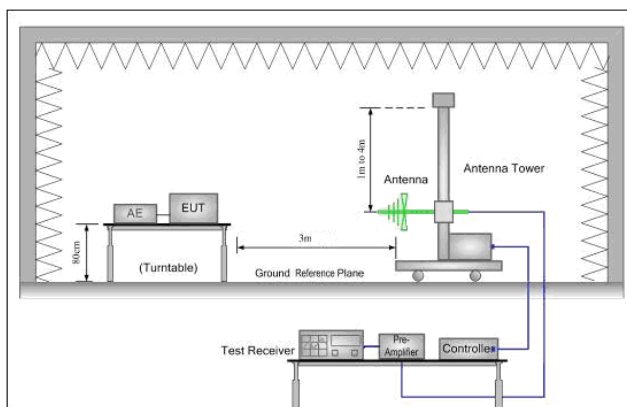


Figure 1. 30MHz to 1GHz

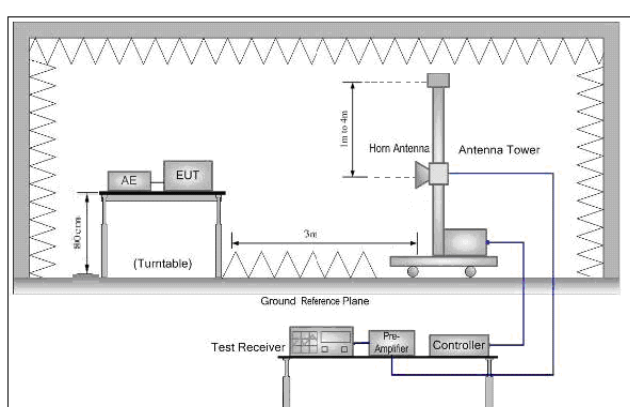


Figure 2. Above 1 GHz

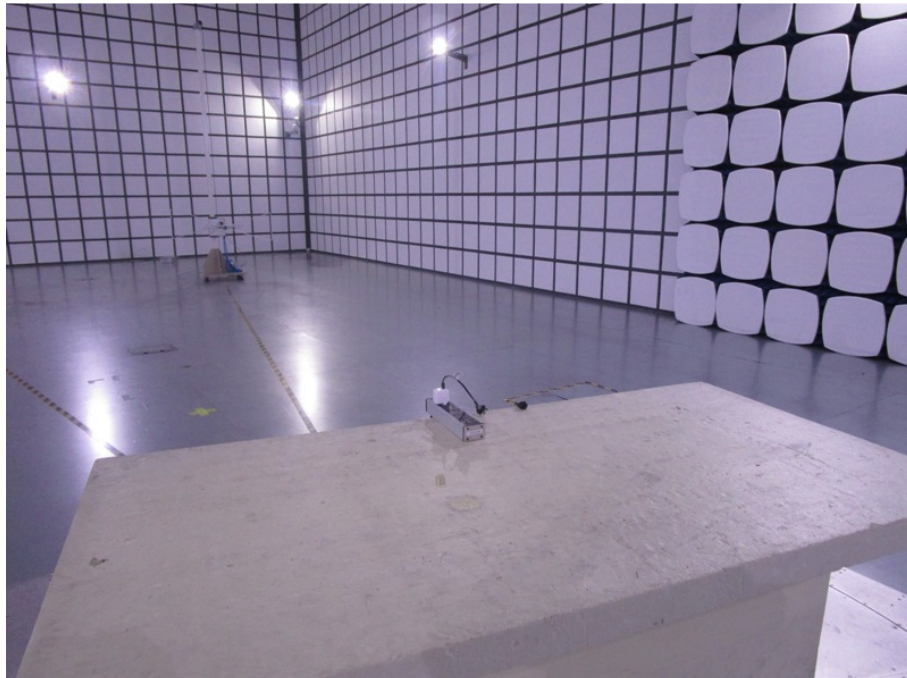
