


Coil (5W-EPP:15W)

Coil (MPP:15W)





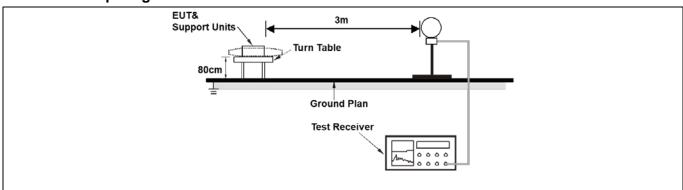
