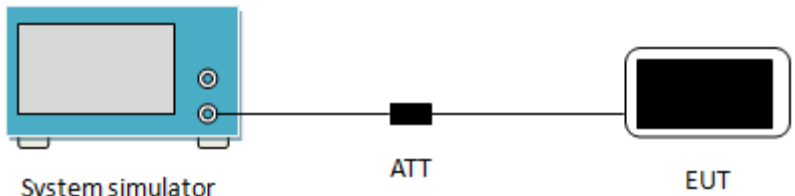

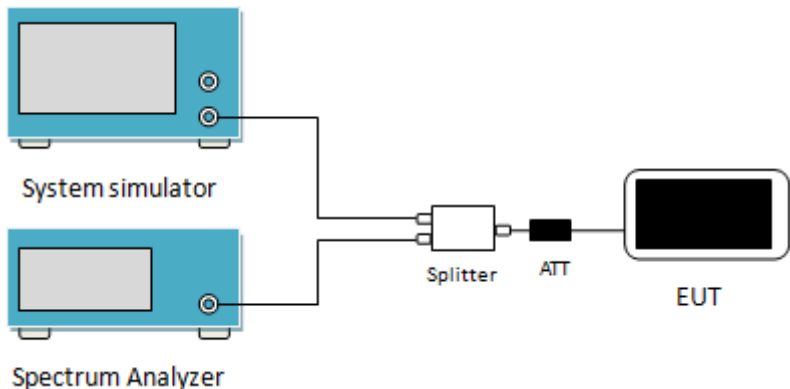

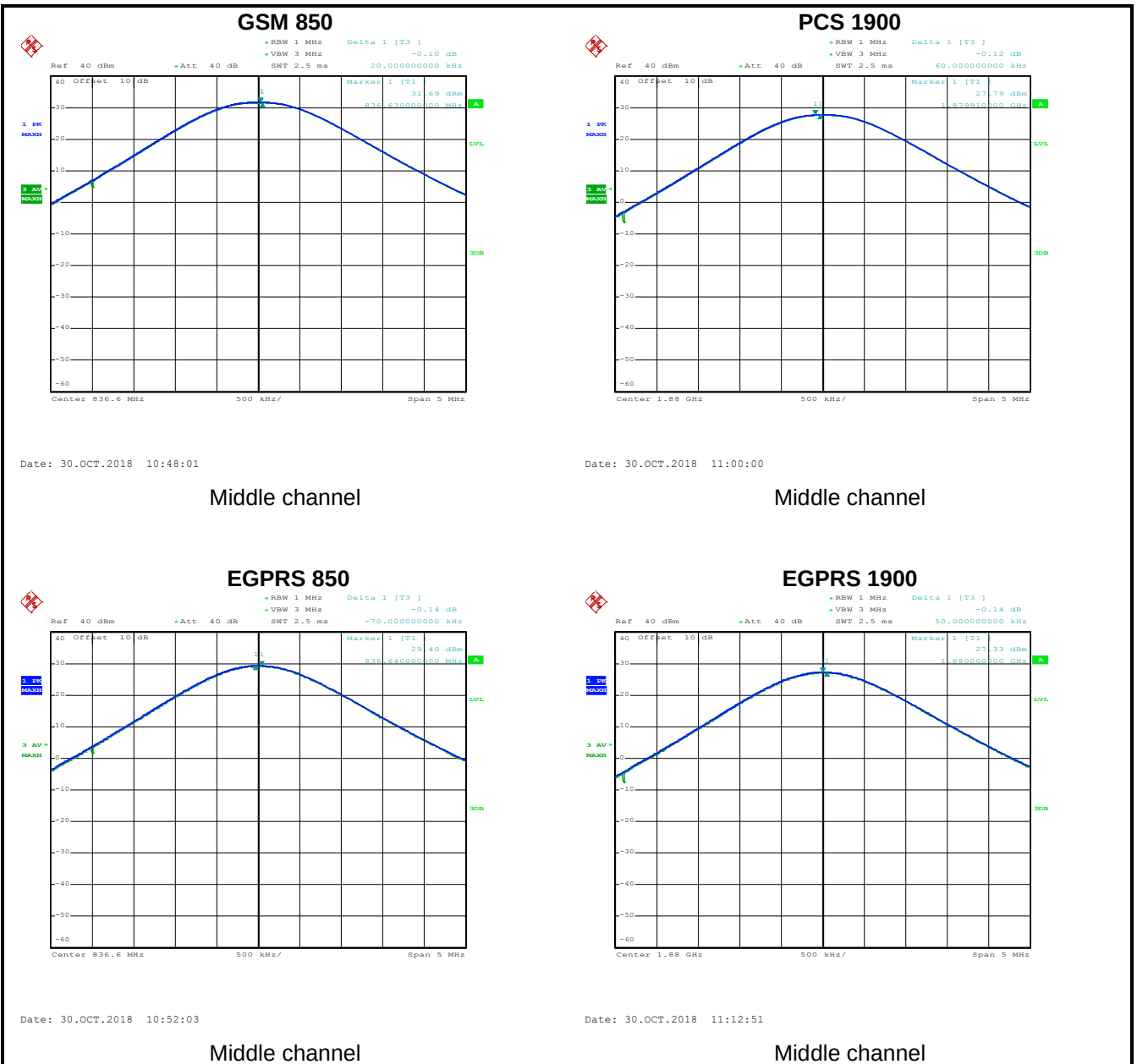

Test setup:	 The diagram shows a test setup for measuring the Peak-to-Average Power Ratio (PAR). It includes a System simulator, a Spectrum Analyzer, a Splitter, an ATT (Attenuator), and the EUT (Equipment Under Test). The System simulator and Spectrum Analyzer are connected to the Splitter. 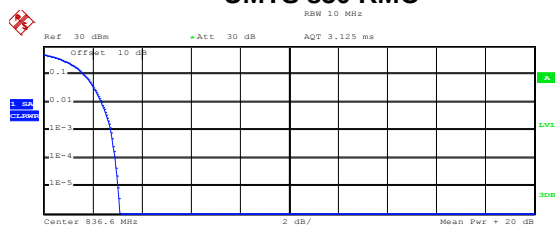

Complementary Cumulative Distribution Function (100000 samples)

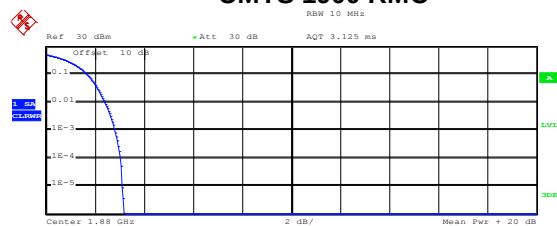

Complementary Cumulative Distribution Function (100000 samples)

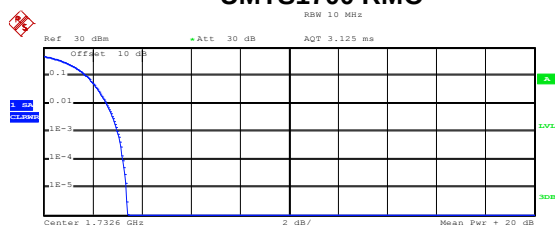

Complementary Cumulative Distribution Function (100000 samples)

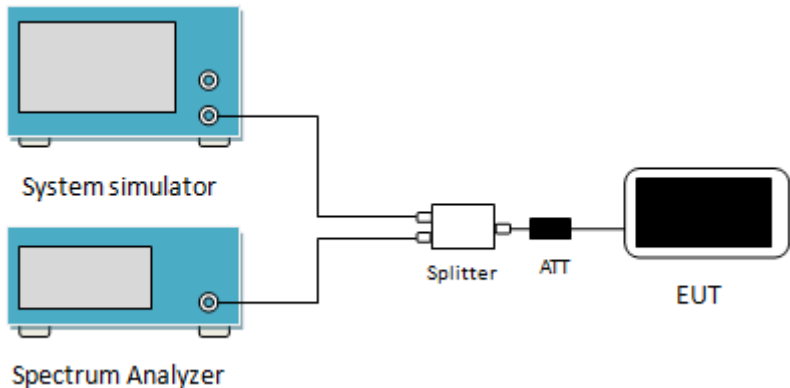
