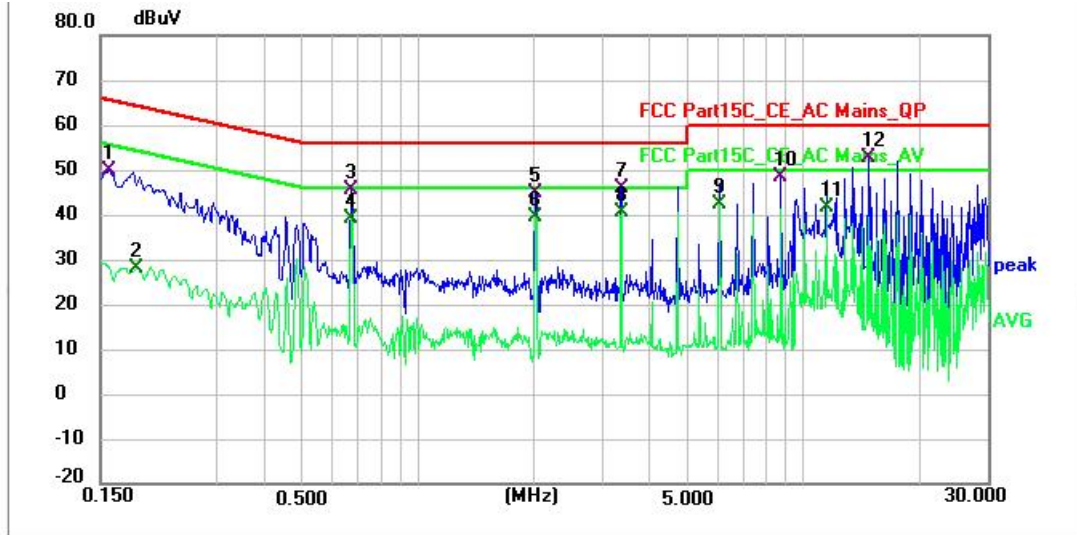

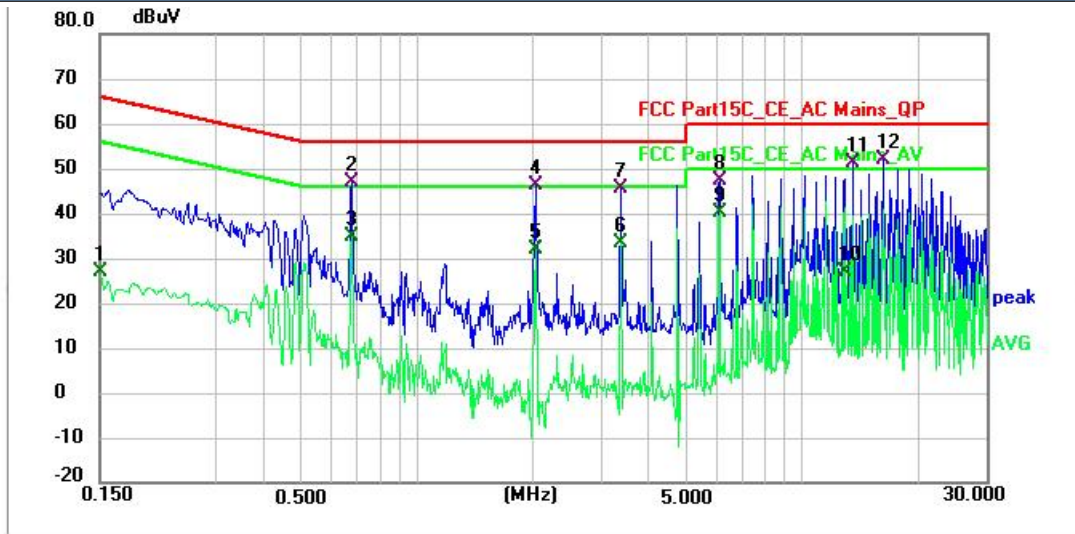

5.2.8.2. Test Setup Diagram



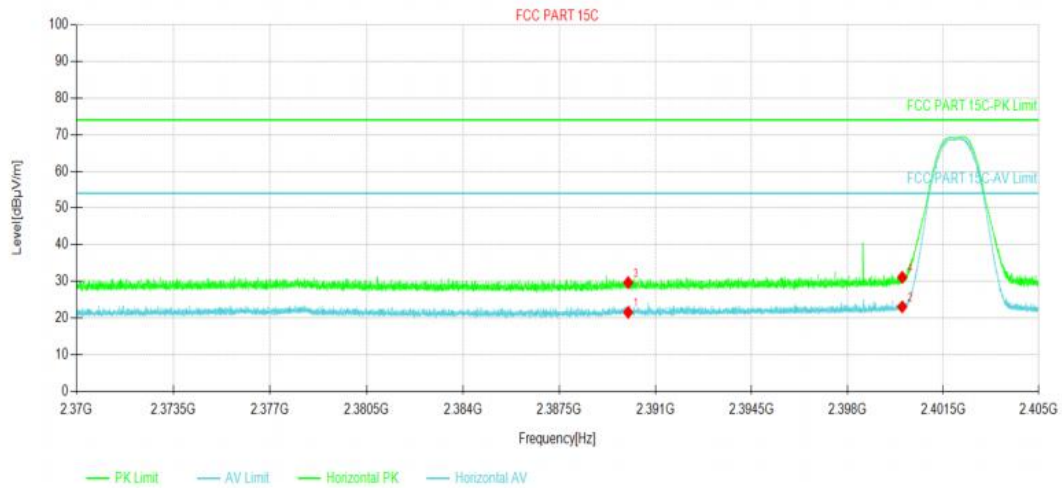

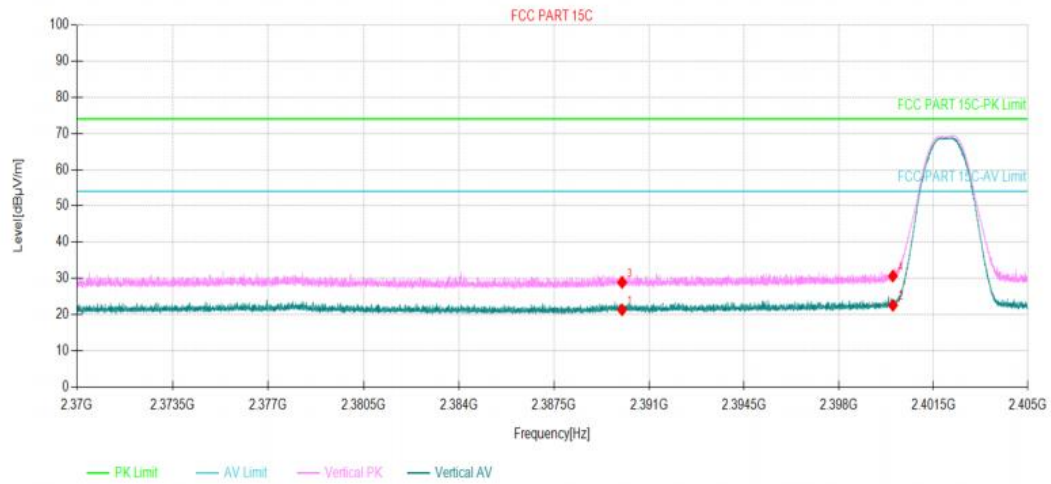

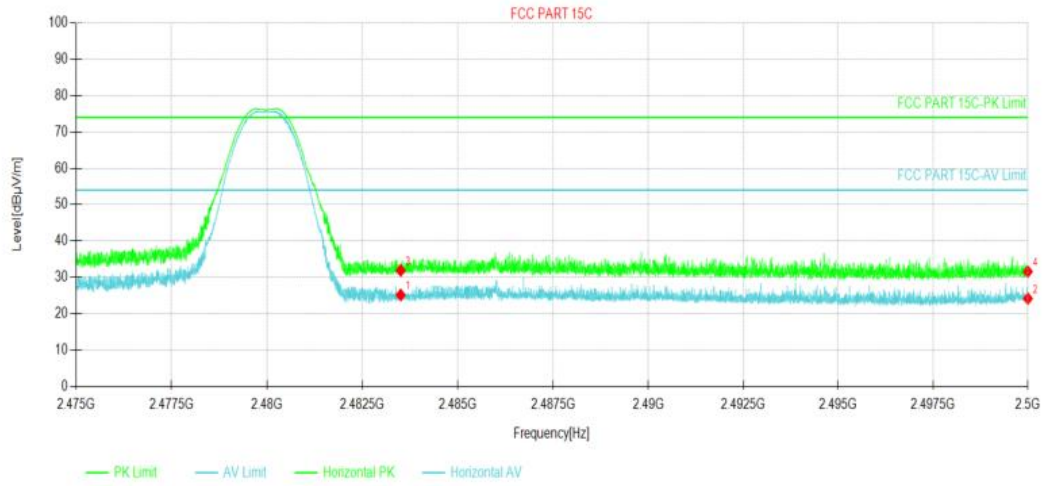

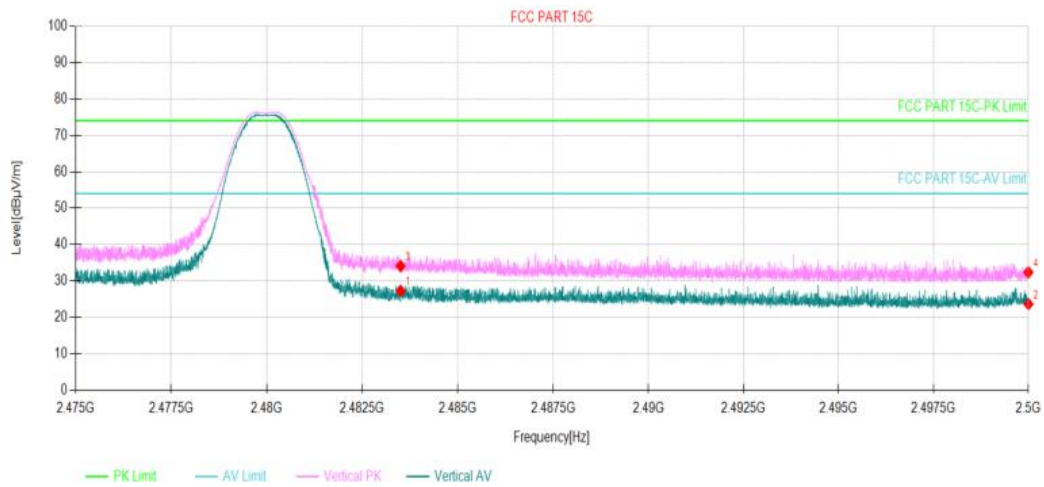

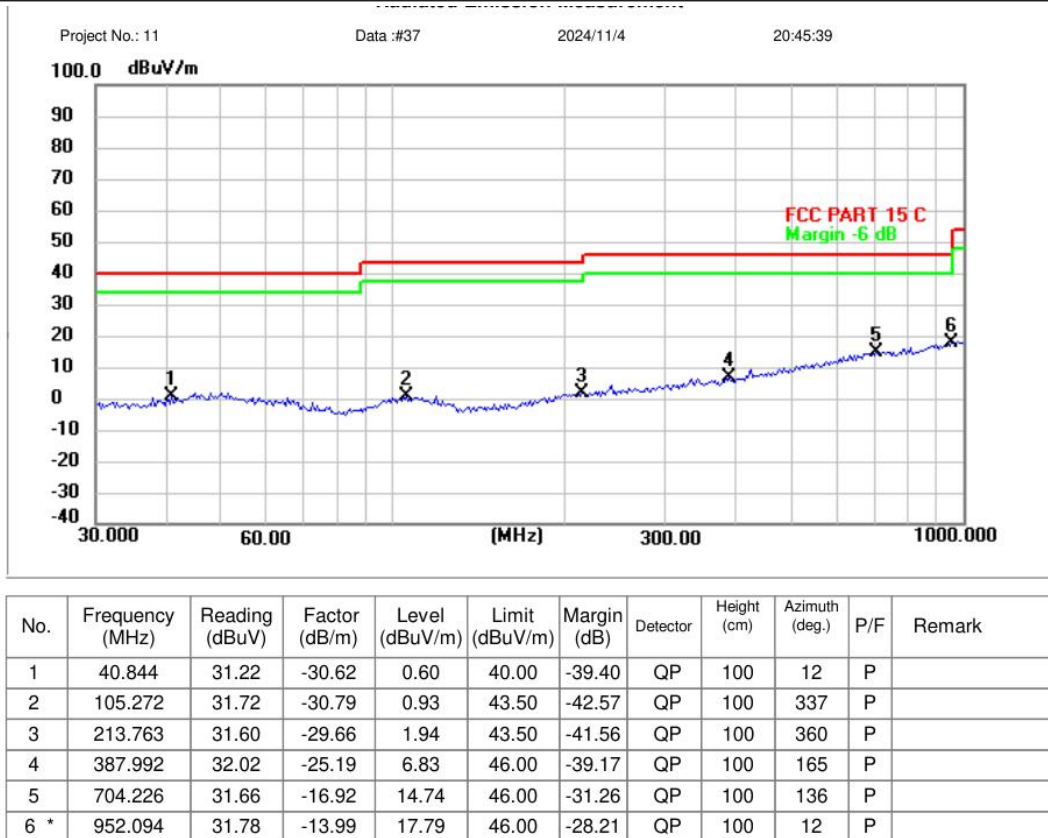

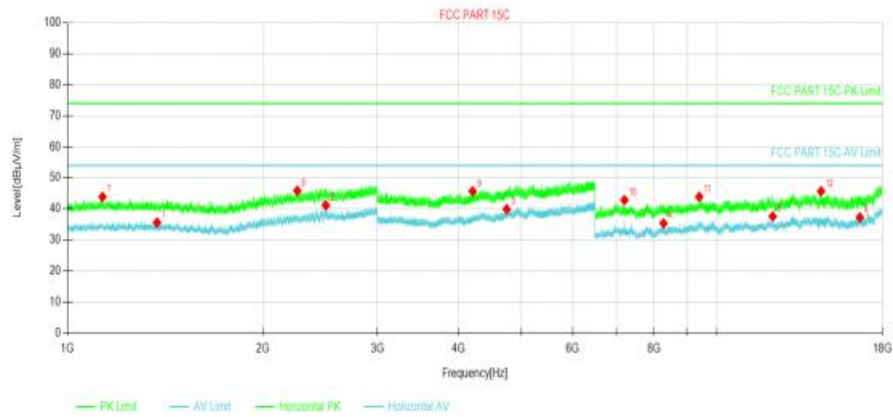

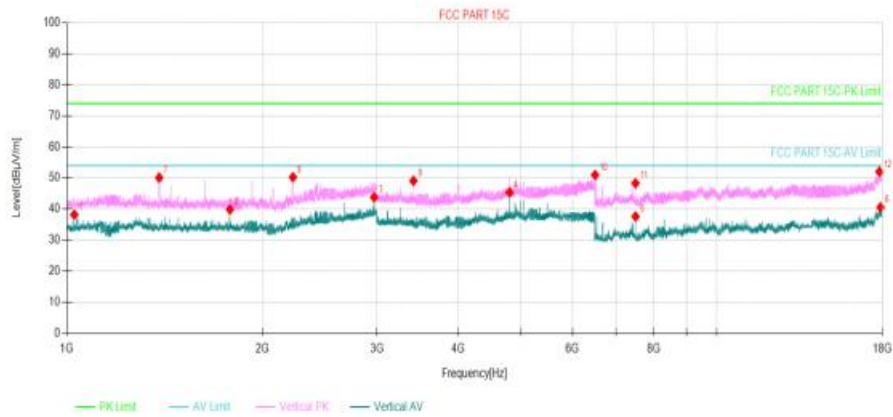

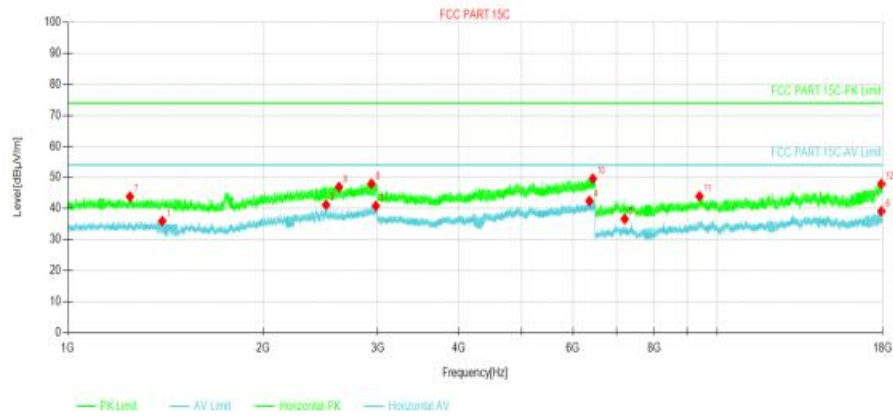

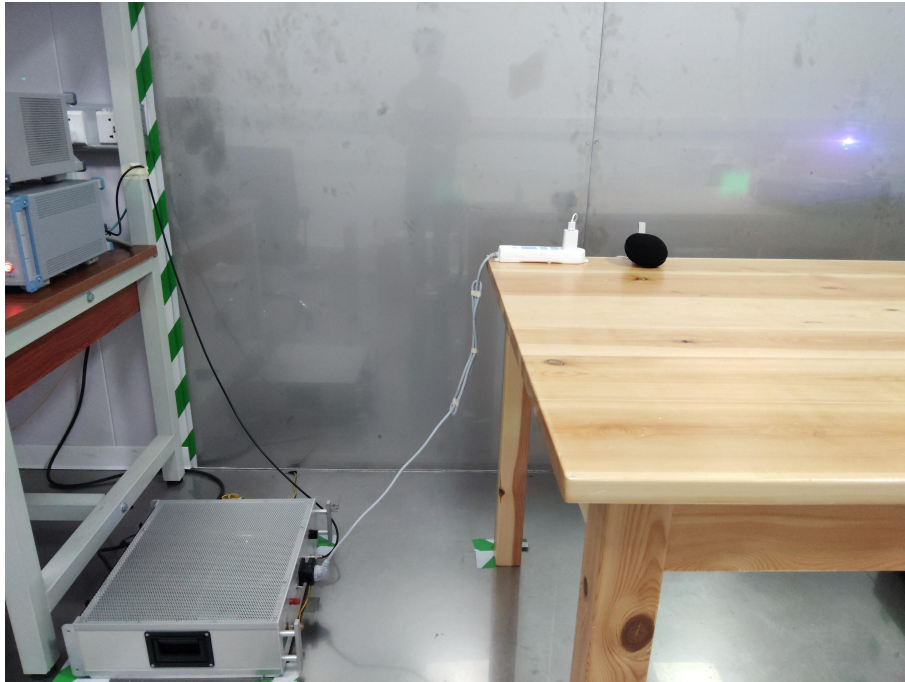
Radiated Spurious Emission (Above 1GHz)



Radiated Spurious Emission (below 1GHz)

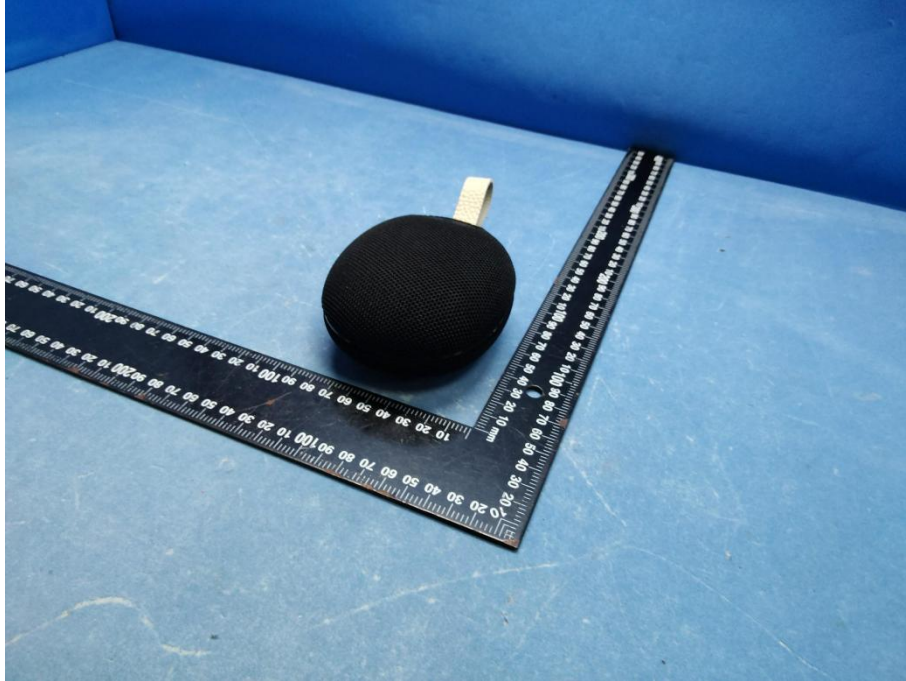


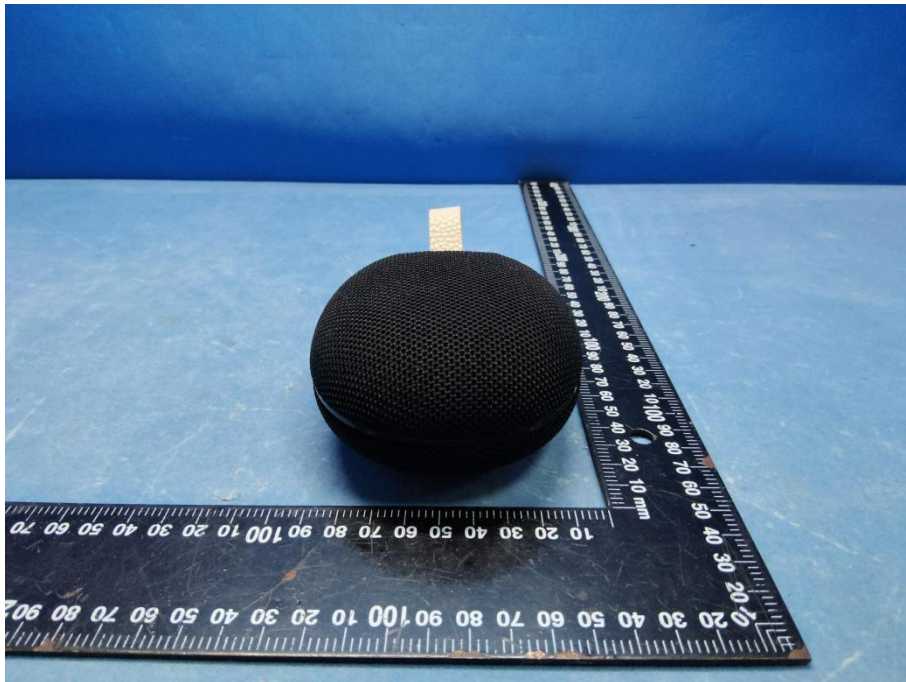
Conducted Emission at AC power line
