
2.2.1 Requirement

According to FCC section 15.247(b)(3), For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: The maximum peak conducted output power of the intentional radiator shall not exceed 1 Watt.

2.2.2 Test Description

The measured output power was calculated by the reading of the spectrum analyzer and calibration.

The EUT (Equipment under the test) which is powered by the Battery is coupled to the Spectrum analyzer; the RF load attached to the EUT antenna terminal is 500Ohm; the path loss as the factor is calibrated to correct the reading, all test result in Spectrum analyzer.







(Plot C: Channel 39: 2480MHz)




2.3 6dB Bandwidth

2.3.1 Requirement

According to FCC section 15.247(a) (2), Systems using digital modulation techniques may operate in the 902 - 928 MHz, 2400 - 2483.5 MHz, and 5725 - 5850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.

2.3.2 Test Description

A. Test Set:



The EUT which is powered by the battery, is coupled to the Spectrum Analyzer; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading.

Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 100 kHz. In order to make an accurate measurement, set the span greater than RBW.






(Plot A: Channel 0: 2402MHz)


2.4 Conducted Spurious Emissions and Band Edge

2.4.1 Requirement

According to FCC section 15.247(d), in any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.

2.4.2 Test Description

A. Test Set:



The EUT which is powered by the Battery, is coupled to the Spectrum Analyzer; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading.

Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 100 kHz. In order to make an accurate measurement, set the span greater than RBW.

2.4.3 Test Result

The measurement frequency range is from 30MHz to the 10th harmonic of the fundamental frequency. The lowest, middle and highest channels are tested to verify the spurious emissions.






(Plot A.1: Channel = 0, 30MHz to 25GHz)




(Band Edge@ Channel = 0)


(Plot B.1: Channel = 19, 30MHz to 25GHz)


2.5 Power spectral density (PSD)

2.5.1 Requirement

For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.






(Plot A: Channel = 0)


2.6 Restricted Frequency Bands

2.6.1 Requirement

According to FCC section 15.247(d), in any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power. In addition, radiated emissions which fall in the restricted bands, as defined in 15.205(a), must also comply with the radiated emission limits specified in 15.209(a).

2.6.2 Test Description

A. Test Setup



The EUT is located in a 3m Semi-Anechoic Chamber; the antenna factors, cable loss and so on of the site as factors are calculated to correct the reading.

For the Test Antenna:

Test Antenna is 3m away from the EUT. Test Antenna height is varied from 1m to 4m above the ground to determine the maximum value of the field strength.






(Plot A1: Channel = 0 PEAK)




(Plot A2: Channel = 0 AVG)

2.7 Conducted Emission

2.7.1 Requirement

According to FCC section 15.207, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency within the band 150kHz to 30MHz shall not exceed the limits in the following table, as measured using a 50 μ H/50 Ω line impedance stabilization network (LISN).



2.7.2 Test Description

A. Test Setup:



The Table-top EUT was placed upon a non-metallic table 0.8m above the horizontal metal reference ground plane. EUT was connected to LISN and LISN was connected to reference Ground Plane. EUT was 80cm from LISN. The set-up and test methods were according to ANSI C63.10:2013


2.7.3 Test Result

The maximum conducted interference is searched using Peak (PK), if the emission levels more than the AV and QP limits, and that have narrow margins from the AV and QP limits will be re-measured with AV and QP detectors. Tests for both L phase and N phase lines of the power mains connected to the EUT are performed. Refer to recorded points and plots below.



2.8 Radiated Emission

2.8.1 Requirement

According to FCC section 15.247(d), radiated emission outside the frequency band attenuation below the general limits specified in FCC section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in FCC section 15.205(a), must also comply with the radiated emission limits specified in FCC section 15.209(a).

According to FCC section 15.209 (a), except as provided elsewhere in this subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table:


1. For Above 1000MHz, the emission limit in this paragraph is based on measurement instrumentation employing an average detector, measurement using instrumentation with a peak detector function, corresponding to 20dB above the maximum permitted average limit.
2. For above 1000MHz, limit field strength of harmonics: 54dBuV/m@3m (AV) and 74dBuV/m@3m (PK)


2.8.2 Test Description

A. Test Setup:


- 1) For radiated emissions from 9kHz to 30MHz



- 2) For radiated emissions from 30MHz to 1GHz



3) For radiated emissions above 1GHz



The test site semi-anechoic chamber has met the requirement of NSA tolerance 4dB according to the standards: ANSI C63.10 (2013). For radiated emissions below or equal to 1GHz, The EUT was set-up on insulator 80cm above the Ground Plane, For radiated emissions above 1GHz, The EUT was set-up on insulator 150cm above the Ground Plane. The set-up and test methods were according to ANSI C63.10.

For the radiated emission test above 1GHz:

Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.

The EUT is located in a 3m Semi-Anechoic Chamber; the antenna factors, cable loss and so on of the site as factors are calculated to correct the reading.

For the Test Antenna:

- In the frequency range of 9kHz to 30MHz, magnetic field is measured with Loop Test Antenna.

The Test Antenna is positioned with its plane vertical at 1m distance from the EUT. The center of the Loop Test Antenna is 1m above the ground. During the measurement the Loop Test Antenna rotates about its vertical axis for maximum response at each azimuth about the EUT.

(b) In the frequency range above 30MHz, Bi-Log Test Antenna (30MHz to 1GHz) and Horn Test Antenna (above 1GHz) are used. Test Antenna is 3m away from the EUT. Test Antenna height is varied from 1m to 4m above the ground to determine the maximum value of the field strength. The emission levels at both horizontal and vertical polarizations should be tested.

2.8.3 Test Result

According to ANSI C63.10 , because of peak detection will yield amplitudes equal to or greater than amplitudes measured with the quasi-peak (or average) detector, the measurement data from a spectrum analyzer peak detector will represent the worst-case results, if the peak measured value complies with the quasi-peak limit, it is unnecessary to perform an quasi-peak measurement.

The measurement results are obtained as below:




During the test, the total correction Factor A_T and A_{Factor} were built in test software.

Note: All radiated emission tests were performed in X, Y, Z axis direction. And only the worst axis test condition was recorded in this test report.

The low frequency, which started from 9KHz to 30MHz, was pre-scanned and the result which was 20dB lower than the limit line per 15.31(o) was not reported.




(Antenna Vertical, 30MHz to 25GHz)






