Open the app and tap the menu icon (≡) > **Settings** > **Card Readers**. Follow the setup instructions from there.



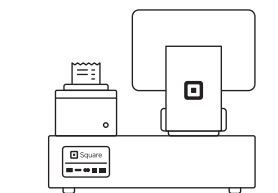
