### 2.1 Limits For Maximum Permissible Exposure (MPE)

### 2.2 MPE Calculation Formula

 $Pd = (Pout*G) / (4*pi*r^2)$ 

where

Pd = power density in mW/cm<sup>2</sup>

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

#### 2.3 Classification

The antenna of this product, under normal use condition, is at least 25cm away from the body of the user. So, this device is classified as **Mobile Device**.

#### 2.4 Calculation Result Of Maximum Conducted Power

NOTE:

2.4GHz: Directional gain = 5.89dBi

5180-5240MHz: Directional gain = 6.92dBi 5745-5825MHz: Directional gain = 7.28dBi

### **Conclusion:**

The formula of calculated the MPE is:

CPD1 / LPD1 + CPD2 / LPD2 + .....etc. < 1

CPD = Calculation power density

LPD = Limit of power density

WLAN 2.4GHz + WLAN 5GHz = 0.2930 + 0.5648 = 0.8578

Therefore the maximum calculations of above situations are less than the "1" limit.
