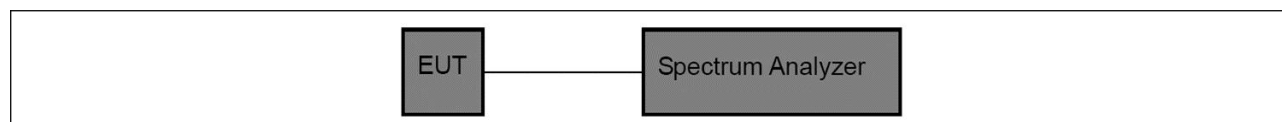
5. Channel Separation
