The antenna is a **Monopole Antenna** which permanently attached, and the best case gain of the antenna is **2.6 dBi**. It complies with the standard requirement.



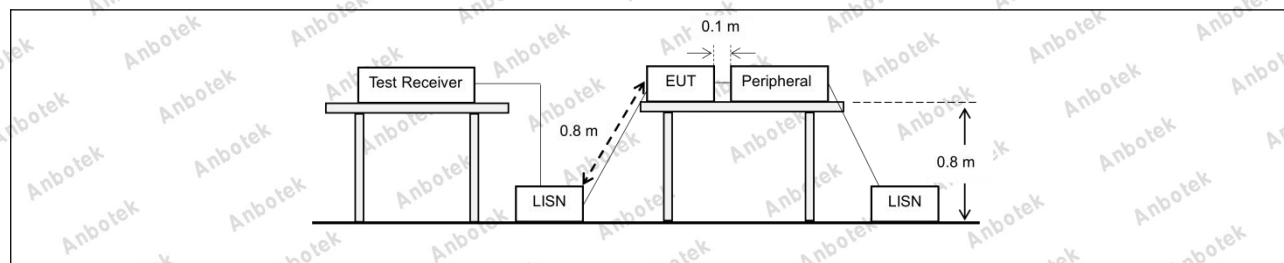
