Simultaneous transmitting consideration (worst case):

The ratio=ERP $_{\text{Wi-Fi}}$ /limit+ERP $_{\text{FHSS}}$ /limit=0.012/0.768+0.019/0.768=0.04<1.0, so simultaneous exposure is compliant.

To maintain compliance with the FCC's RF exposure guidelines, place the equipment at least 20cm from nearby persons.
