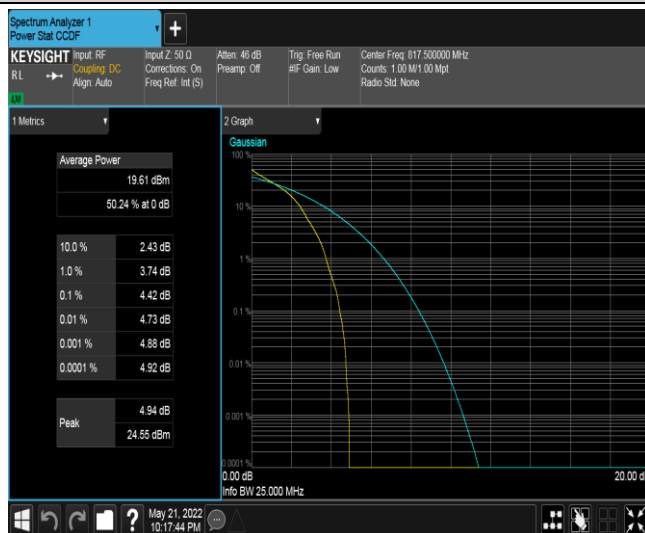

Band18-5MHz-QPSK-23875-25RB#0



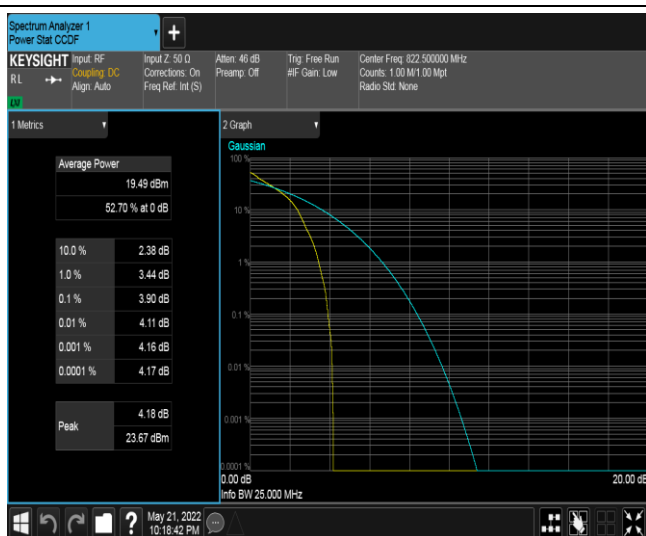

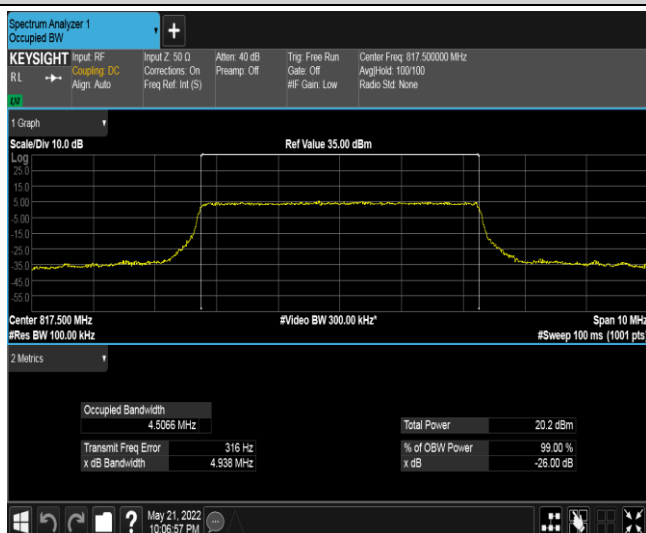
