1.	Yes	The radio element of the modular transmitter must have its own shielding.	Shielding is provided by a metal cover.
2.	N/A	The modular transmitter must have buffered modulation/data inputs (if such inputs are provided).	Due to a nature of the module, any buffer function is not necessary. There are NOT wireless datacommunication function on the module. Wired data port (UART) is for device-setting or RX-detective signal.
3.	Yes	The modular transmitter must have its own power supply regulation.	Power supply regulation is achieved by one regulator IC.
4.	Yes	The modular transmitter must comply with the antenna requirements of FCC 15.203 and 15.204(c).	Antenna requirements are achieved by an integrated patch antenna structure.

This modular transmitter is labeled with its own FCC ID. As it is not visible when the module is installed into a host device, a label of the host device will bear the wording "Contains FCC ID: 2ACUJ4267F3C1" with one line.
