

# 1 MPE EVALUATION OF MOBILE DEVICES

Human exposure to RF emissions from mobile devices (47 CFR §2.1091) may be evaluated based on the MPE limits adopted by the FCC for electric and magnetic field strength and/or power density, as appropriate, since exposures are assumed to occur at distances of 20 cm or more from persons.

## 1.1 LIMITS FOR GENERAL POPULATION/UNCONTROLLED EXPOSURE

Frequency Range (MHz)	Power Density (mW /cm <sup>2</sup> )	Averaging Time (minutes)
300~1500	F/1500	30
1500~100000	1.0	30

## 1.2 MPE EVALUATION FORMULA

$$Pd = \frac{Pt}{4 * \pi * R^2}$$

Where

Pd= Power density in mW/cm<sup>2</sup>

Pt= EIRP in Mw

π= 3.1416

R= Measurement distance

### 1.3 MPE EVALUATION RESULTS

#### MPE Evaluation of Single Transmission

#### MPE Evaluation of Simultaneous Transmission

2.4 and 5GHz can transmit at the same time, MPE evaluation is as below formula

$PD1 / \text{Limit1} + PD2 / \text{Limit 2} + \dots < 1$ , PD = Power density

MPE Evaluation = Maximum MPE of 2.4GHz<sup>Note</sup> + Maximum MPE of 5 GHz =  $0.393 / 1 + 0.162 / 1 = 0.555 < 1$

Note: Test result of 2.4GHz is from original MPE report, Report No. FA4O0702

#### Conclusion

MPE evaluations of single and simultaneous transmission meet the requirement of standard.
