



Band5-1.4MHz-QPSK-20407-1RB#0




Band5-1.4MHz-QPSK-20407-6RB#0



**Band5-1.4MHz-QPSK-20525-1RB#0**



**Band5-1.4MHz-16QAM-20407-6RB#0**




**Band5-1.4MHz-16QAM-20525-1RB#0**


