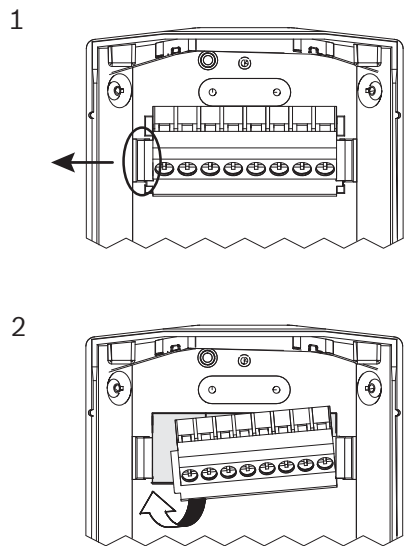
3 | Bracket mount (optional)



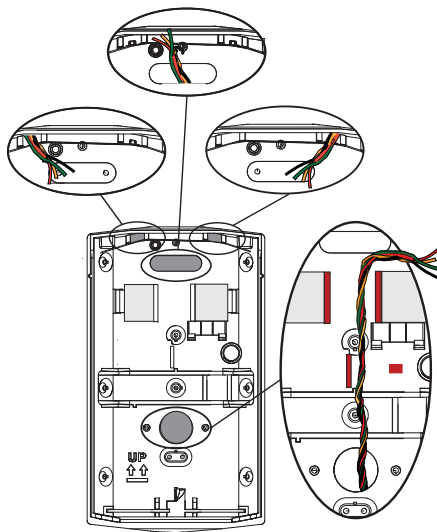

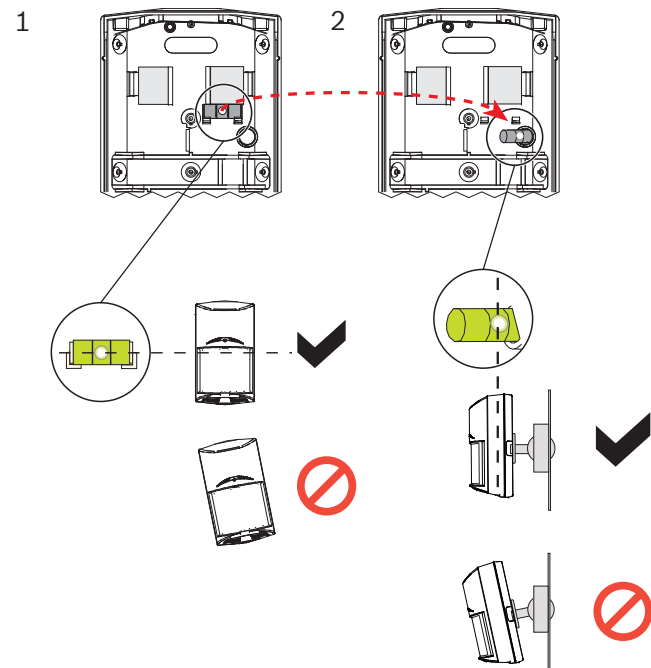

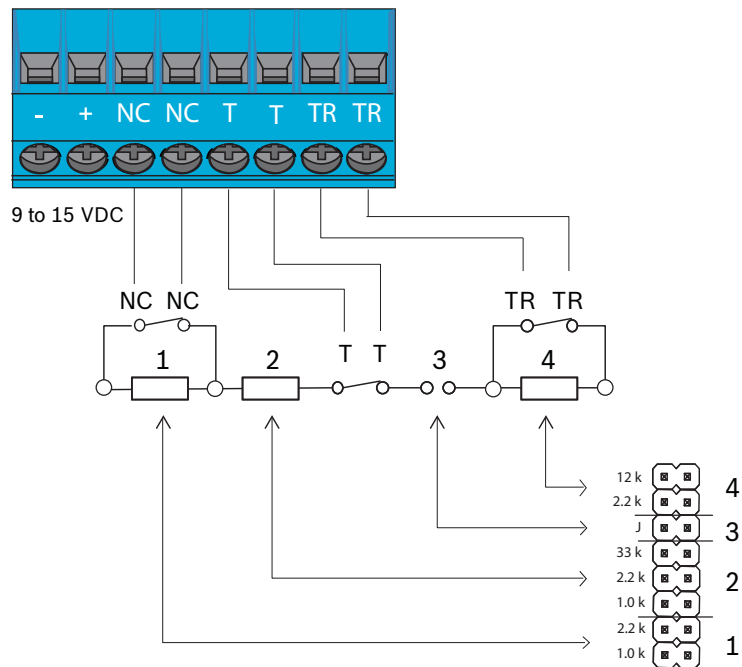

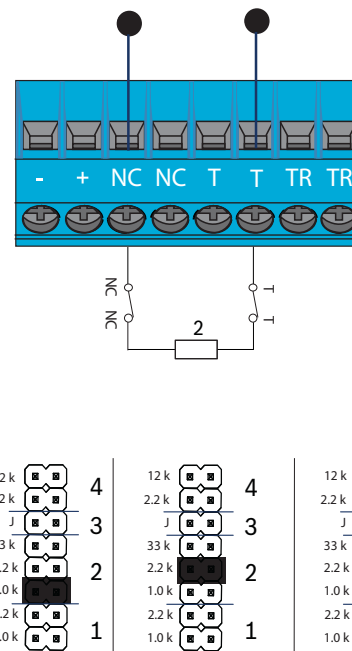

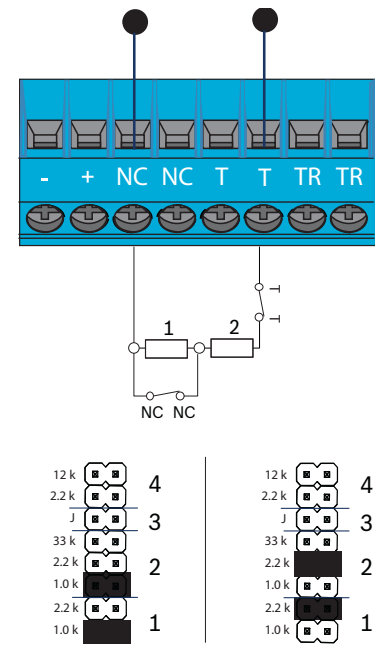

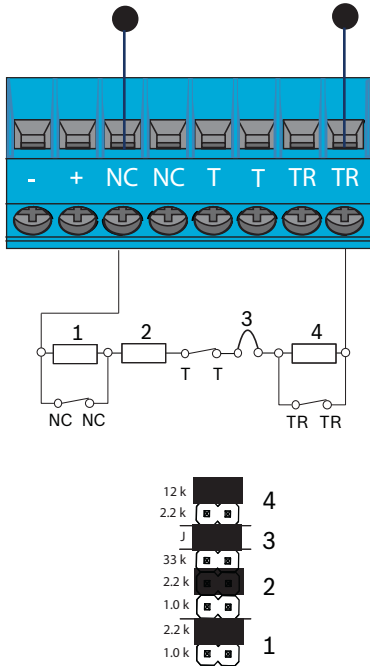
7a | Single EOL resistor



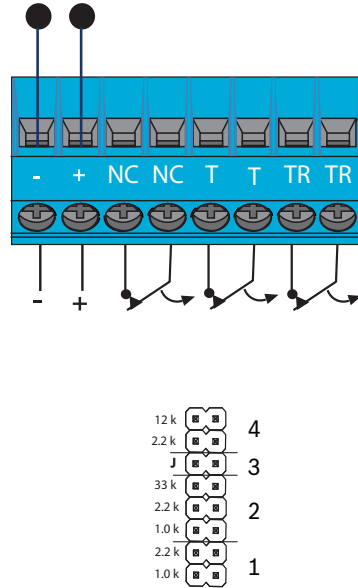
7b | Double EOL resistors



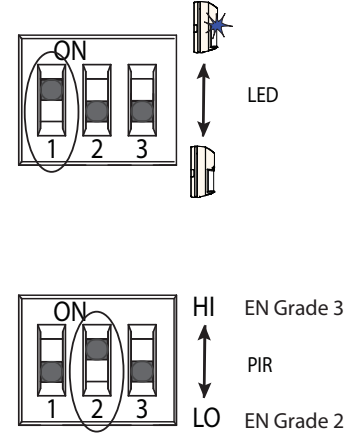
7c | Triple EOL resistors



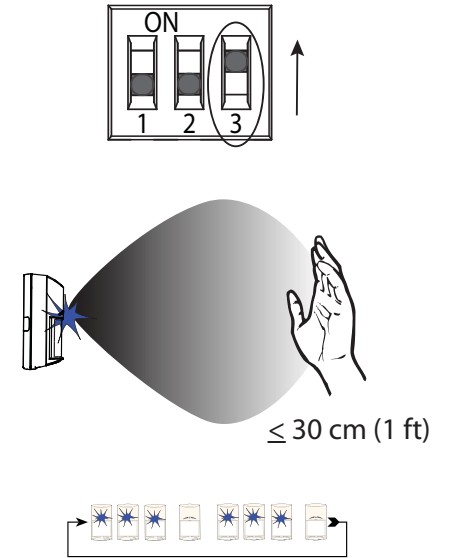

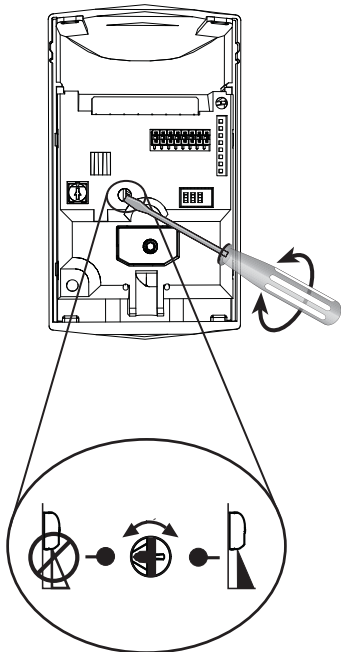

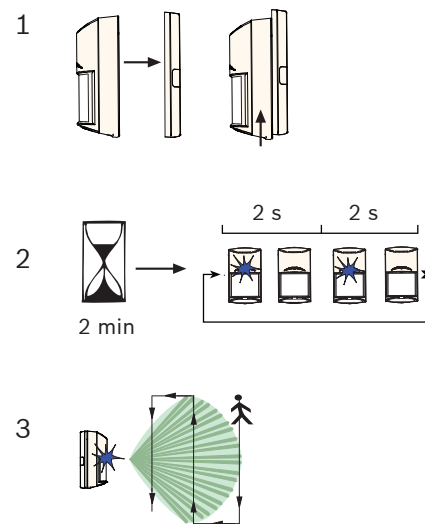
8b | Anti-mask feature



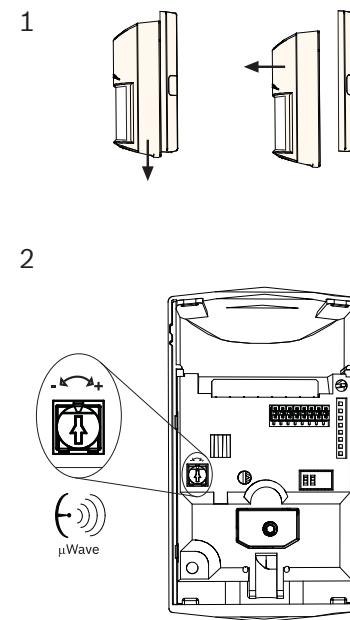

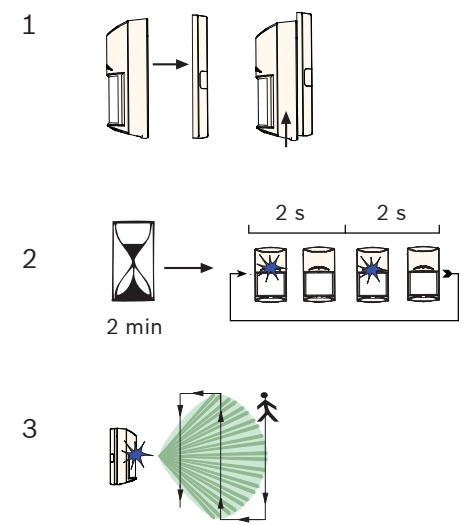
