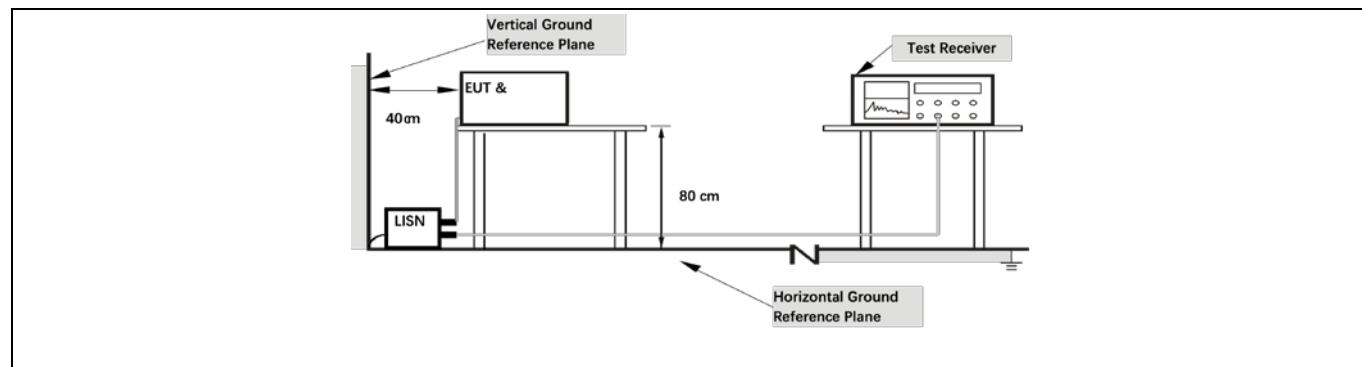

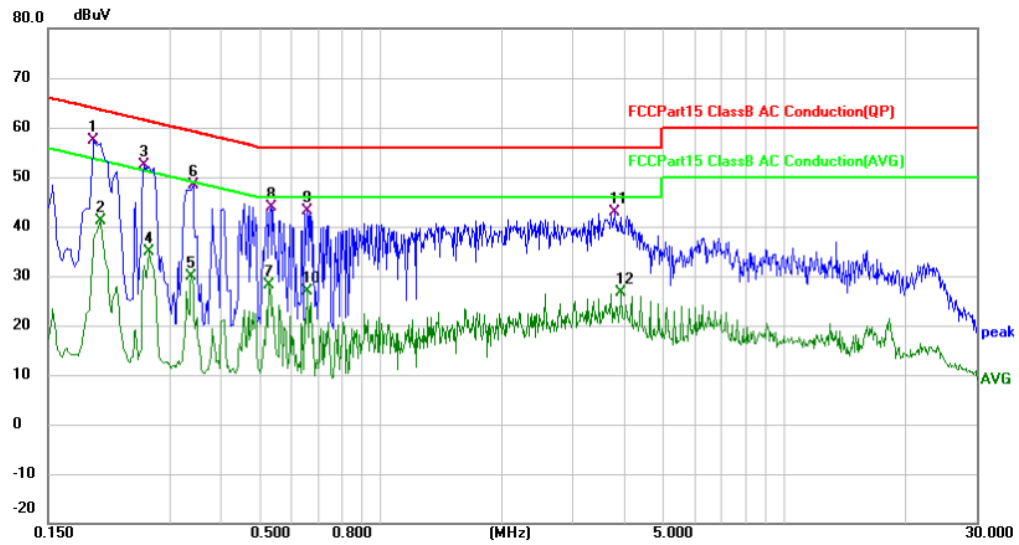

#### 6.1.2 Test Setup Diagram:



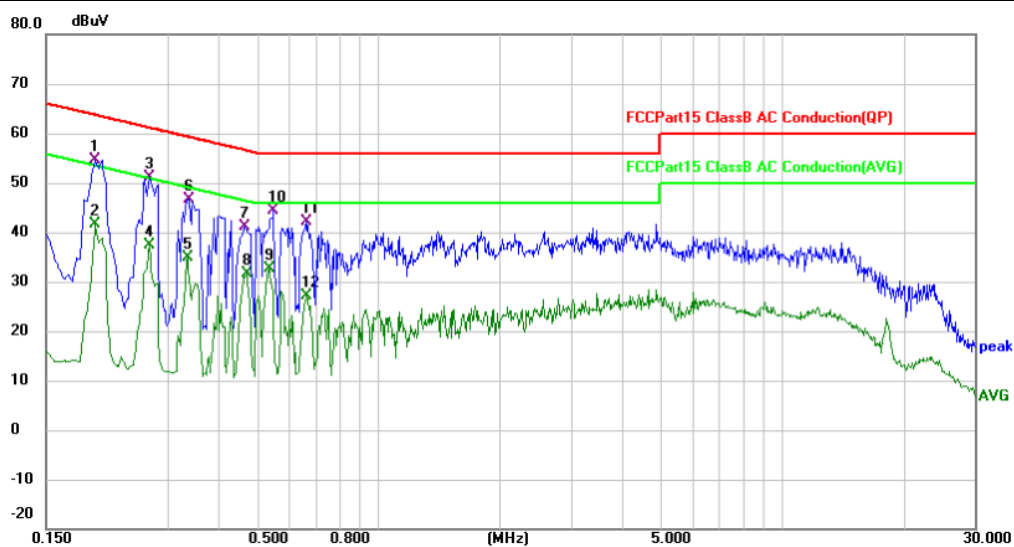

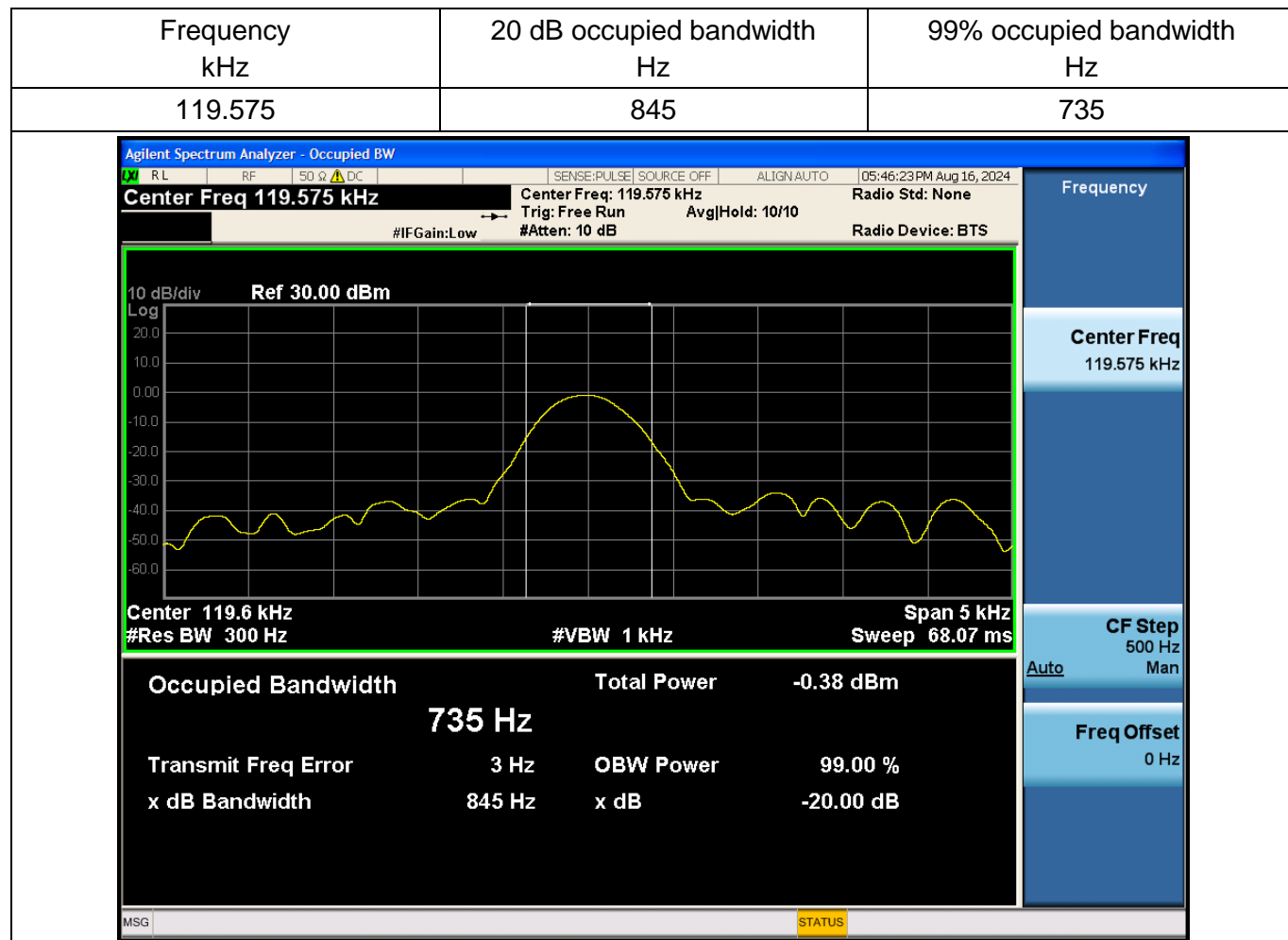

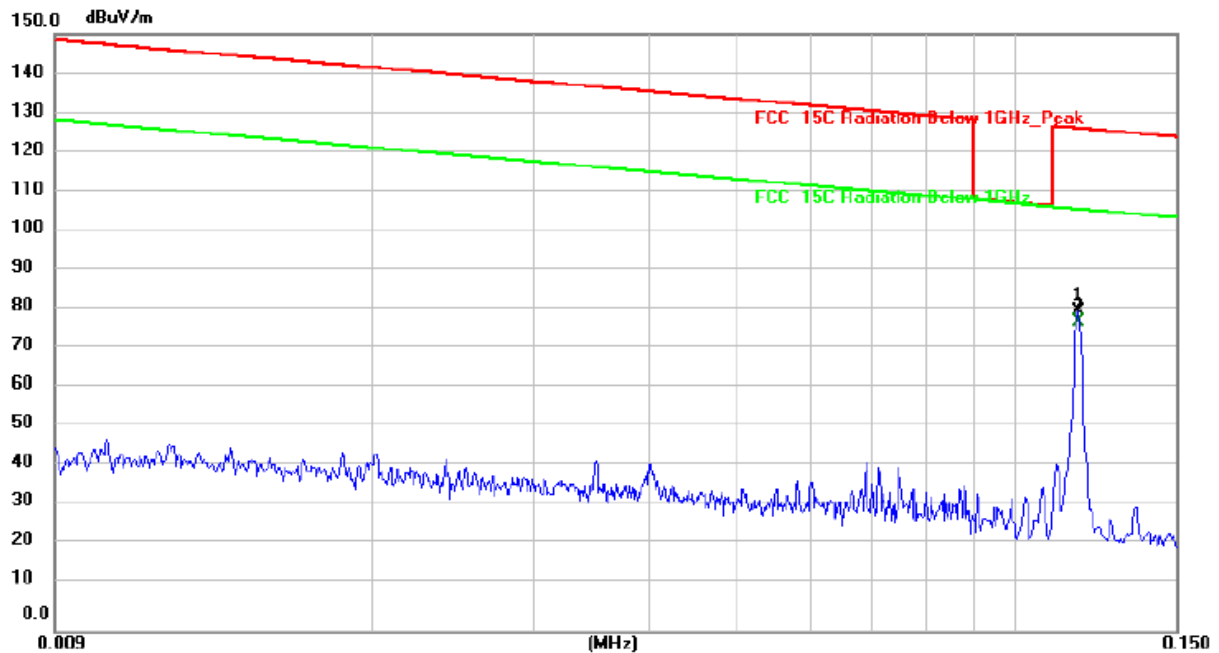

#### 6.3.2 Test Setup Diagram:



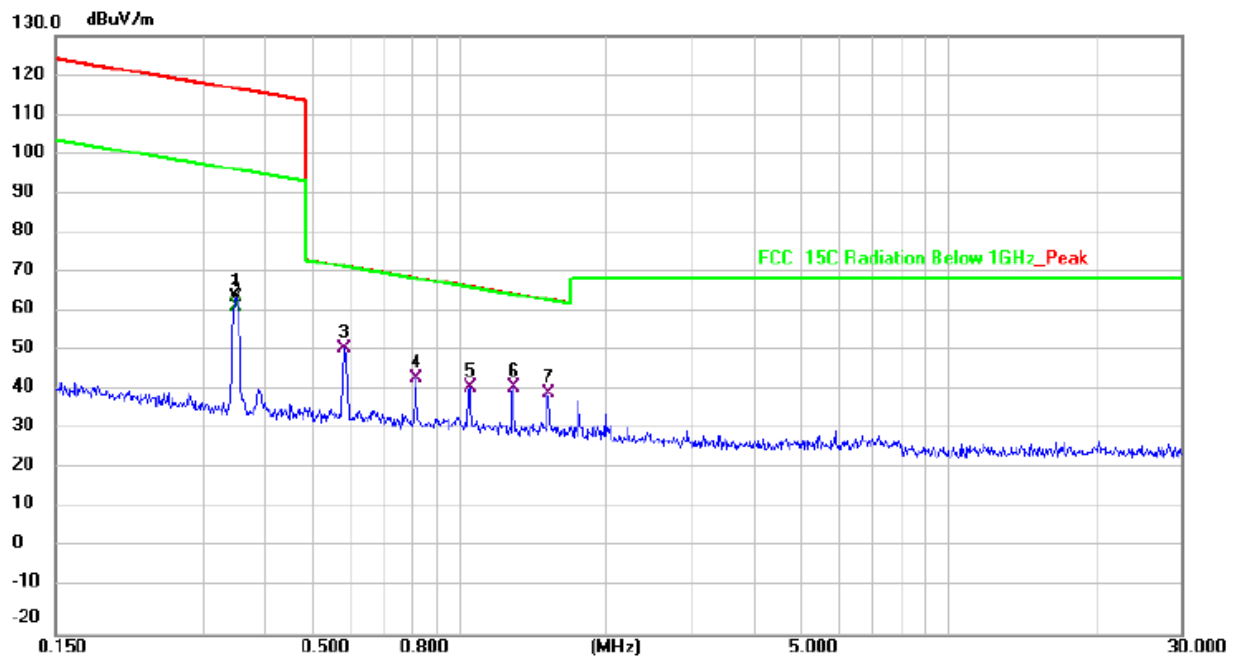

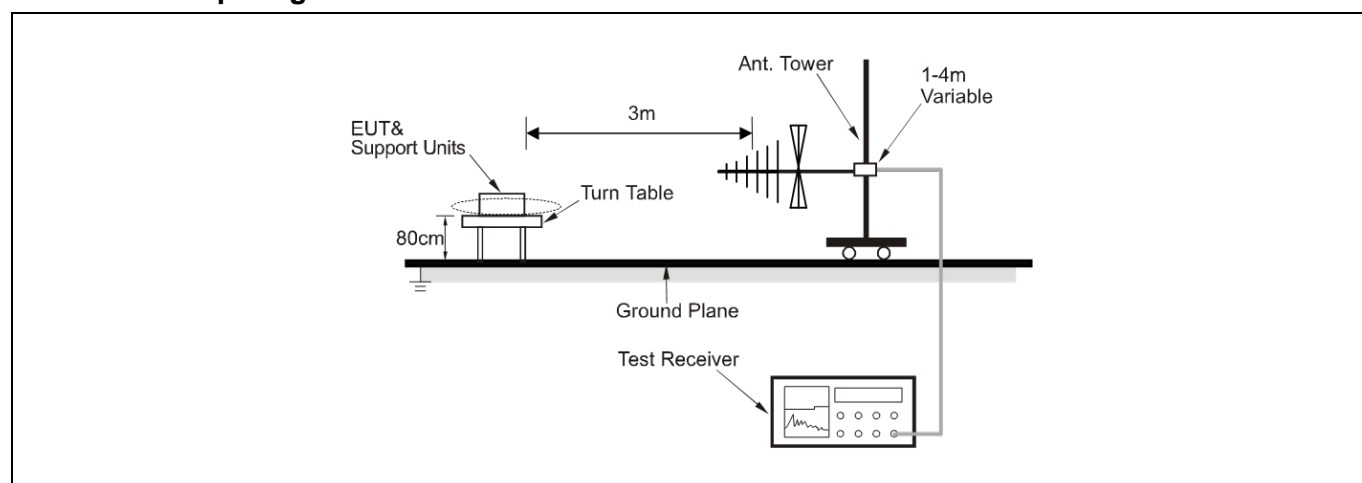

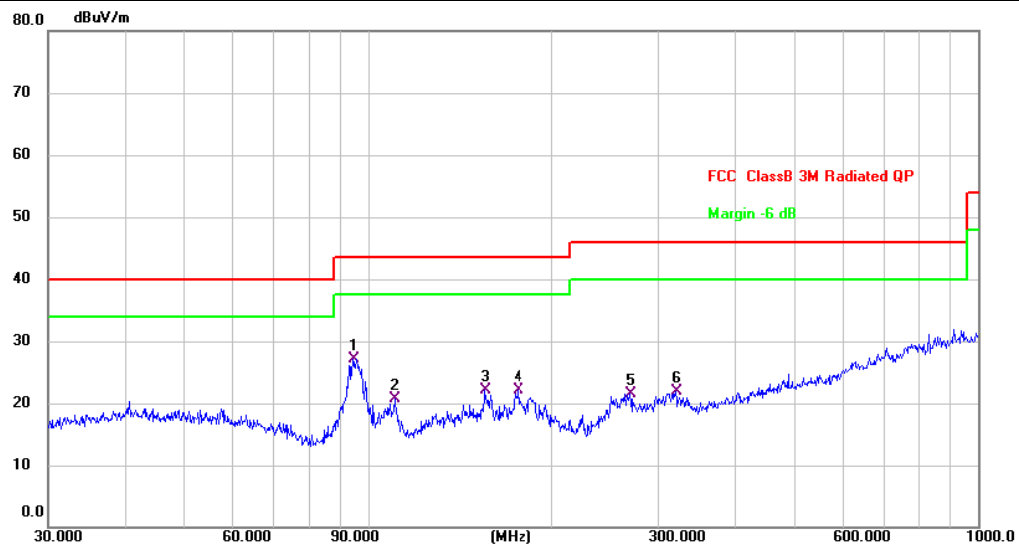

##### 6.4.2 Test Setup Diagram:



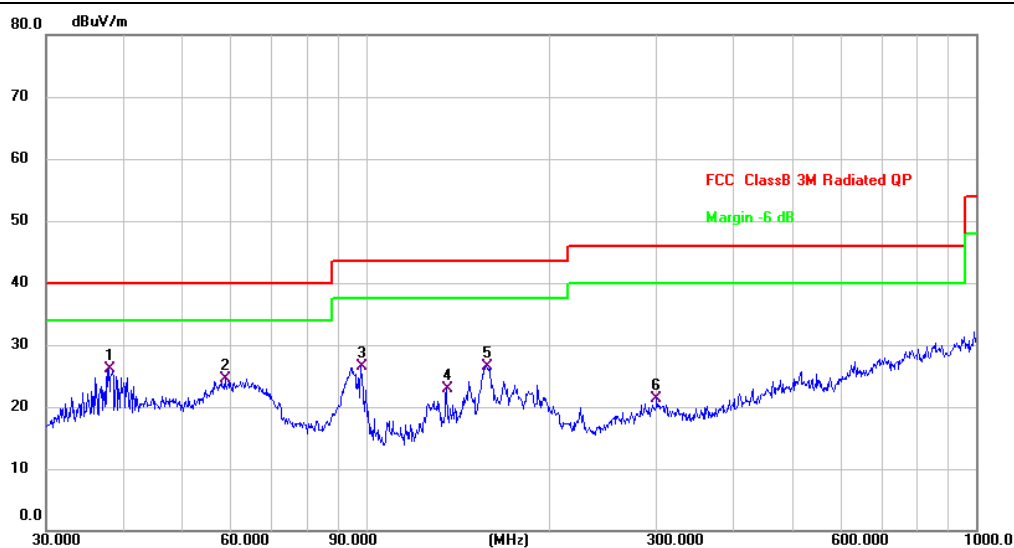
