<p>This Limited Warranty applies to your purchase of Republic Relay in the United States.</p> <p>What does this warranty cover and how long does it last? Republic Wireless warrants that a new Republic Relay device (including any parts that may be packaged with it) will be free from defects in materials and workmanship under normal use in accordance with Republic Wireless's published user documentation for one year from the date of original retail purchase in its original packaging by you. If a Republic Relay has been refurbished, Republic Wireless warrants that the Republic Relay (including any parts that may be packaged with it) will be free from defects in materials and workmanship under normal use in accordance with Republic Wireless's published user documentation for ninety days from the original date of retail purchase by you (these warranties are collectively referred to as our "Limited Warranty").</p> <p>What will Republic Wireless do? (THIS IS YOUR EXCLUSIVE REMEDY) If a defect covered by this Limited Warranty arises and you return your Republic Relay during the Limited Warranty period (which is one year for new devices and ninety days for refurbished devices), Republic Wireless will in its sole discretion and to the extent permitted by law repair your Republic Relay using new or refurbished parts, replace your Republic Relay with a new or refurbished Republic Relay functionally at least equivalent to yours, or accept the return of your Republic Relay in exchange for a refund of the purchase price you paid for your Republic Relay. If Republic Wireless repairs or replaces your Republic Relay, the repaired or replaced Republic Relay will continue to be warranted for the remaining time of the original warranty period. All returned parts for which you have received a replacement will become the property of</p>	<p>Republic Wireless. Repair or replacement may result in loss of data.
