Band38-15MHz-16QAM-38000-1RB#0-Range1:30~1000MHz

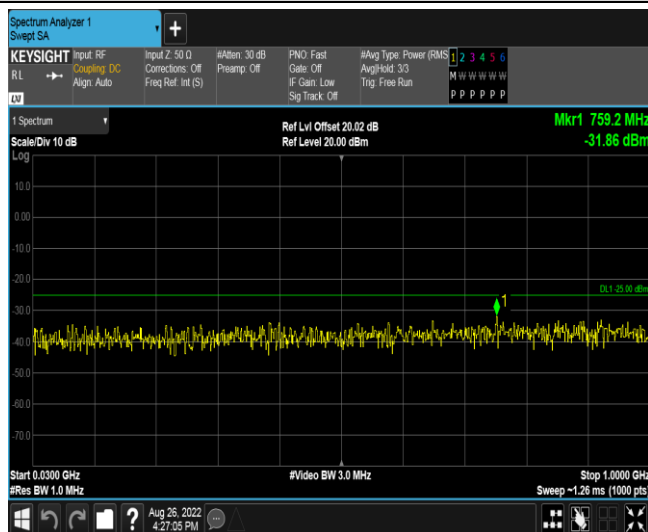


Band38-15MHz-16QAM-38000-1RB#0-Range2:1000~27000MHz

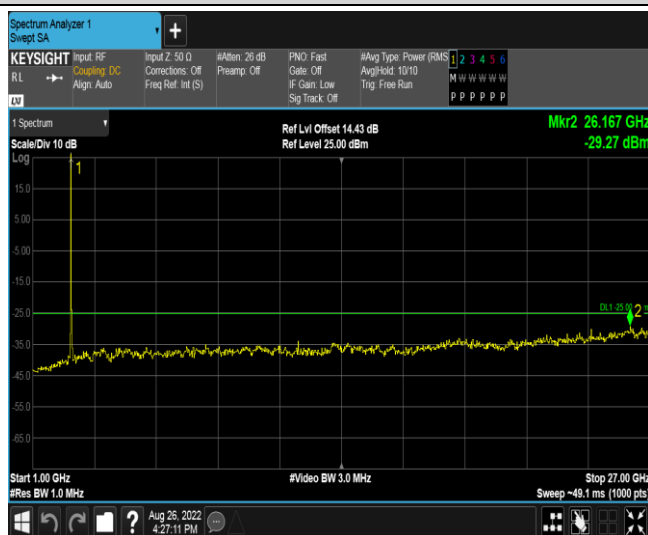
