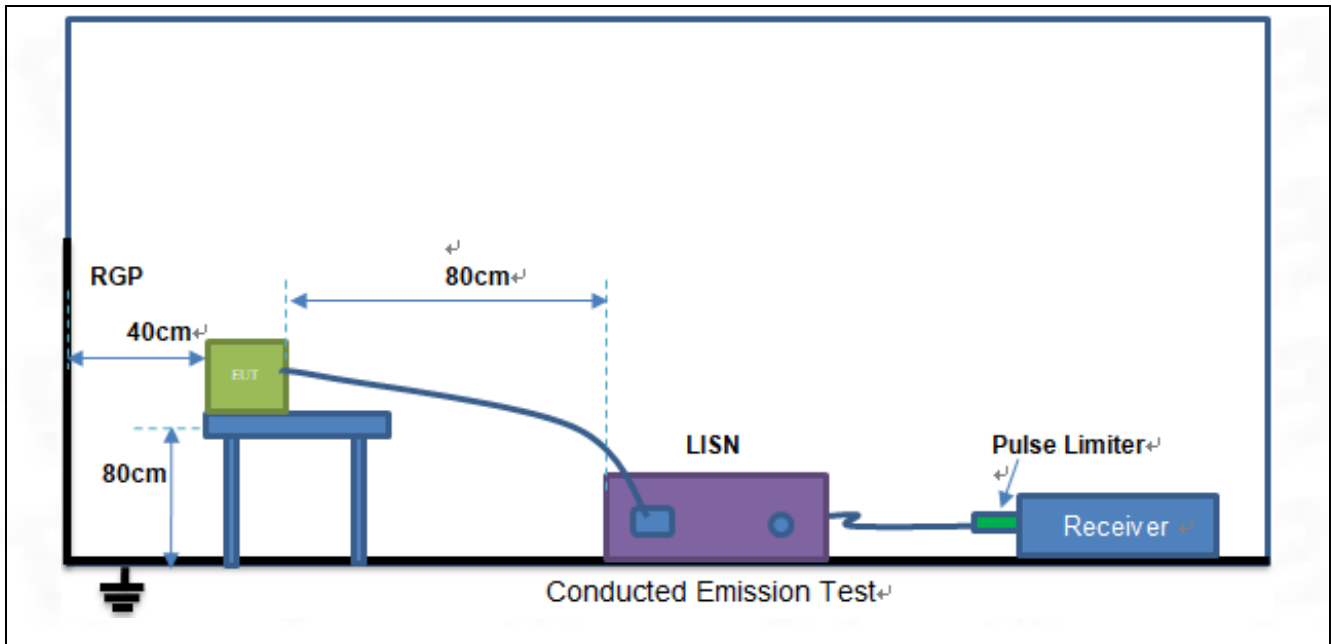

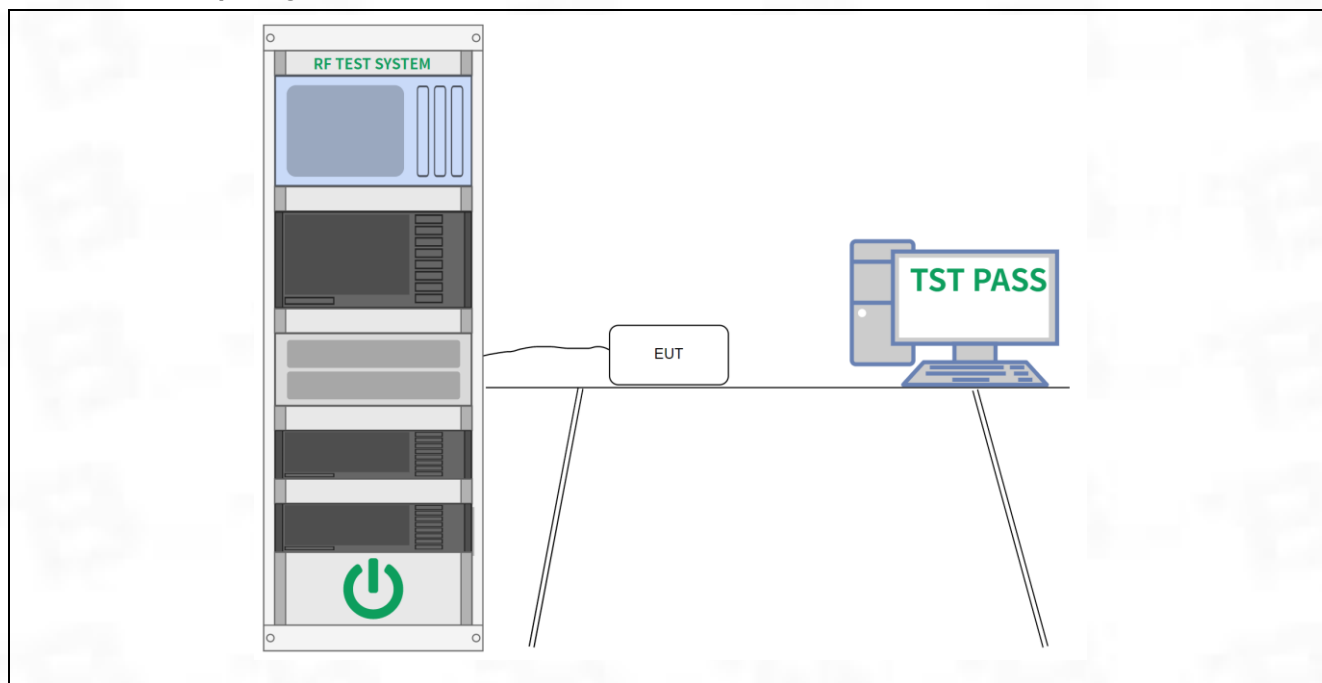

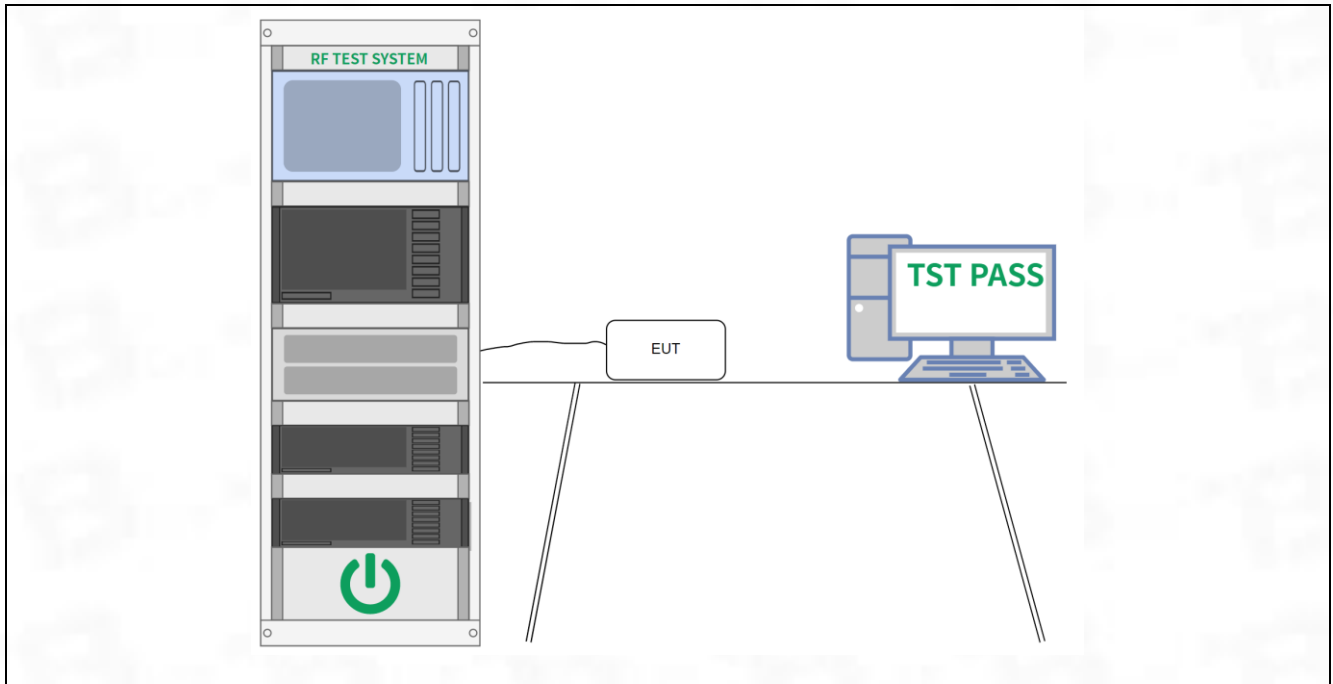

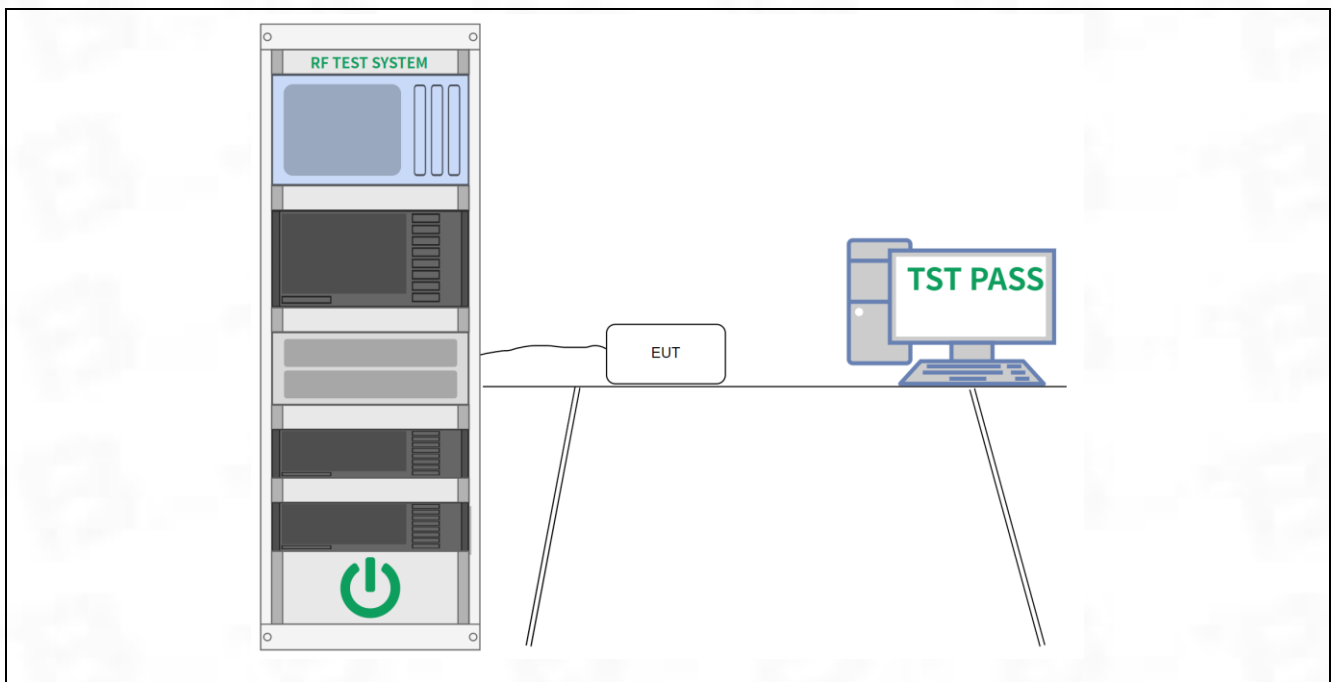

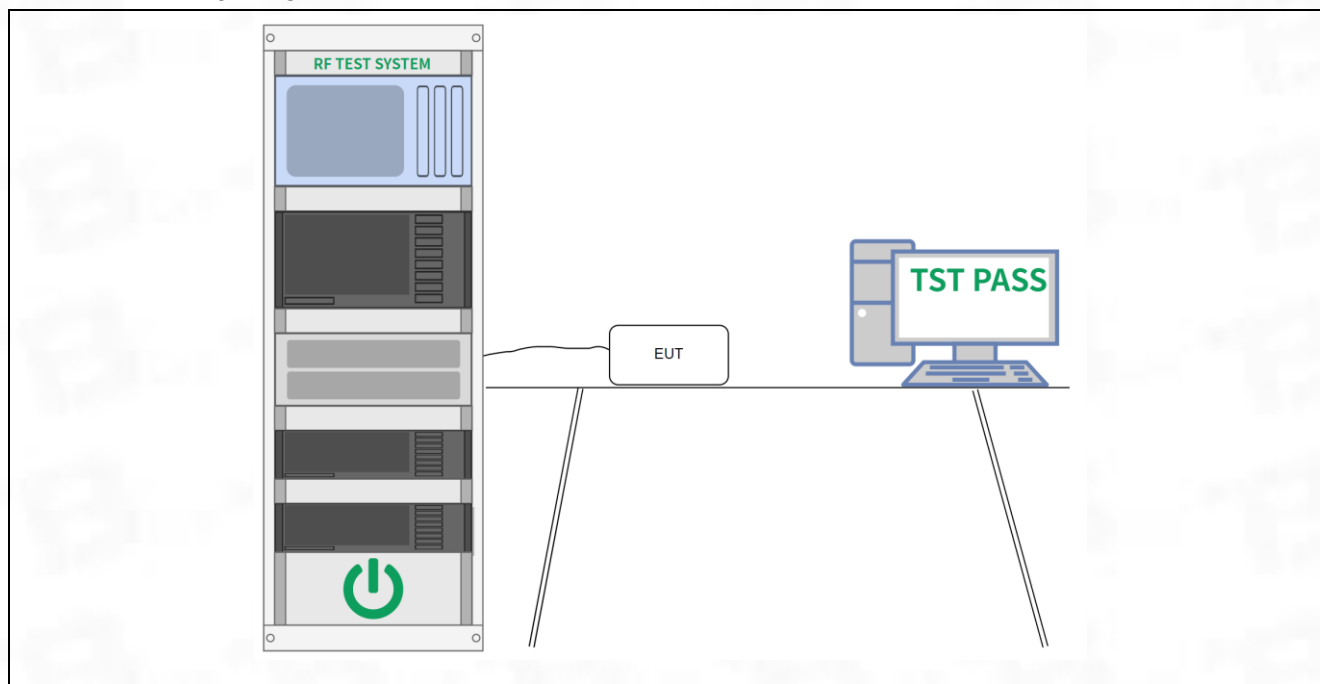

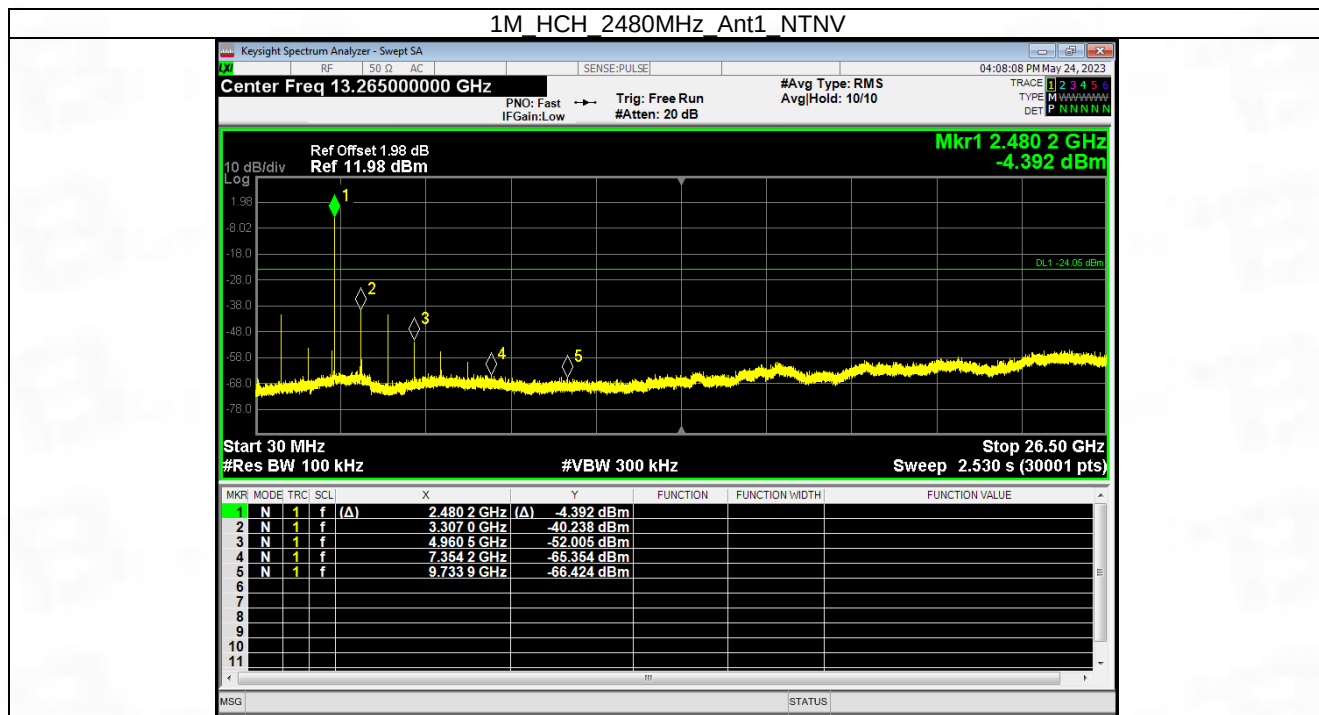


1M MCH 2440MHz Ant1 NTN
