
User manual





- 1. InsertingtheSIMcard
- 2. Powering up the gateway (Inputvoltage: 120-277V, Frequency: 60Hz)
- 3. Observing the status of indicators. Waiting 2 minutes, if the blue light and the green light is blinking and the red light is extinguishing, the gateway is working.

Users can issue control commands on their phones or computers. And the 3G antenna receives data from the cloud. The gateway converts 3G data into zigbee data. Finally, the light is controlled by zigbee antenna.

- 1. Account registration—Send the username and email address to Chenzw@yankon.com.

- 3. Send the Mac of lights and the gateway to the background administrator (Chenzw@yankon.com) for addition.
- 4. Control lights on the web.
