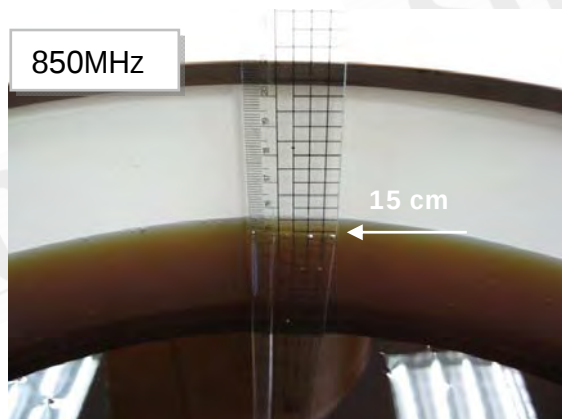

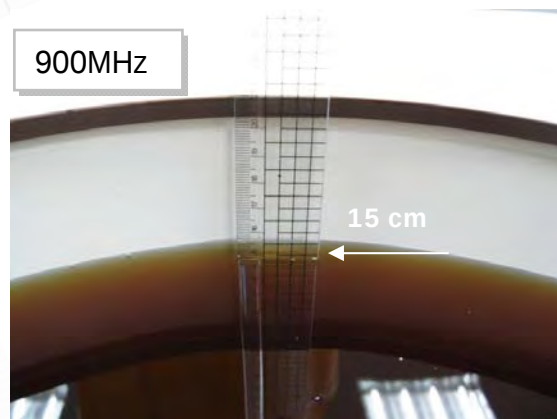

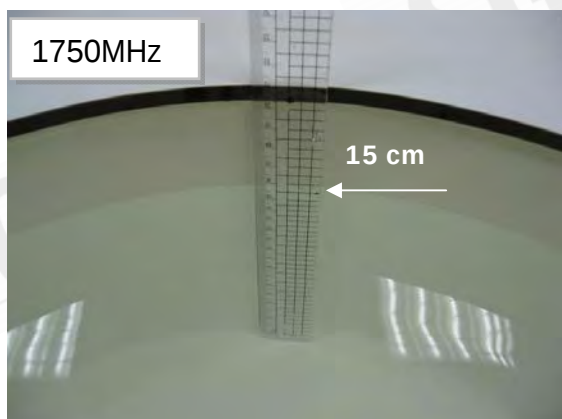

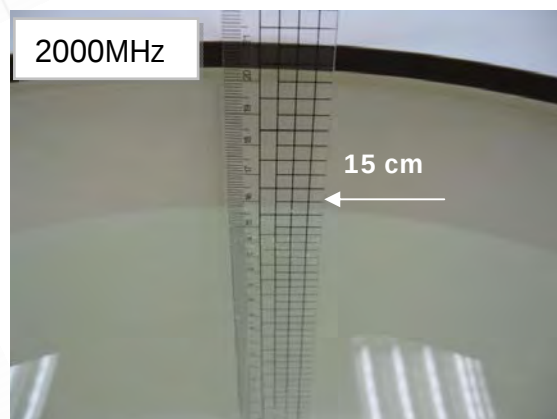

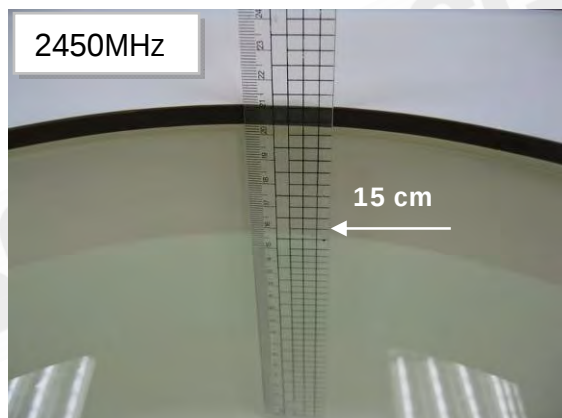

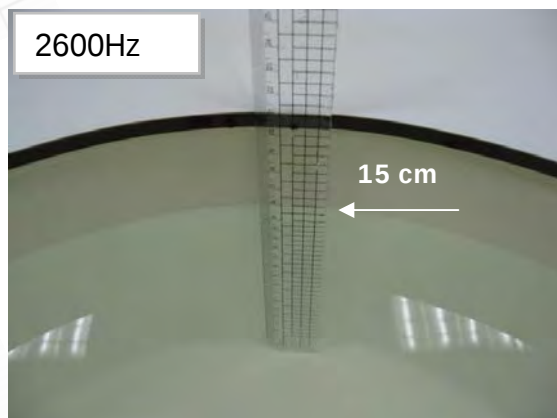

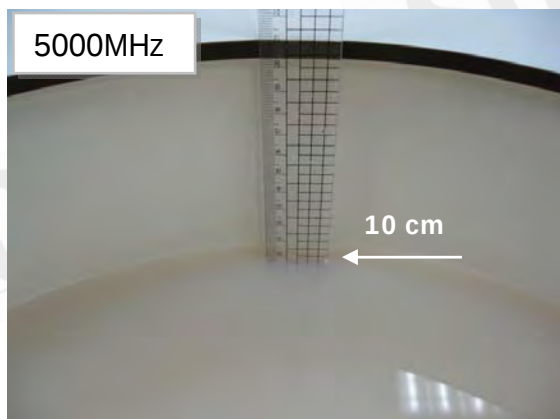

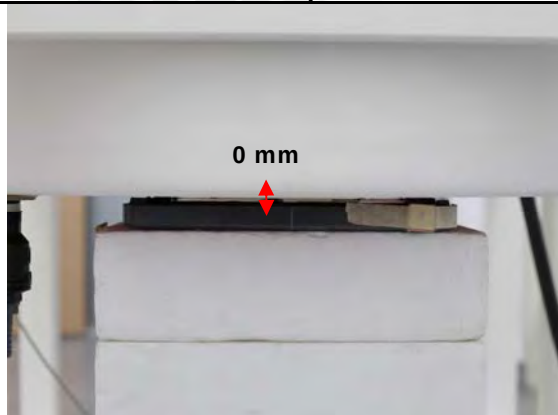


Fig.3 EUT Back side to flat phantom

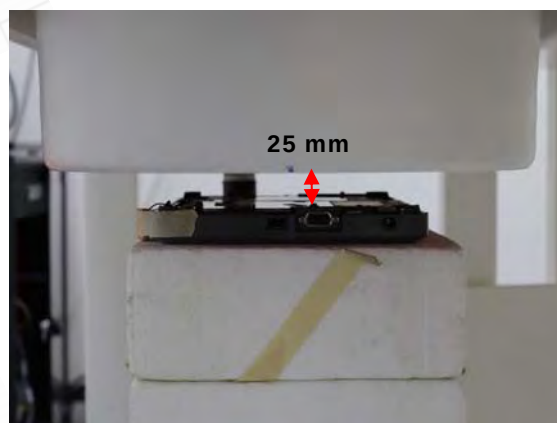


Fig.4 EUT Back side (25mm) to flat phantom

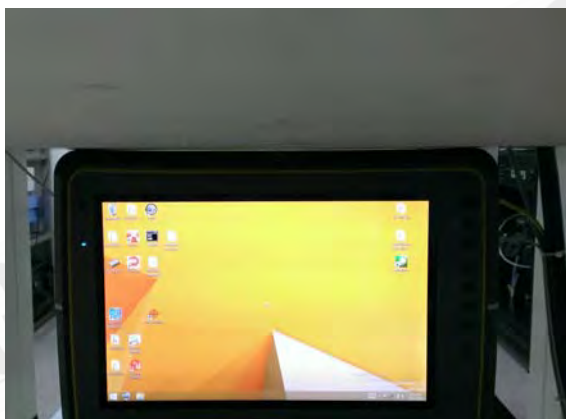


Fig.8 EUT Top side with transceiver to flat phantom

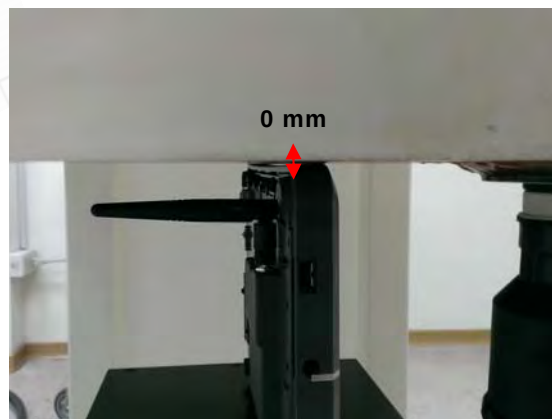


Fig.9 EUT Bottom side to flat phantom

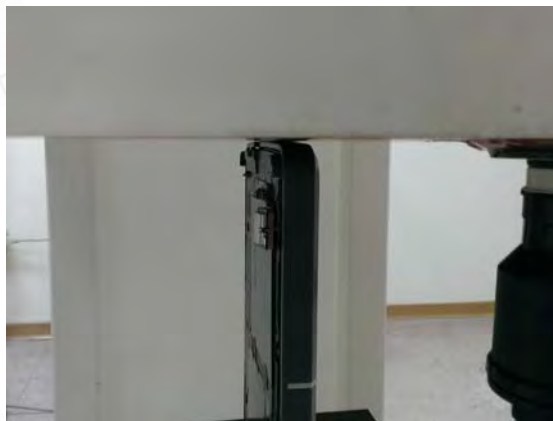
Fig.11 EUT Bottom side with transceiver to flat phantom
