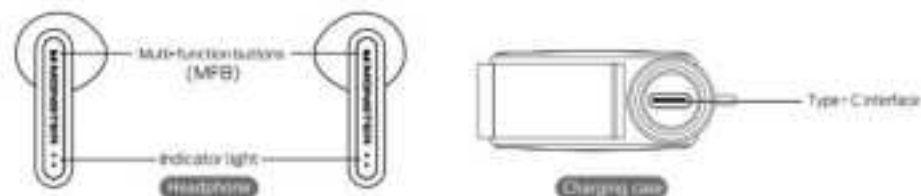

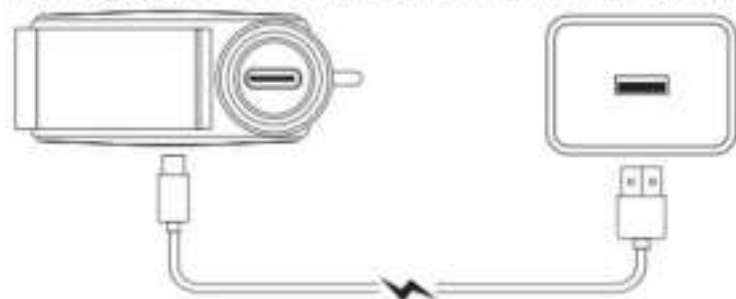

Product Schematic Description



Charge the charging case

Connect the charging case to the 5V power adapter with Type-C charging cable.



Rated input: 5V=30mA (Headphone) Rated input: 5V=200mA (Charging case)

Tips: When the ice blue indicator flashes while closing the cover, please charge in time.

Indicator guide

Mode	Describe	Sound prompt
Power On	Headset blue indicator lights on for 1 second	"Power on"
Power Off	The blue indicator of the headset blinks quickly three times	"Power off"
Pairing	The earphone blue indicator blinks	"Pairing"
Connected	Headphone indicator off	"Connected"
Disconnected	The blue indicator of the headset is blinking	"Disconnected"
Low Battery	—	"Battery Low"
Headphones placed in charging case	RGB lights fade after 12 seconds	—
Charging case low power	The red light blinks for 6 seconds	—
Charging case charged	RGB light gradient	—
Charging case fully charged	RGB light off	—

Product operating instructions

1. Power on

Method 1: Open the cover of the charging box, and turn on the headset automatically after taking it out.

Method 2: Press the function button on the left/right ear for 3 seconds

2. Power off

Method 1: Put the headphone/s into the charging case and close the cover.

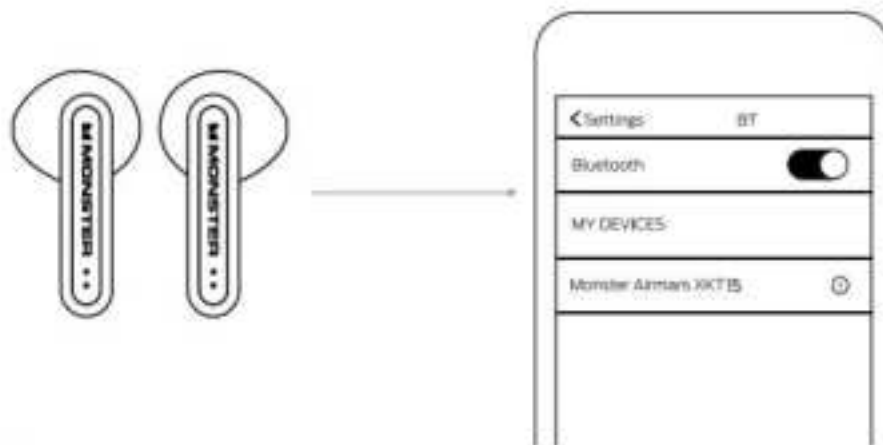
Method 2: After disconnected from the BT device for 3 minutes.

3. Pairing

Method 1: Open the charging case, the headphones will start pairing automatically.

Method 2: Open the Bluetooth list of smart devices and search for "Monster Airmars XKT15". Make a pair, and when you've successfully connected, you'll hear the prompt "Connected".

- * Beyond the distance, within 3 minutes of disconnection, return to the effective distance and automatically connect the device.



Note:

- * Fully charge the headphones and power off before an intended not-in-use period.
- * Unplug the charging cable after charging.

Operation

Normal



- Voice assistant: Press the left MFB for 2 seconds
- Volume +: Click right MFB
- Volume -: Click left MFB

Music playback



- Pause/Play: Double click Left/Right MFB
- Last song: Triple click left MFB
- Next song: Triple click right MFB

Phone



- Answer: Double click the left/right MFB
- Reject: Press left/right MFB for 2 seconds
- Hang up: Double click the left/right MFB

Game/music switching: device connected



- Press right MFB for 2 seconds to enter game mode
- Press right MFB for 2 seconds to enter music mode

Clear Bluetooth device Settings

Power on the earphone. If the earphone is not connected, click the left and right earphone five times, clear the connection information and earphone group information, and then power off

Precautions

1. After opening the cover of the charging box, take out the earphone to start automatically, pair and connect; Put the earphones in the charging case and charge the earphones. Earphones, Turn off the phone.
2. Charging every 15 days will extend battery life when not in use often. Cleaning off dirt on the charging contacts by cotton swabs with alcohol will maintain a good contact for charging.
3. Keep battery (battery pack) away from inflammables or excessive heat such sunlight, as direct
4. Intermittent is normal during playback for wireless products due to environmental factors, device brand, users' behavior, etc.

Warnings

1. Do not use headphones at high volume for an extended period of time.
2. Keep the headphones away from dust and water.
3. Do not disassemble the headphones and accessories, otherwise warranty will be voided.
4. Keep headphones away from any impact or vibration.
5. Do not use any chemical solvents or cleaning agent on the headphones.
