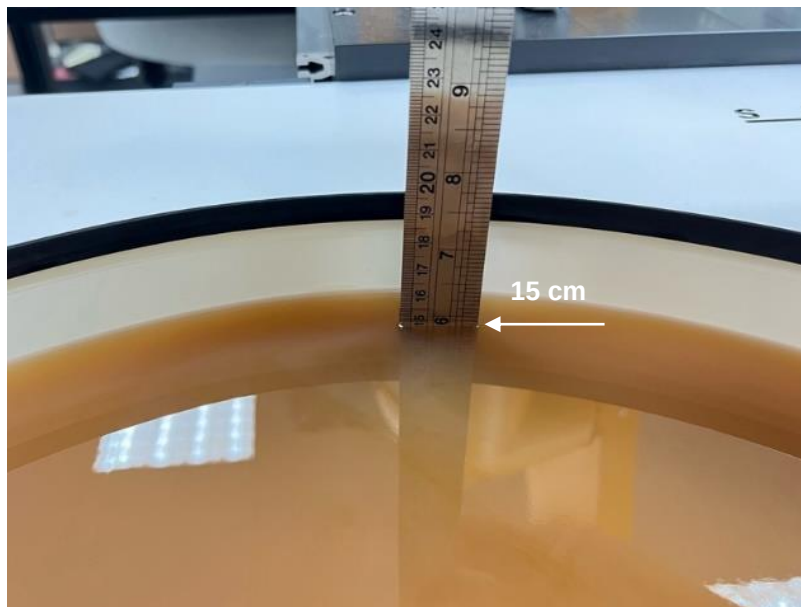

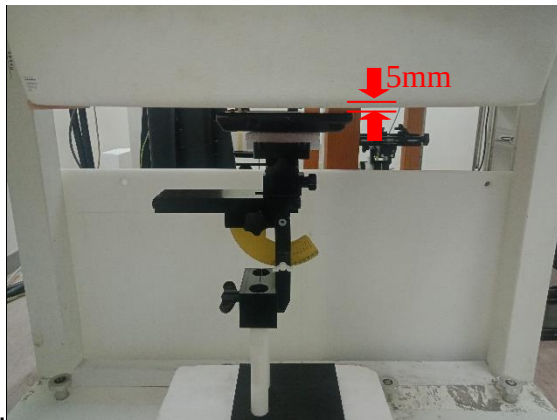

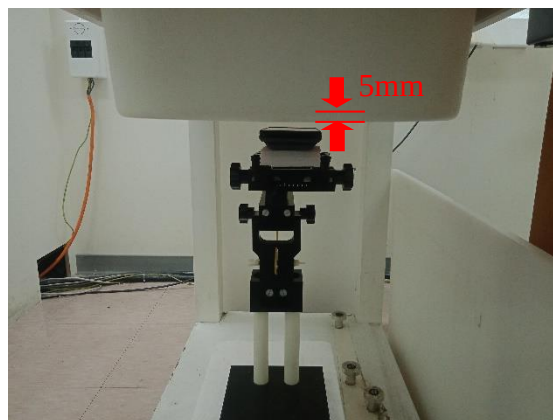

Body - distance between flat phantom and S1E2-L is 5 mm



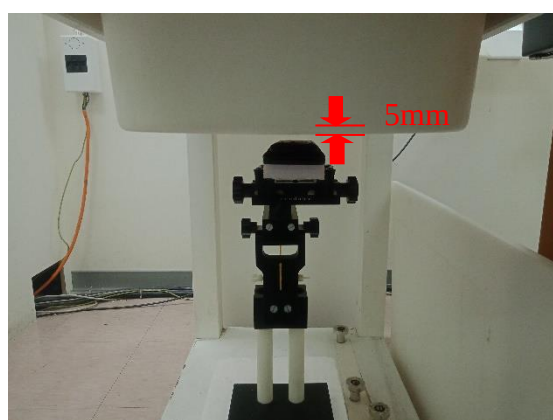
Photograph 1. Body, Front Surface, 5mm

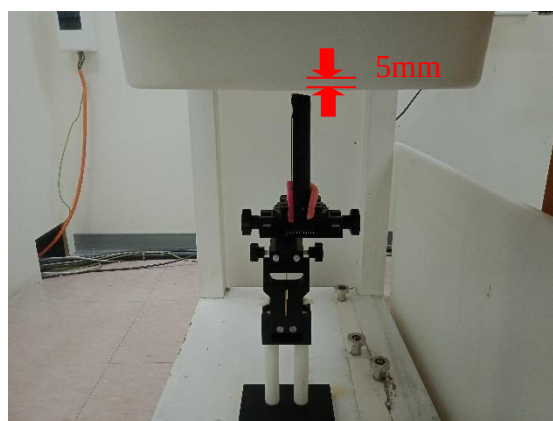
Photograph 3. Body, Back Surface, 5mm

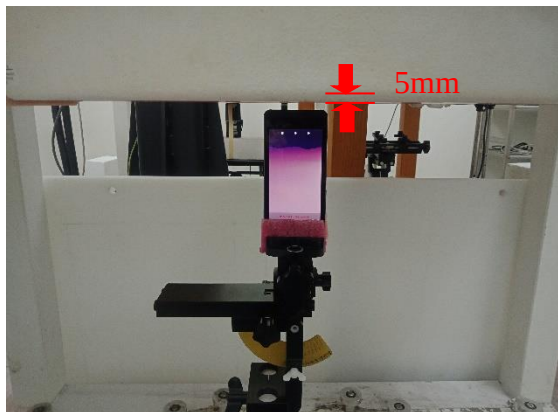
Photograph 5. Body, Top Edge, 5mm



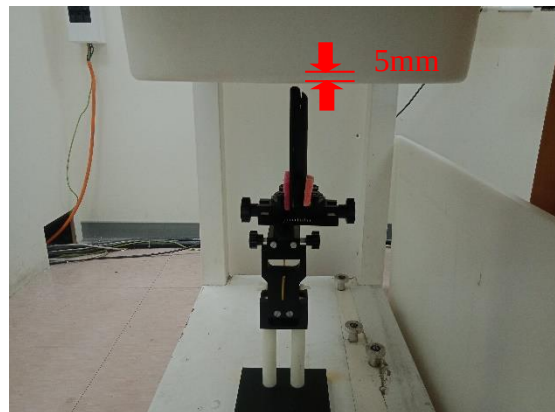
Photograph 6. Body, Top Edge, 5mm

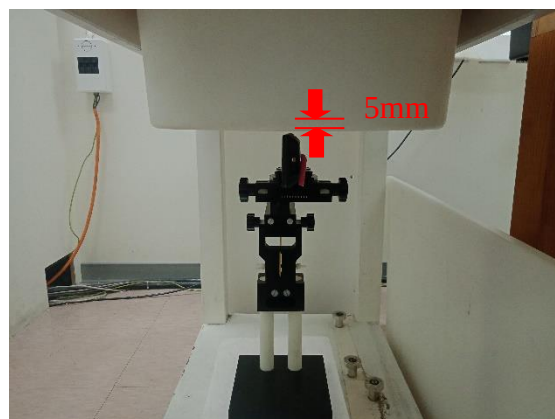
Photograph 7. Body, Bottom Edge, 5mm



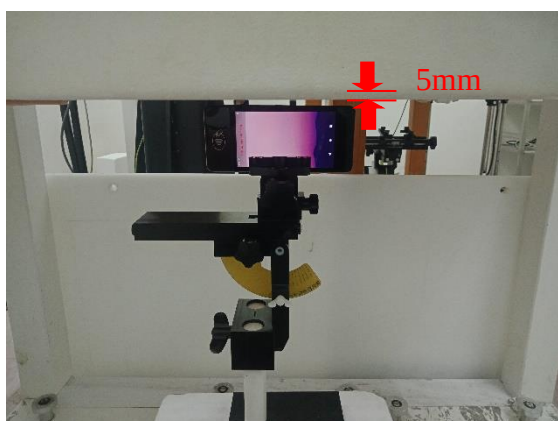
Photograph 8. Body, Bottom Edge, 5mm



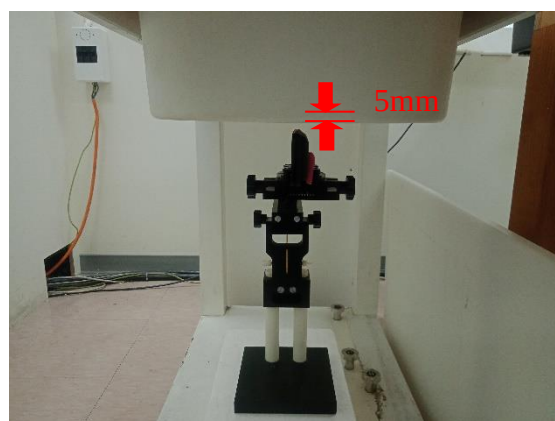
Photograph 9. Body, Left Edge, 5mm

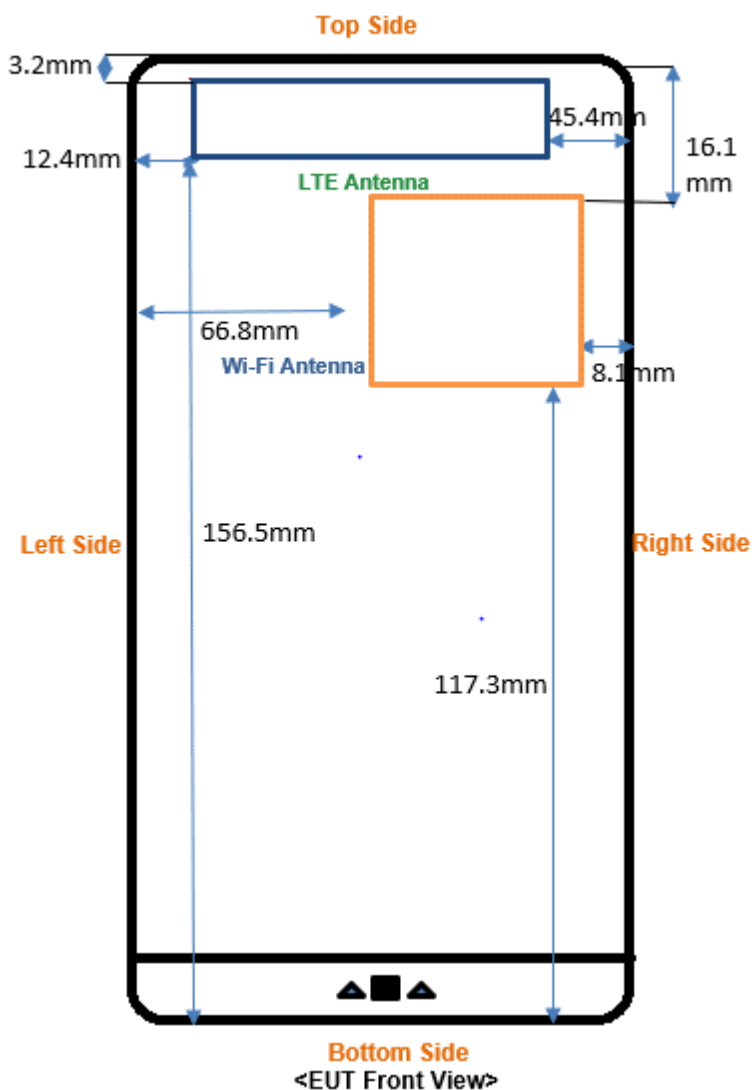
Photograph 13. Front view of EUT
