Install screw in desired location leaving 3/16" of the screw exposed.






Align mounting hole with screw head, slide the bracket over the screw head and let the plug drop down to lock into place.

Alexa, turn off front yard. Alexa, good morning. <u>Alexa</u>, turn on patio


