Conducted Peak Output Power_DH5_2402



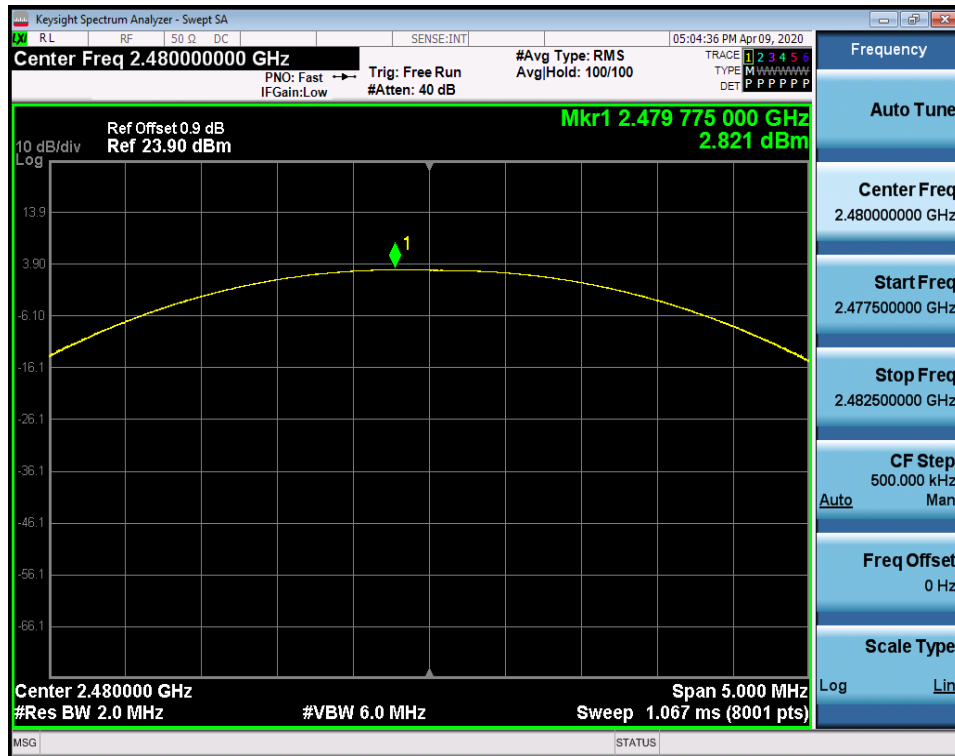

Band-edge for RF Conducted Emissions_DH5_2402_Hopping Off



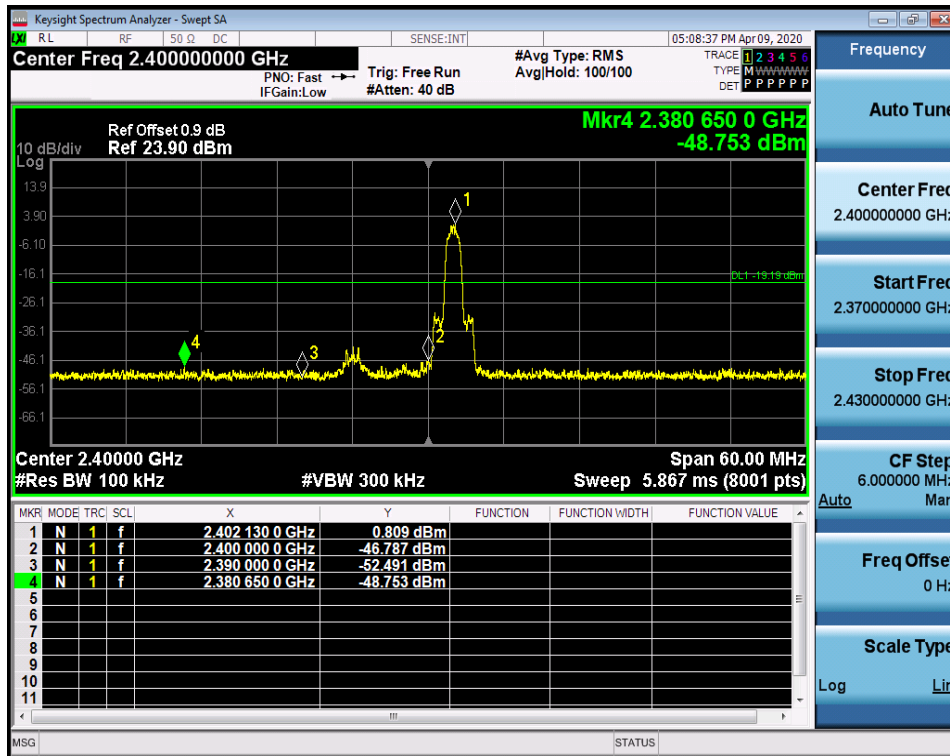
