**1.DO NOT** use if you have had an eye operation, or if you have any eye diseases such as glaucoma, cataract, and amotio retinae.

2.Disabled people, and the elderly should only use this product when properly supervised.

3.DO NOT use if you have any swelling in the eye area.

4.If you feel any pain around your eyes, please discontinue using the device and consult a physician.

**5.DO NOT** use in high temperatures or humid environments. Avoid direct exposure to the sun.

6.Do not use the device with wet hands.

7. Remove contact lenses, glasses, false eyelashes, hairpins, and hair accessories, etc before using.

8.Only use the charger (5V  $1\bar{A}$ , not included) to recharge the eye massager.

**9.DO NOT** clean the product with water; clean it with cotton soaked in alcohol.

10. Avoid contact with sharp objects.

11.Do not use this product while driving.

12.If any fault or malfunction should occur during use, take it off immediately. Never attempt to disassemble or repair the device yourself.

13.The device is for private use only and cannot be used as medical equipment. It is not intended for medical diagnosis, treatment, or commercial purposes.


14.Use it in the morning and evening for no more than 10 minutes each time.

### **Power Button**


Long press: Power ON/OFF Short press: Switch modes. (Quick press twice to switch between Silent Mode and Voice Mode.)

## **Using the Product**

### Charging

- 1.Use the 5V mobile charger (not included) to charge your eye massager.
- 2.Insert USB cable into the socket of the mobile charger.
- 3. Softly insert the USB plug into the socket of the device.
- 4. While charging, the LED indicator will flash red. When done charging, the LED indicator will be solid red.
- 5.The charge duration will be about 2 hours. Disconnect the power adapter after charging is complete.
- \* The massager and the adapter may become warm during normal charging process.
- \* Use time may differ depending on the operation mode selected.
- \* The device can not be turned on while charging.

### Wear this device

- 1. Loosen the adjustable headband.
- 2. Place the device around your head and tighten the headband to the appropriate fit.
- \* Be careful to ensure the device is not too tight around your head.
- \* Please make sure that you have removed your contact lenses, glasses, false eyelashes, etc. before using this device.
- \* Do not operate the device with wet hands.

### **Bluetooth Connection**

- 1. Turn on the device by long press the Power Button.
- 2. Enable your mobile phone Bluetooth setting and search for "R-G002", an audio voice "Bluetooth Connected" will confirm when the device is connected to Bluetooth.
- 3. After successfully pairing your device, music can be pushed to the device for playing while massaging.

**Note:** After connecting Bluetooth successfully for the first time, it will be connected automatically next time it's turned on.

### Operation

1.Long press the Power button to turn on the massager and there will be a voice prompt "Welcome to the RENPHO Eye Massager" and it will broadcast the current mode.

# This massage has memory function. It will run the mode selected last time.

2. Short press the Power Button to switch modes. An audio voice will confirm mode change.

3. Long press the Power Button to turn off the massager, the indicator light will go off.

**Auto-off timer:** a voice prompt "Your RENPHO Massage is complete" will be heard when the device has been in operation for 10 minutes. And indicator light will go off and the device will automatically shut down.

### Silent Mode & Voice Mode

Quick press the Power button twice to switch between Silent Mode

and Voice Mode.

In the silent mode, there will be a voice prompt "Silent Mode" and all the voice broadcast and built-in music will stop. Bluetooth music plays normally.

Note: Every time the product is turned on, it will enter Voice Mode.

### Warm Tips

- \* When you are using this device, please keep your eyes closed, lean back in the chair and completely relax your body.
- \* Your vision will become blurry for a short period of time after use. Regular vision will return faster if eyes are kept closed for a short while.

# **Cleaning and Maintenance**
