CHARGING



1. The included USB charging cable has a Micro USB plug and a standard USB plug.

2. Insert the Micro USB plug into the charging port on the neckbuds.

3. Insert the standard USB plug into the USB port of a computer or suitable USB charging adapter.

4. The LED Indicator will turn red while the neckbuds are charging. The LED Indicator will turn off when charging is complete.

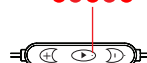
BLUETOOTH PAIRING

Blue Slowly Flashing LED



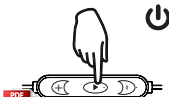
1. Press and hold the Play button for 2-3 seconds to power on the neckbuds.

2. The LED Indicator will alternately flash red and blue indicating the neckbuds are in pairing mode.

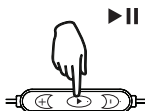
3. Go to the Bluetooth settings page on your smartphone. Make sure that Bluetooth is turned on. Connect to "MUZ4006".

4. The LED Indicator will slowly flash blue indicating the neckbuds are paired with your phone.

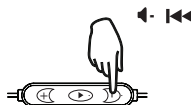
USING YOUR NECKBUDS



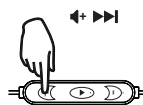
1. Press and hold the Play button to turn the neckbuds ON/OFF.

3. Press the Minus button to decrease the volume. Press and hold to go to the previous track.

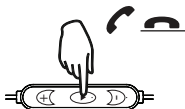


4. Press the Plus button to increase the volume. Press and hold to go to the next track.

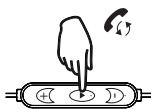
IMPORTANT SAFETY PRECAUTIONS
