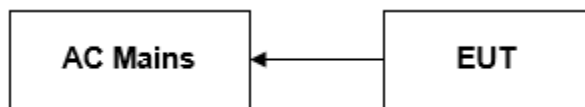

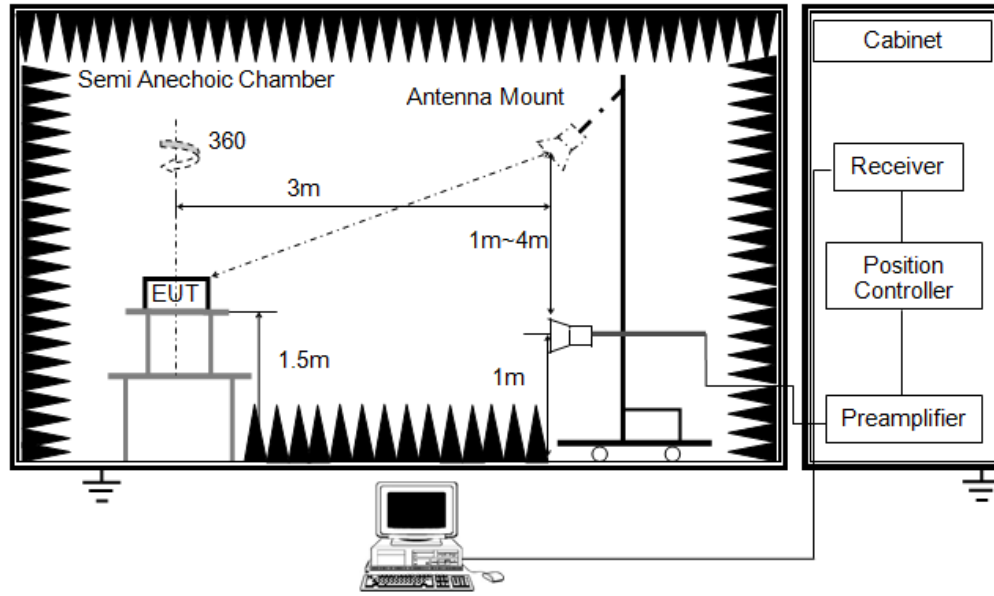
X axis, Y axis, Z axis positions:

Radiated emissions above 1GHz

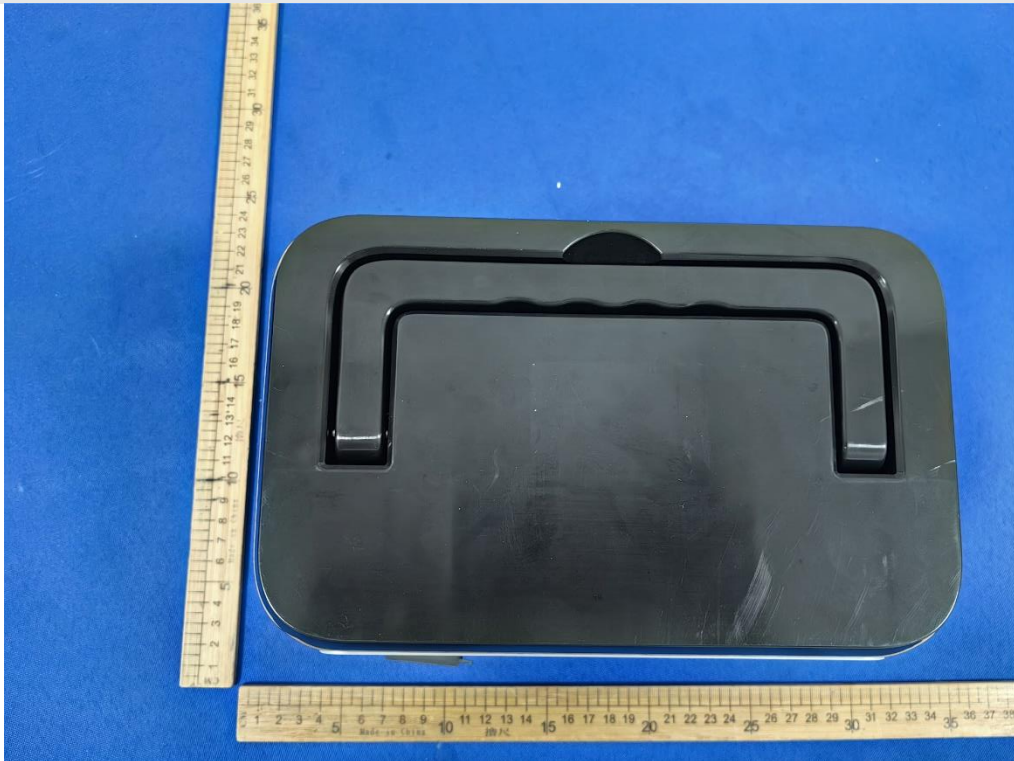
