Estimtion Result

[2402MHz, -11.26 dBm, (0.07 mW) output power], $(0.07/5)*[\sqrt{2.402(GHz)}] = 0.02$

[2426MHz, -11.88 dBm, (0.06 mW) output power], $(0.06/5)*[\sqrt{2.426}(GHz)] = 0.02$

 $[2480MHz, -8.55 dBm, (0.14 mW) output power], (0.14/5)*[<math>\sqrt{2.480(GHz)}] = 0.04$

Worse case is as below: 2402MHz+2426MHz+2480MHz=0.02+0.02+0.04=0.08< 3.0 for 1-g SAR Then SAR evaluation is not required.
