## 1.7. Description of Test Modes

The EUT has been tested under operating condition.

This test was performed with EUT in X, Y, Z position and the worst case was found when EUT in X position.

Worst-case mode and channel used for 150 KHz-30 MHz power line conducted emissions was determined to be IEEE 802.11a mode (Low Channel).

Worst-case mode and channel used for 9 KHz-1000 MHz radiated emissions was determined to be IEEE 802.11a mode (Low Channel).

Pre-test AC conducted emission at both voltage AC 120V/60Hz and AC 240V/50Hz, recorded worst case.

AC conducted emission pre-test at power adapter modes, recorded worst case;

Worst-Case data rates were utilized from preliminary testing of the Chipset, worst-case data rates used during the testing are as follows:

IEEE 802.11a Mode: 6 Mbps, OFDM.

IEEE 802.11n HT20 Mode: MCS0, OFDM.

## 2. TEST METHODOLOGY

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

The radiated testing was performed at an antenna-to-EUT distance of 3 meters. All radiated and conducted emissions measurement was performed at Shenzhen LCS Compliance Testing Laboratory Ltd.

### 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

### 2.2. EUT Exercise

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to FCC's request, Test Procedure 789033 D02 General U-NII Test Procedures New Rules v02r01 and KDB 662911 D01 Multiple Transmitter Output v02r01 is required to be used for this kind of FCC 15.407 UII device.

According to its specifications, the EUT must comply with the requirements of the Section 15.203, 15.205, 15.207, 15.209 and 15.407 under the FCC Rules Part 15 Subpart E

### 2.3. General Test Procedures

#### 2.3.1 Conducted Emissions

The EUT is directly placed on the ground. According to the requirements in Section 6.2.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

#### 2.3.2 Radiated Emissions

The EUT is placed on a turntable, which is directly placed on the ground. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10-2013.

## 5. TEST RESULT

### 5.1. 6dB Occupied Bandwidth Measurement

#### 5.1.1. Standard Applicable

Within the 5.725-5.85 GHz band, the minimum 6 dB bandwidth of U-NII devices shall be at least 500 kHz.

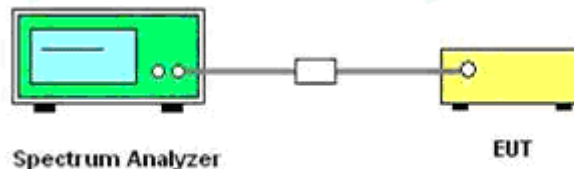

1. The transmitter output (antenna port) was connected to the spectrum analyzer in peak hold mode.
2. The resolution bandwidth of 100 KHz and the video bandwidth of 300 KHz were used.
3. Measured the spectrum width with power higher than 6dB below carrier.

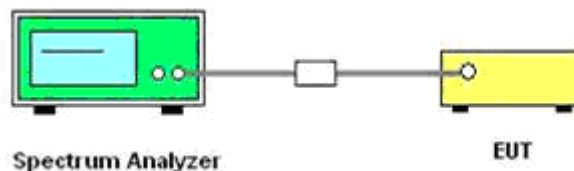

### 5.3. Maximum Conducted Output Power Measurement

#### 5.3.1. Standard Applicable

##### For 5725~5850MHz

For the band 5.725-5.85 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W. In addition, the maximum power spectral density shall not exceed 30 dBm in any 500-kHz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. However, fixed point-to-point U-NII devices operating in this band may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter conducted power. Fixed, point-to-point operations exclude the use of point-to-multipoint systems, omnidirectional applications, and multiple collocated transmitters transmitting the same information. The operator of the U-NII device, or if the equipment is professionally installed, the installer, is responsible for ensuring that systems employing high gain directional antennas are used exclusively for fixed, point-to-point operations.

According to KDB789033 D02 General UNII Test Procedures New Rules v02r01 Section 3 (a) Method PM (Measurement using an RF average power meter):

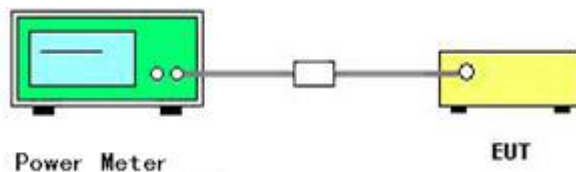
(i) Measurements may be performed using a wideband RF power meter with a thermocouple detector or equivalent if all of the conditions listed below are satisfied.

- The EUT is configured to transmit continuously or to transmit with a constant duty cycle.
- At all times when the EUT is transmitting, it must be transmitting at its maximum power control level.
- The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five.

(ii) If the transmitter does not transmit continuously, measure the duty cycle,  $x$ , of the transmitter output signal as described in section II.B.

(iii) Measure the average power of the transmitter. This measurement is an average over both the on and off periods of the transmitter.

## 5.4. Power Spectral Density Measurement

### 5.4.1. Standard Applicable

#### For 5725~5850MHz

For the band 5.725-5.85 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W. In addition, the maximum power spectral density shall not exceed 30 dBm in any 500-kHz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. However, fixed point-to-point U-NII devices operating in this band may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter conducted power. Fixed, point-to-point operations exclude the use of point-to-multipoint systems, omnidirectional applications, and multiple collocated transmitters transmitting the same information. The operator of the U-NII device, or if the equipment is professionally installed, the installer, is responsible for ensuring that systems employing high gain directional antennas are used exclusively for fixed, point-to-point operations.

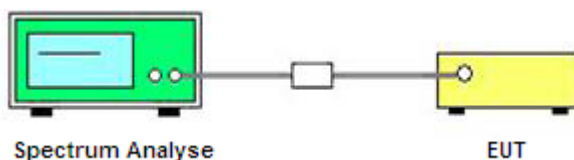

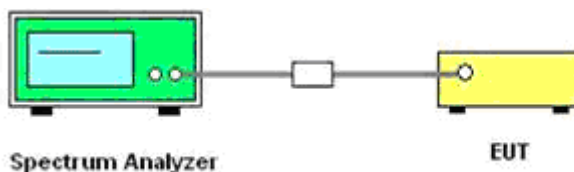
## 5.5. Emissions in Restricted Bands

### 5.5.1 Limit

According to §15.407 (b) Undesirable emission limits. Except as shown in paragraph (b) (7) of this section, the maximum emissions outside of the frequency bands of operation shall be attenuated in accordance with the following limits:

- (a) For transmitters operating in the 5.15-5.25 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of  $-27$  dBm/MHz.
- (b) For transmitters operating in the 5.25-5.35 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of  $-27$  dBm/MHz.
- (c) For transmitters operating in the 5.47-5.725 GHz band: All emissions outside of the 5.47-5.725 GHz band shall not exceed an e.i.r.p. of  $-27$  dBm/MHz.
- (d) For transmitters operating in the 5.725-5.85 GHz band:
  - (i) All emissions shall be limited to a level of  $-27$  dBm/MHz at 75 MHz or more above or below the band edge increasing linearly to 10 dBm/MHz at 25 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge, and from 5 MHz above or below the band edge increasing linearly to a level of 27 dBm/MHz at the band edge.
  - (ii) Devices certified before March 2, 2017 with antenna gain greater than 10 dBi may demonstrate compliance with the emission limits in §15.247(d), but manufacturing, marketing and importing of devices certified under this alternative must cease by March 2, 2018. Devices certified before March 2, 2018 with antenna gain of 10 dBi or less may demonstrate compliance with the emission limits in §15.247(d), but manufacturing, marketing and importing of devices certified under this alternative must cease before March 2, 2020.
- (e) The emission measurements shall be performed using a minimum resolution bandwidth of 1 MHz. A lower resolution bandwidth may be employed near the band edge, when necessary, provided the measured energy is integrated to show the total power over 1 MHz.
- (f) Unwanted emissions below 1 GHz must comply with the general field strength limits set forth in §15.209. Further, any U-NII devices using an AC power line are required to comply also with the conducted limits set forth in §15.207.
- (g) The provisions of §15.205 apply to intentional radiators operating under this section.
- (h) When measuring the emission limits, the nominal carrier frequency shall be adjusted as close to the upper and lower frequency band edges as the design of the equipment permits.

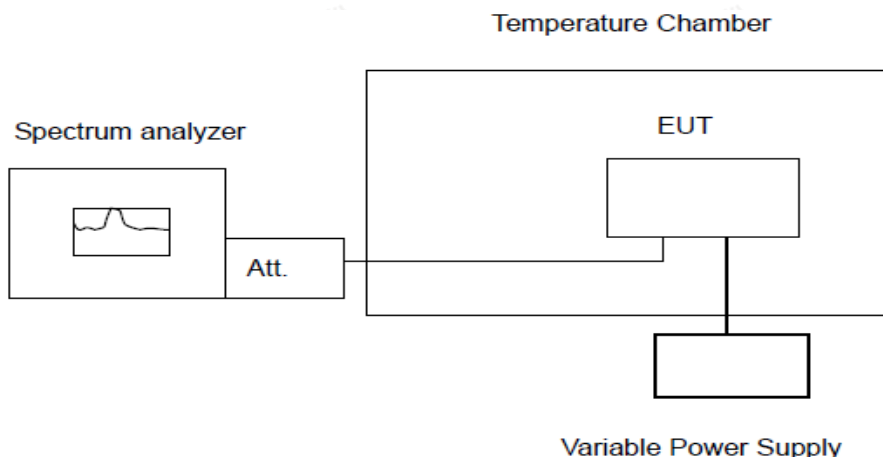

- (1) From  $-30^{\circ}$  to  $+50^{\circ}$  centigrade for all equipment except that specified in paragraphs (a) (2) and (3) of this section.
- (2) From  $-20^{\circ}$  to  $+50^{\circ}$  centigrade for equipment to be licensed for use in the Maritime Services under part 80 of this chapter, except for Class A, B, and S Emergency Position Indicating Radiobeacons (EPIRBS), and equipment to be licensed for use above 952 MHz at operational fixed stations in all services, stations in the Local Television Transmission Service and Point-to-Point Microwave Radio Service under part 21 of this chapter, equipment licensed for use aboard aircraft in the Aviation Services under part 87 of this chapter, and equipment authorized for use in the Family Radio Service under part 95 of this chapter.
- (3) From  $0^{\circ}$  to  $+50^{\circ}$  centigrade for equipment to be licensed for use in the Radio Broadcast Services under part 73 of this chapter.

The EUT was placed inside the temperature chamber. Set the spectrum analyzer RBW low enough to obtain the desired frequency resolution and measure EUT 20 degree operating frequency as reference frequency. Turn EUT off and set the chamber temperature to -30 degree. After the temperature stabilized for approximately 30 minutes recorded the frequency. Repeat step measure with 10 degree increased per stage until the highest temperature of +50 degree reached.

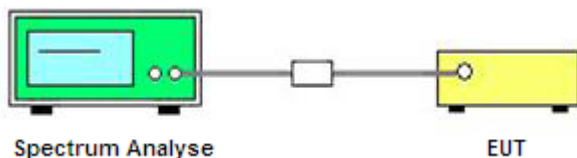

#### 1) Sequence of testing 9 kHz to 30 MHz

##### Setup:

- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- If the EUT is a tabletop system, a rotatable table with 0.8 m height is used.
- If the EUT is a floor standing device, it is placed on the ground.
- Auxiliary equipment and cables were positioned to simulate normal operation conditions.
- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- The measurement distance is 3 meter.
- The EUT was set into operation.

##### Premeasurement:

- The antenna is polarized vertical and horizontal.
- The antenna height changes from 1 to 3 meter.
- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

### Final measurement:

- The final measurement will be performed with minimum the six highest peaks.
- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ( $\pm 45^\circ$ ) and antenna movement between 1 and 4 meter.
- The final measurement will be done with QP detector with an EMI receiver.

- If the EUT is a tabletop system, a rotatable table with 1.5 m height is used.
- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- The measurement distance is 3 meter.
- The EUT was set into operation.

#### Premeasurement:

- The turntable rotates from 0° to 315° using 45° steps.
- The antenna is polarized vertical and horizontal.
- The antenna height scan range is 1 meter to 2.5 meter.
- At each turntable position and antenna polarization the analyzer sweeps with peak detection to find the maximum of all emissions.

#### Final measurement:

- The final measurement will be performed with minimum the six highest peaks.

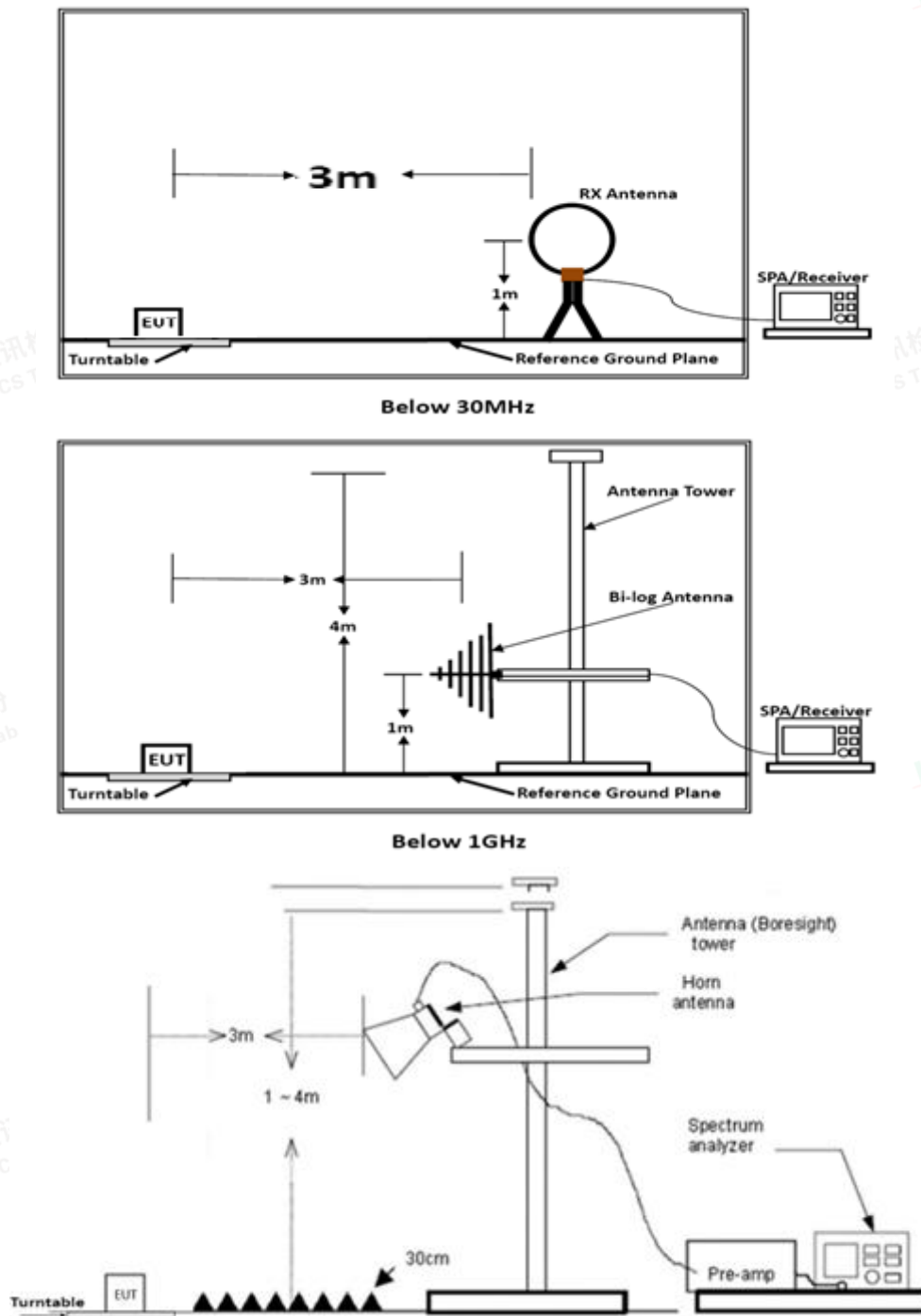

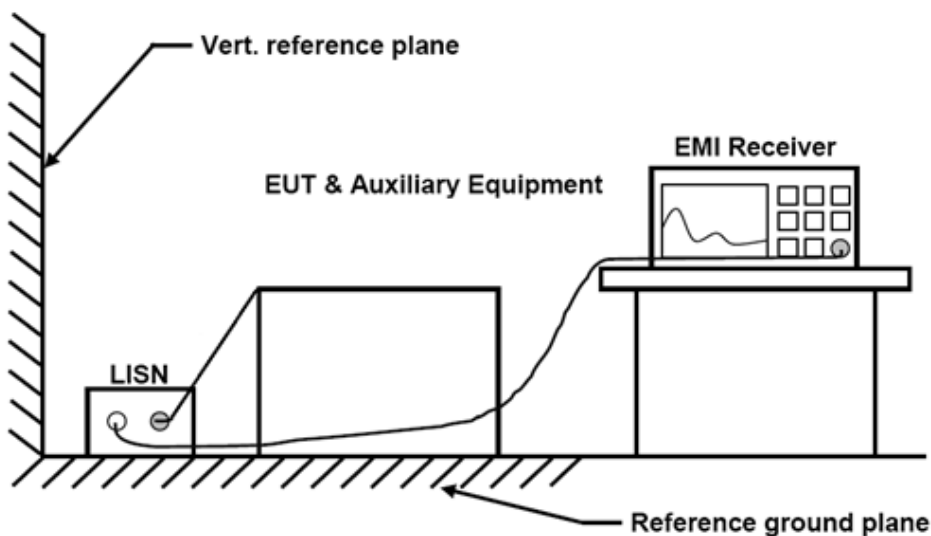
### 5.9.1 Standard Applicable

According to §15.207 (a): For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). The limits at specific frequency range are listed as follows:

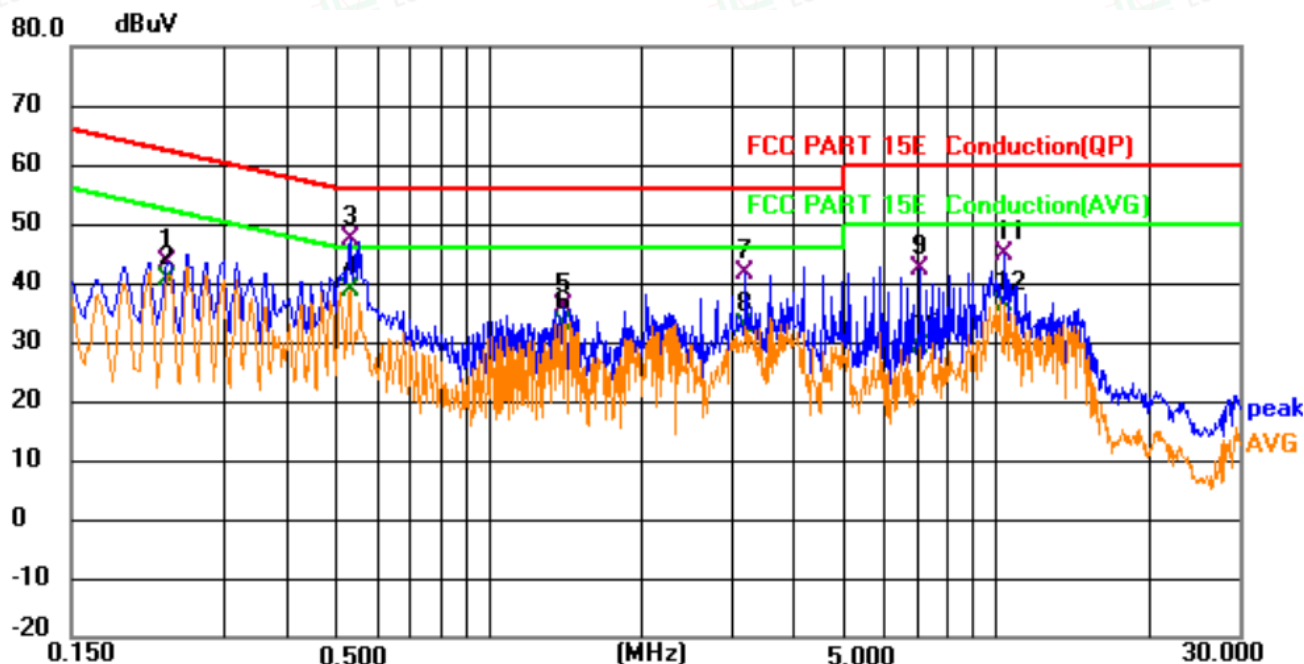

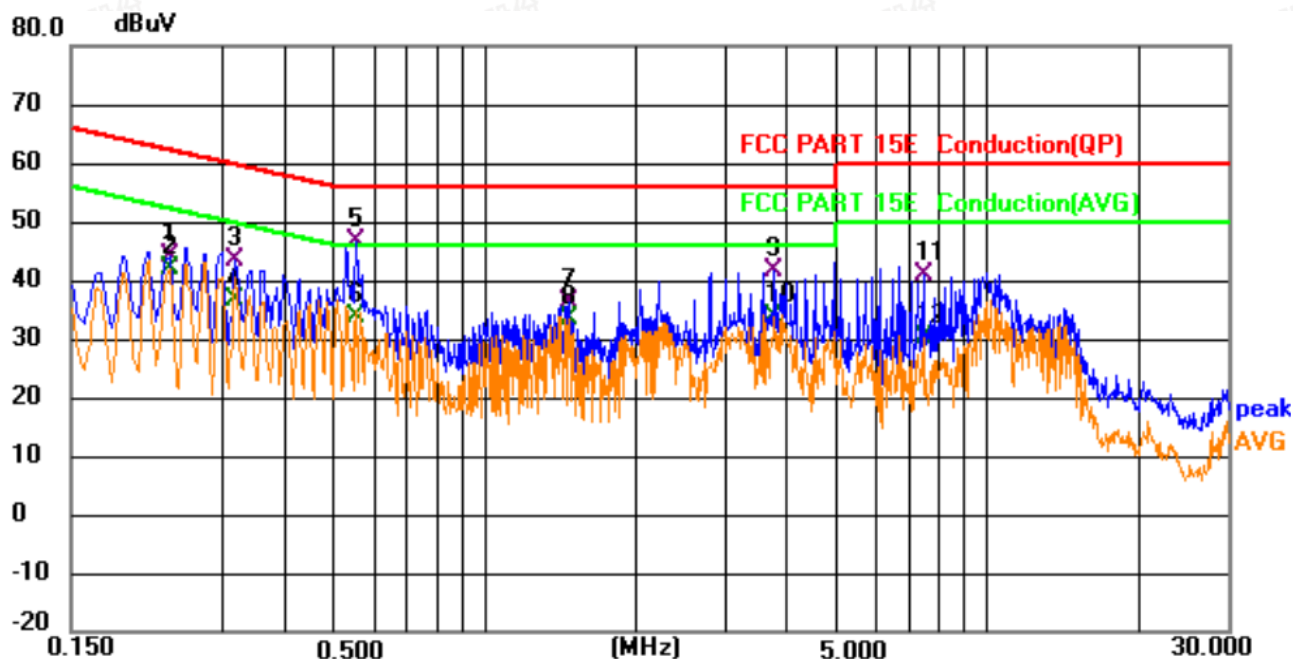

## 5.10. Antenna Requirements

### 5.10.1 Standard Applicable

For intentional device, according to FCC 47 CFR Section 15.203:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited

And according to FCC 47 CFR Section 15.407 (a), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

### 5.10.2 Antenna Connected Construction

#### 5.10.2.1. Standard Applicable

According to § 15.203 & RSS-Gen, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

#### 5.10.2.2. Antenna Connector Construction

The gains of antenna used for transmitting is 2.87dBi(Max), and the antenna is FPC Antenna connect to PCB board and no consideration of replacement. Please see EUT photo for details, meet 15.203 & RSS-Gen antenna requirement.
