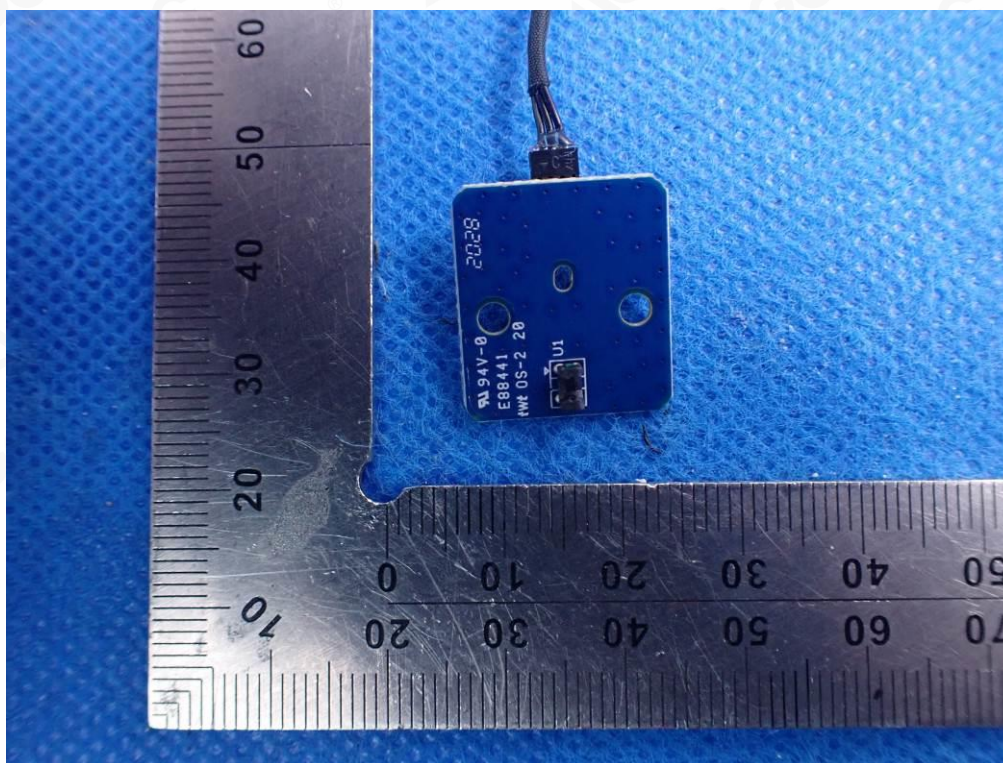




INTERNAL VIEW-7 OF EUT

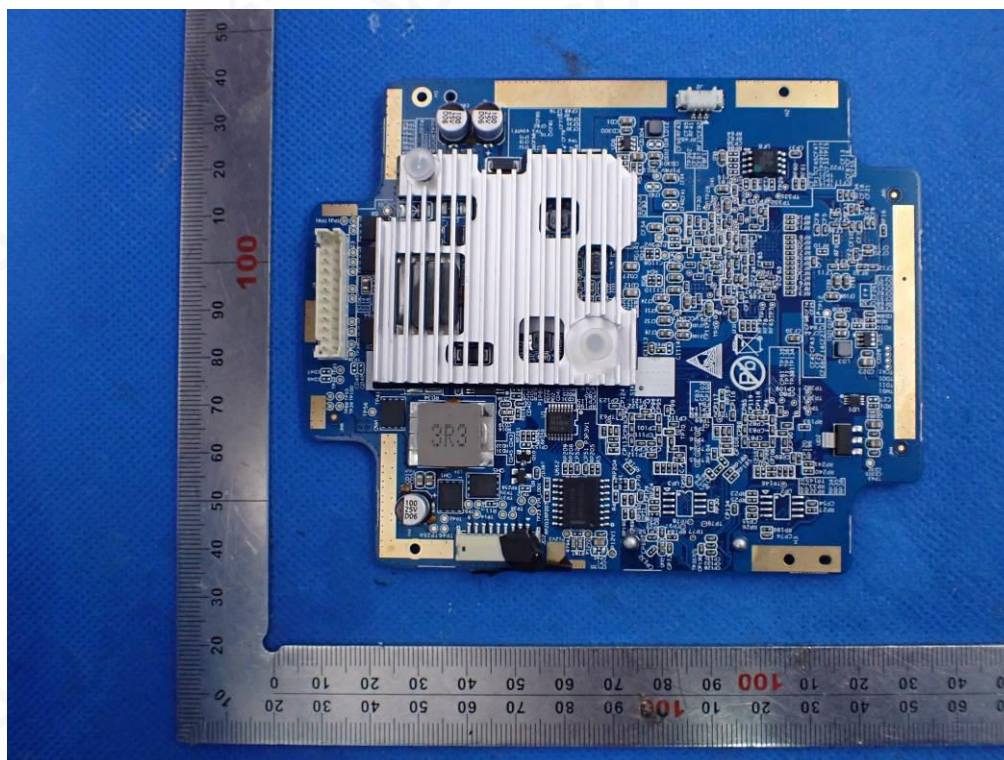

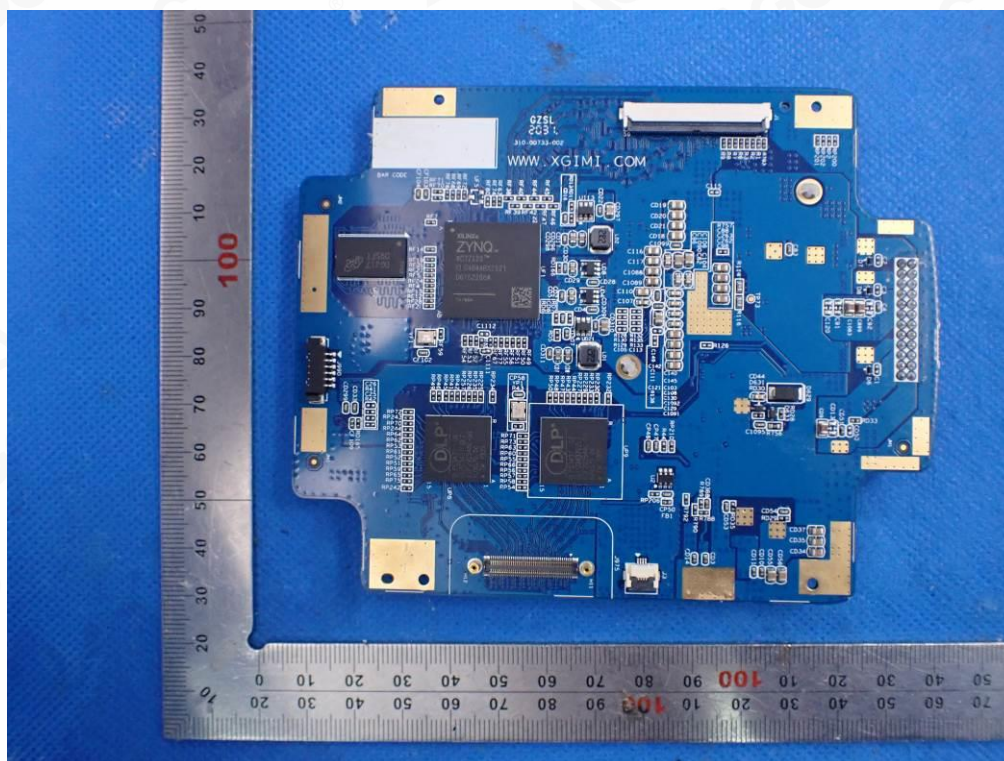




INTERNAL VIEW-9 OF EUT

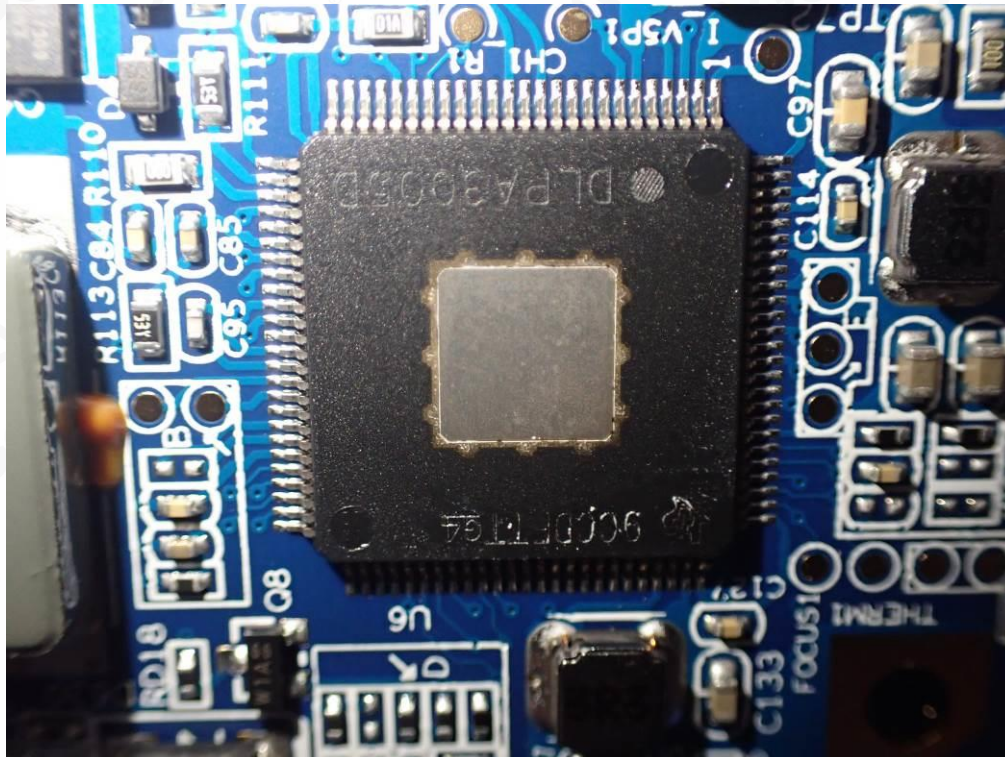

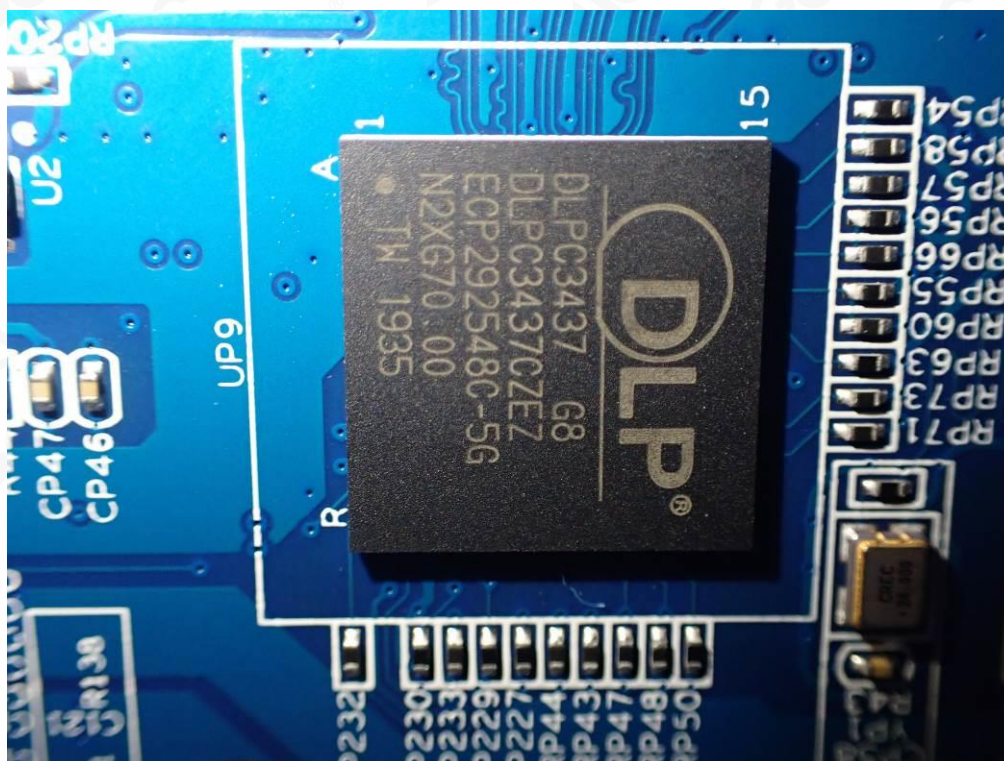

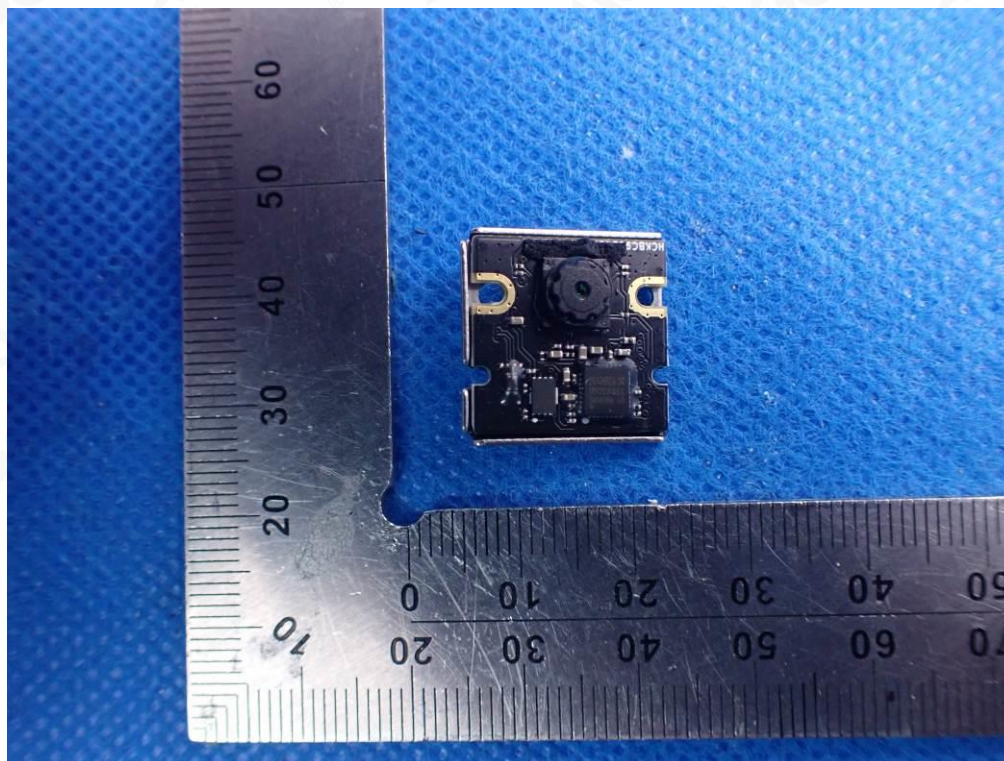




INTERNAL VIEW-15 OF EUT

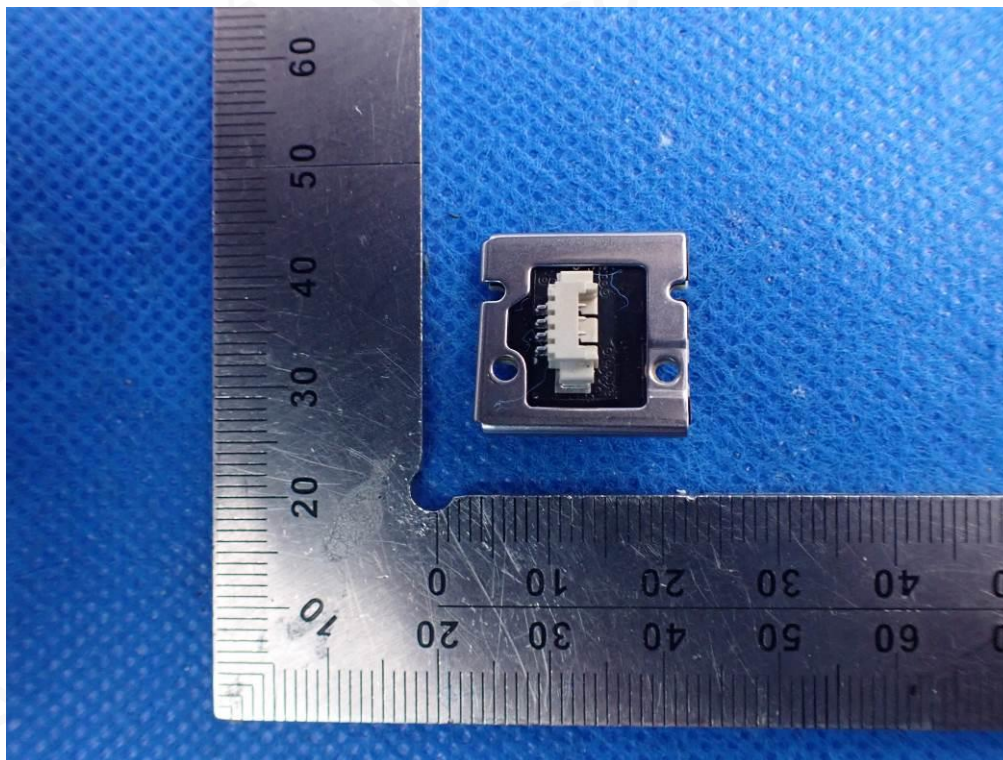

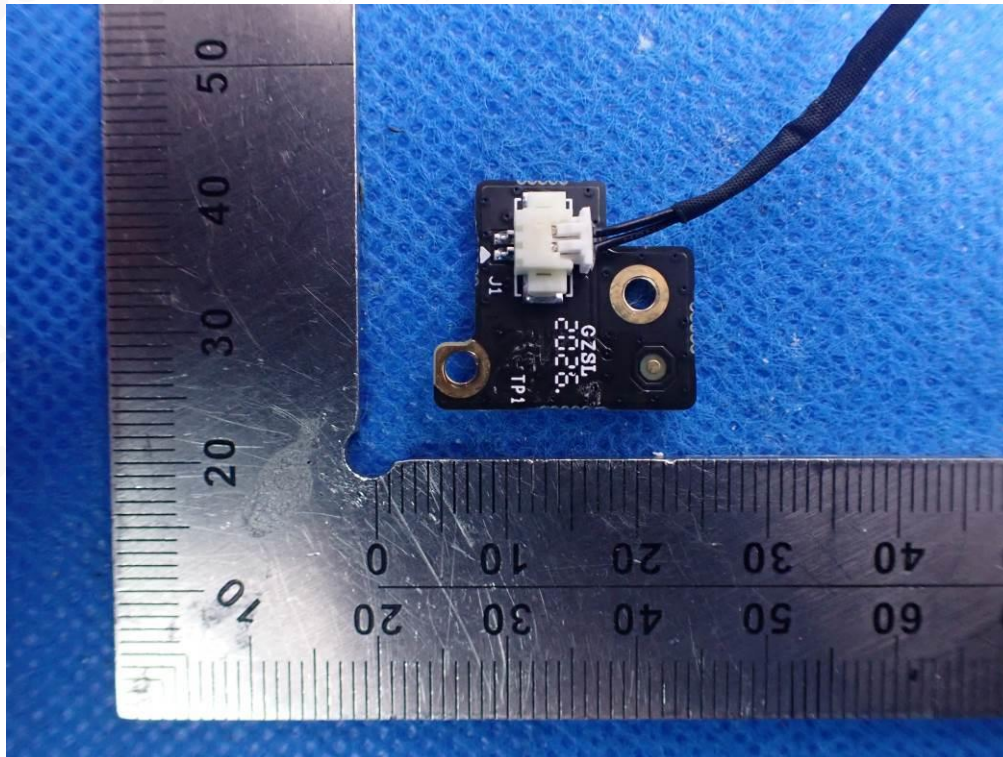




INTERNAL VIEW-17 OF EUT

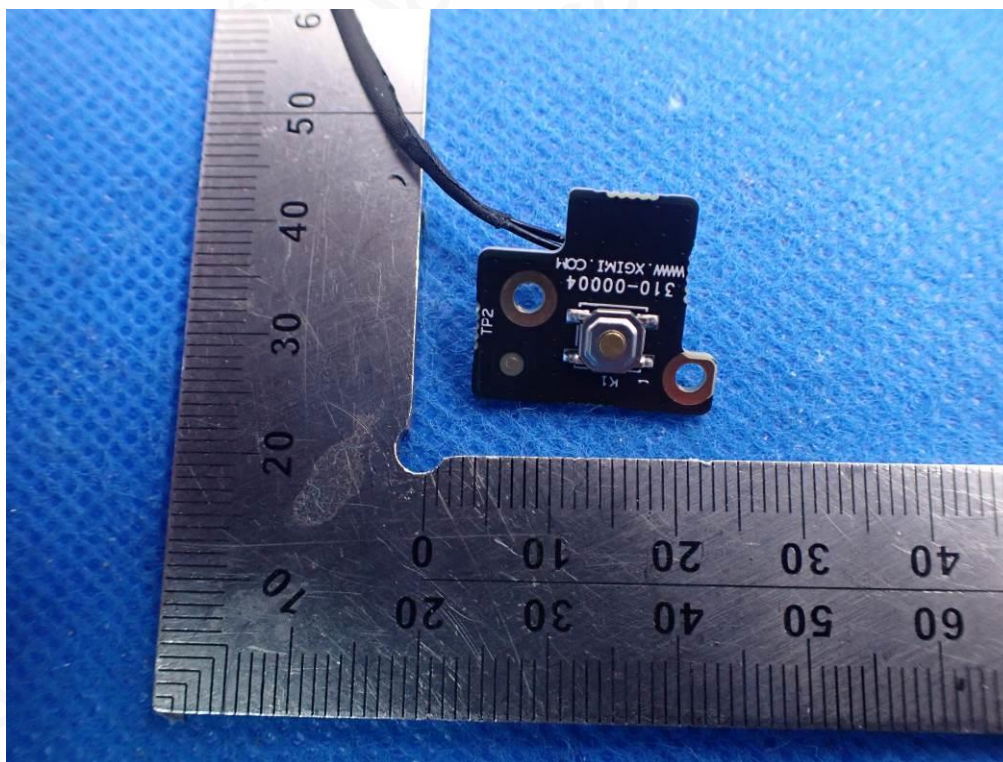

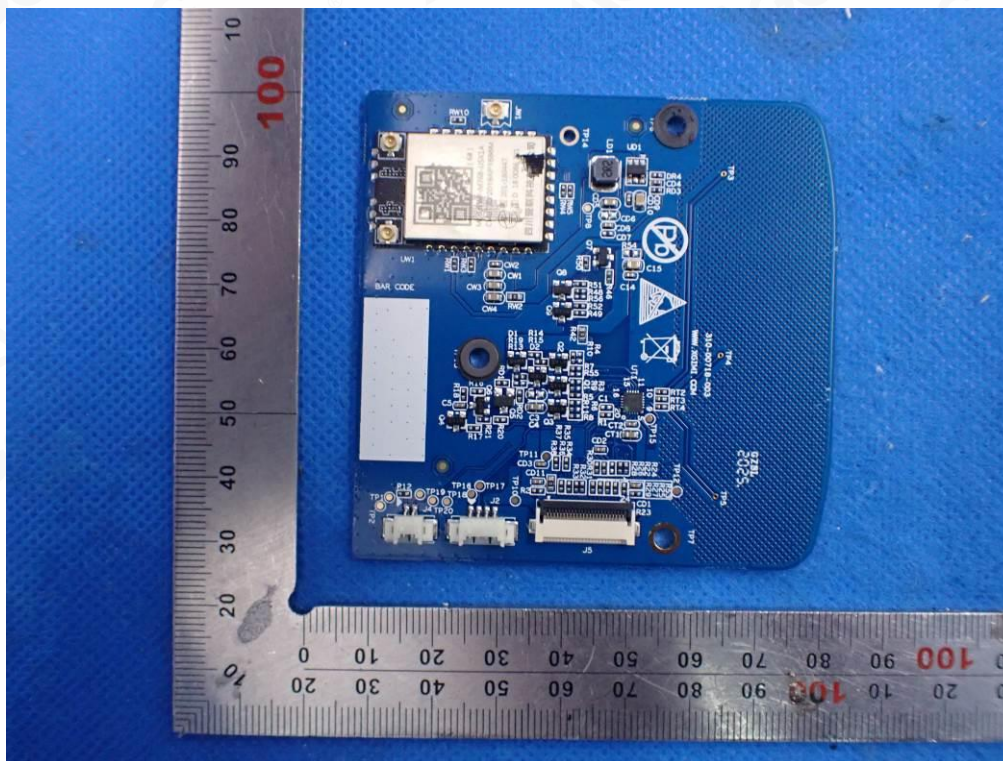




INTERNAL VIEW-19 OF EUT

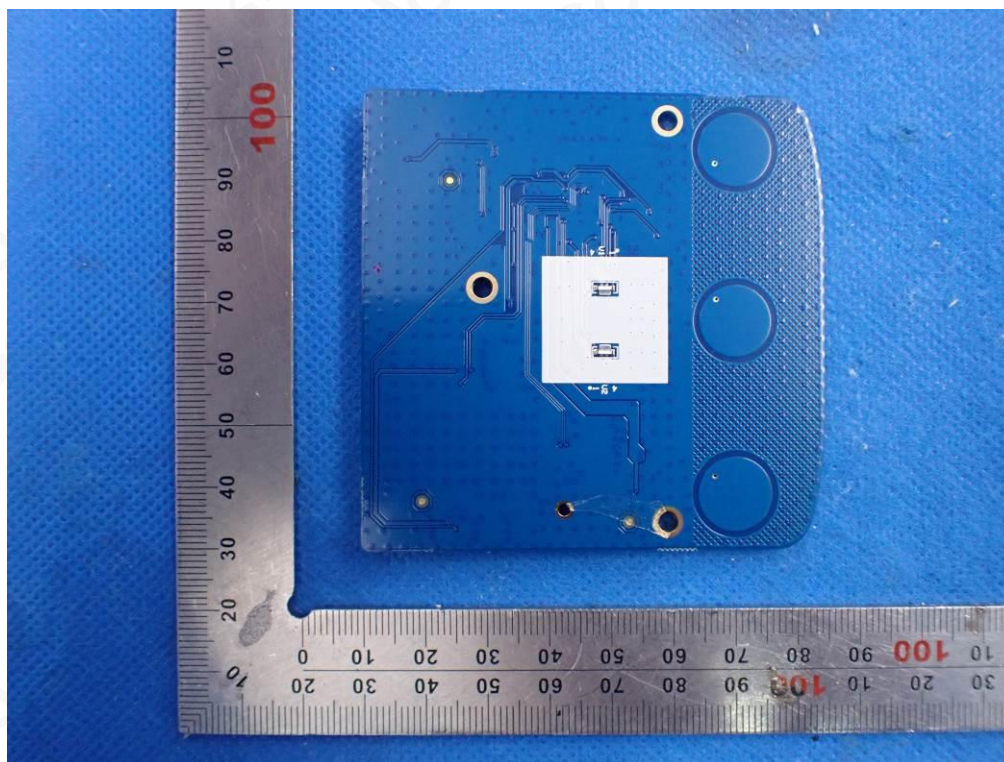

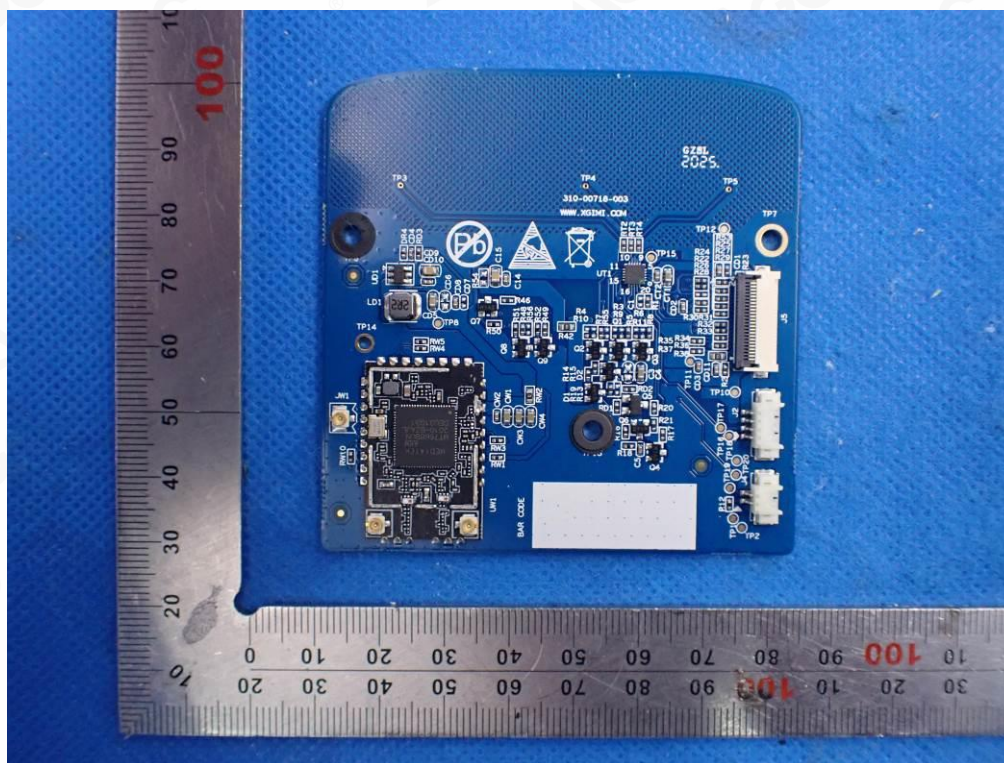




INTERNAL VIEW-21 OF EUT

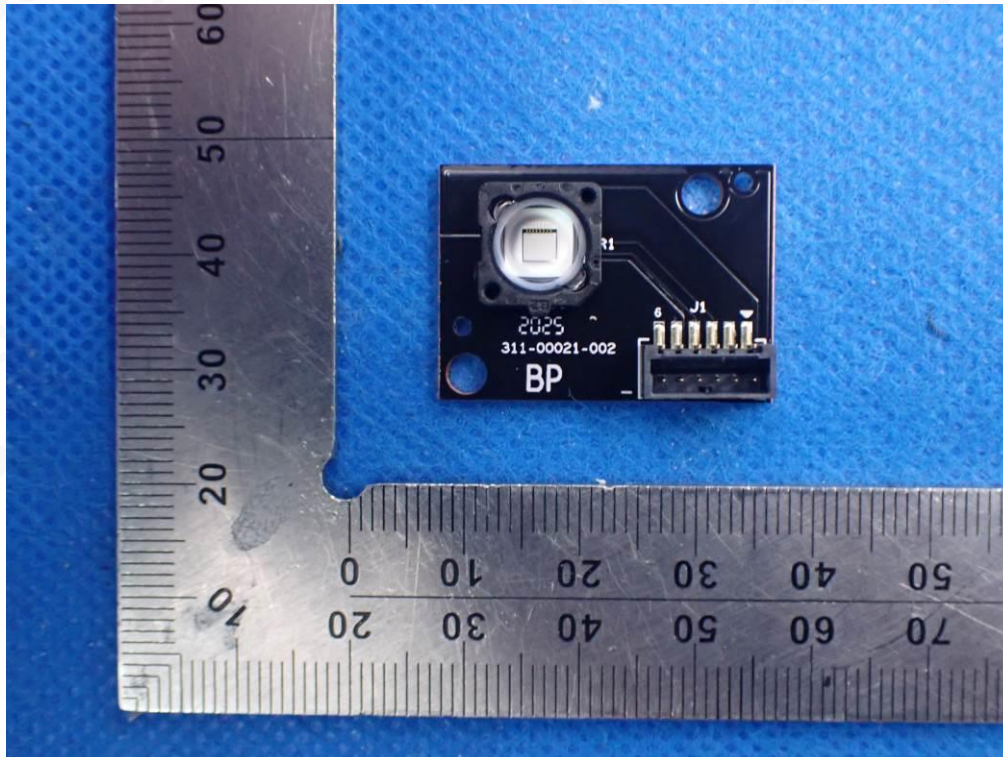

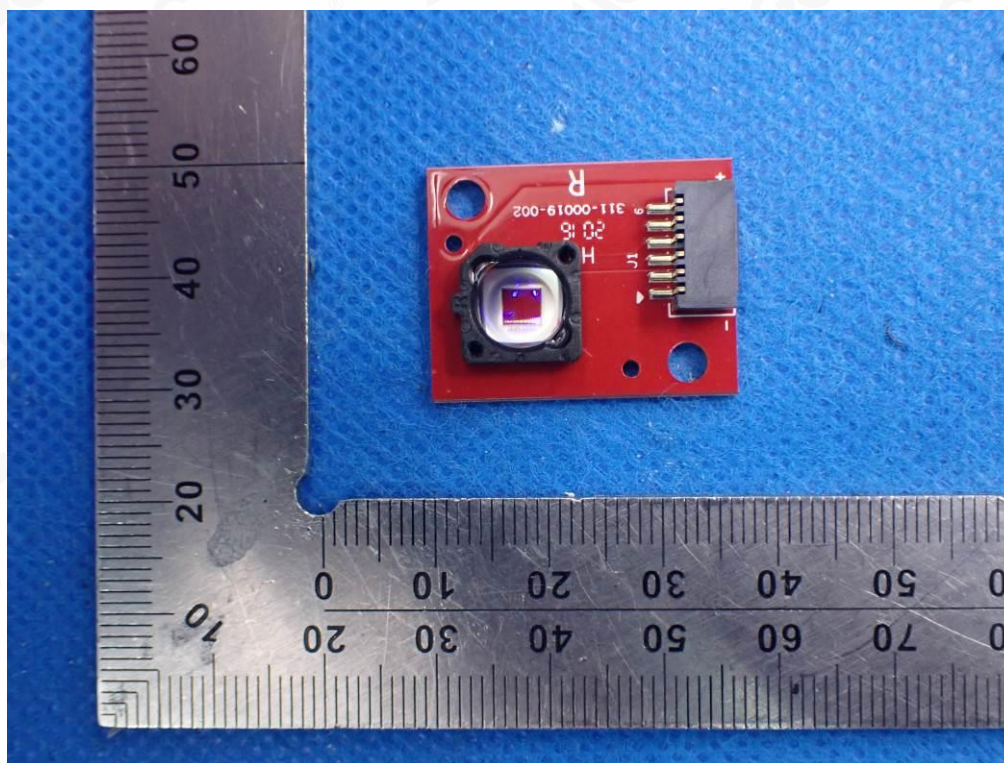

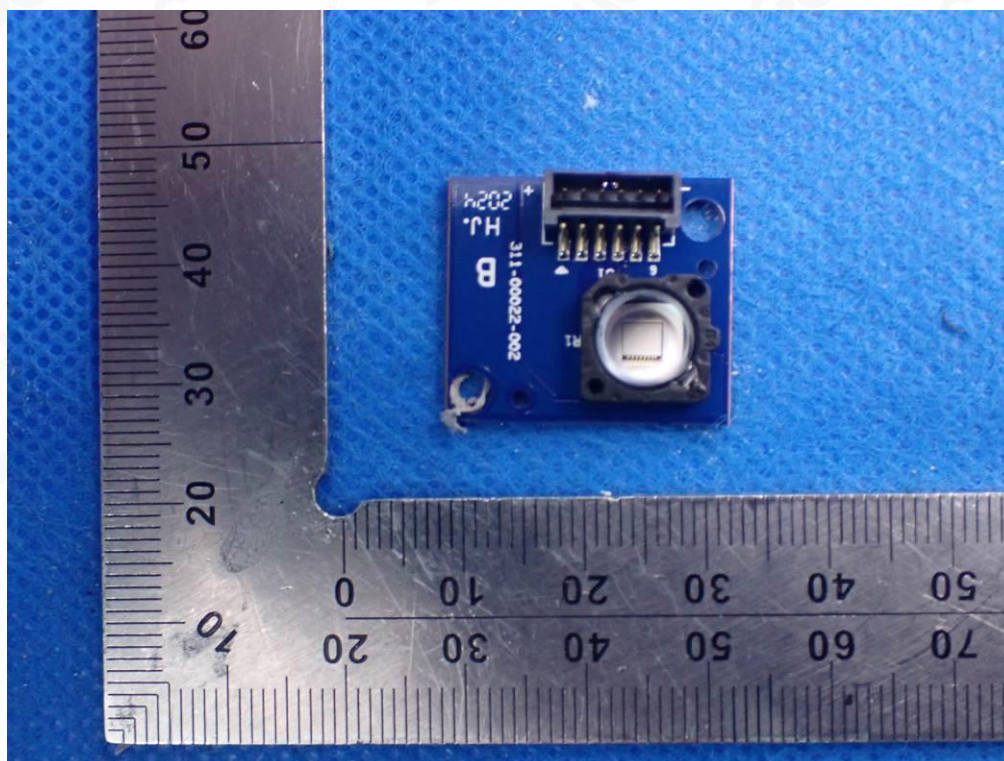

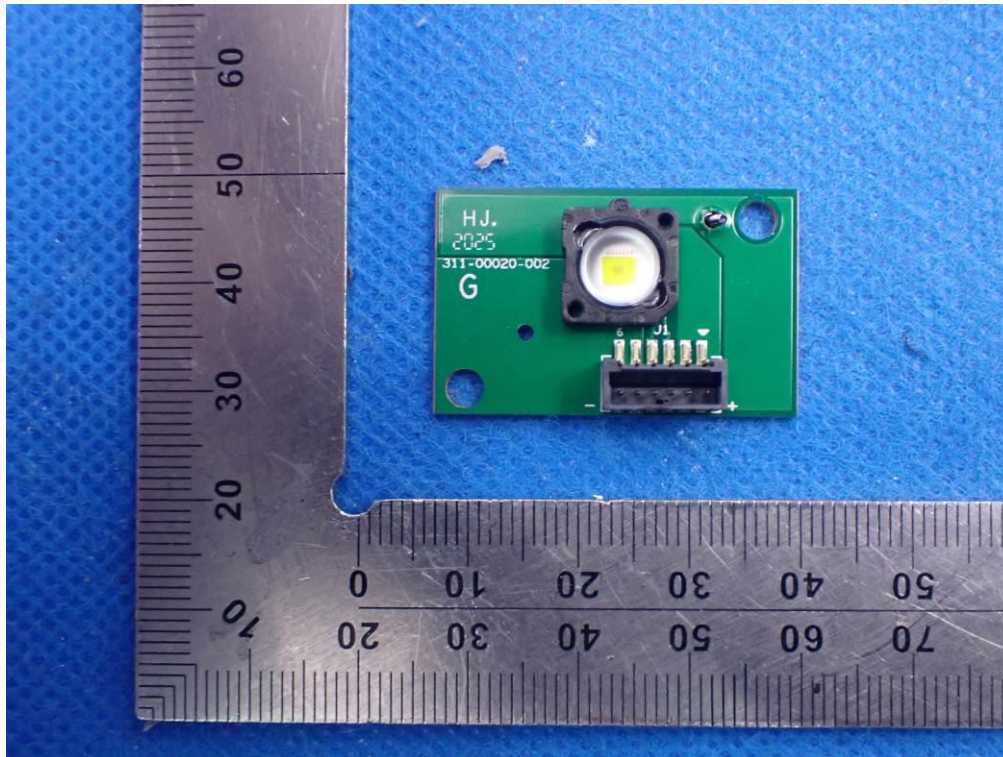
