#### CHARGING YOUR HEADSET

1. Plug the Micro-USB Charging cable into your earbuds.
2. Plug the USB port on a computer or power adapter.
3. Charge for 90 mins or until the red charging indicator light shuts off, then the blue indicator light will be on.
4. Unplug your earbuds, it is now ready for use.

#### CAUTION




1. When not in use for a prolonged period, it is recommended that you turn off the headset to lengthen battery life.
2. When the power indicator light flashes red, this indicates that the battery on your headset is low. it is recommended you echarge your headset.

#### USING YOUR WIRELESS HEADSET

- Turn On Headset:  
Press and hold the “” button for 3 seconds until the blue and red light turn on at the same time.

- Turn Off Headset:  
Press and hold the “” button for 2 seconds. The red light will flash 1 time, then the device will shut off.

- Pairing:  
Ensure Bluetooth is enabled on your mobile device or tablet. Make sure your device and your headset are no more than 3ft apart during this pairing process. Make sure the earbuds are still turned on and that the blue/red light are flashing alternately, then select “AZ Earbuds” from the list of available Bluetooth devices to pair.

- Answer a Call:  
Press the “”button quickly to answer an incoming call.
- Reject a Call:  
Press and hold the “” button to reject a call.
- Play/Pause Music:  
Press the “” button to play/pause music.

Volume Up: Long press “+”  
Volume Down: Long press “-”  
Previous Track: Click “+”  
Next Track: Click “-”
