Labelling Requirements

The FCC/IC allows electronic labelling if the product meets the eligibility requirements.

FCC KDB 784748 Section 4. Labeling requirements:

Users must be able to access the regulatory information without requiring special access codes or permissions, and in all cases the information must be accessible in no more than three steps from a product's main or home menu.

RSS-Gen Section 4. Labelling requirements:

Devices with an integrated display screen may have the required label information represented electronically in an e-label instead of on a physical label or nameplate.
