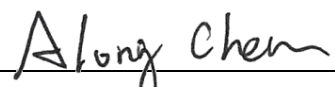

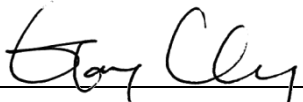

# 1 EXPOSURE EVALUATION OF PORTABLE DEVICES

## 1.1 SAR TEST EXCLUSION THRESHOLD FOR 100MHz to 6GHz and $\leq 50\text{mm}$

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by

$$[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}] \leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR, where}$$

- $f(\text{GHz})$  is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is  $< 5$  mm, a distance of 5 mm is applied to determine SAR test exclusion.

## 1.3 MEASUREMENT UNCERTAINTY

The measurement uncertainties given below are based on a 95% confidence level (based on a coverage factor ( $k=2$ )).

 $= 2.82 / 5 * \sqrt{2.480} = 0.888 < 3.0$

EDR

$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] * [\sqrt{f(\text{GHz})}]$   
 $= 8.91 / 5 * \sqrt{2.480} = 2.806 < 3.0$

SAR Test Exclusion Thresholds is  $< 10\text{mW}$  and  $3.0$  for separation distance  $5\text{mm}$ . Therefore, SAR test is not required.
