

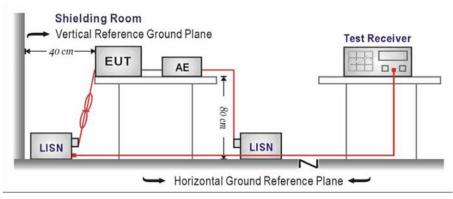

- 1. The EUT was setup according to ANSI C63.10 requirements.
- 2. The EUT was placed on a platform of nominal size, 1 m by 1.5 m, raised 80 cm above the conducting ground plane. The vertical conducting plane was located 40 cm to the rear of the EUT. All other surfaces of EUT were at least 80 cm from any other grounded conducting surface.
- The EUT and simulators are connected to the main power through a line impedances stabilization network (LISN). The LISN provides a 50 ohm /50uH coupling impedance for the measuring equipment.
- 4. The peripheral devices are also connected to the main power through a LISN. (Please refer to the block diagram of the test setup and photographs)

#### **TEST PROCEDURE**

- 1. The EUT was setup and tested according to ANSI C63.10.
- 2. The EUT is placed on a turn table which is 0.8 meter above ground for below 1 GHz, and 1.5 m for above 1 GHz. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
- 3. The EUT was set 3 meters from the receiving antenna, which was mounted on the top of a variable height antenna tower.
- 4. For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. RBW=120 kHz, VBW=300 kHz, Sweep=auto, Detector function=peak, Trace=max hold; If the emission level of the EUT measured by the peak detector is 3 dB lower than the applicable limit, the peak emission level will be reported. Otherwise, the emission measurement will be repeated using the quasi-peak detector and reported.

c) Set RBW=1MHz, VBW=3MHz for >1GHz, Sweep time=auto, Detector=peak, Trace=max hold for Peak measurement

- VBW=10Hz, When duty cycle is no less than 98 percent


