4.3 DESCRIPTION OF TEST MODES

The EUT has been tested under its typical operating condition.

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

The Transmitter was operated in the normal operating mode. The TX frequency was fixed which was for the purpose of the measurements.

Test of channel included the lowest and middle and highest frequency to perform the test, then record on this report.

Pre-defined engineering program for regulatory testing used to control the EUT for staying in continuous transmitting and receiving mode is programmed.






SETUP OF EQUIPMENT UNDER TEST

RADIO FREQUENCY TEST SETUP 1

The EUT wireless component's antenna ports(s) of the EUT are connected to the measurement instrument per an appropriate attenuator. The EUT is controlled by PC/software to emit the specified signals for the purpose of measurements.



RADIO FREQUENCY TEST SETUP 2

The test site semi-anechoic chamber has met the requirement of NSA tolerance 4 dB according to the standards: ANSI C63.10. The test distance is 3m.The setup is according to the requirements in Section 13.1.4.1 of ANSI C63.10-2013 and CAN/CSA-CEI/IEC CISPR 22.

Below 30MHz:

The EUT is placed on a turntable 0.8 meters above the ground in the chamber, 3 meter away from the antenna (loop antenna). The Antenna should be positioned with its plane vertical at the specified distance from the EUT and rotated about its vertical axis for maximum response at each azimuth about the EUT. The center of the loop shall be 1 m above the ground. For certain applications, the loop antenna plane may also need to be positioned horizontally at the specified distance from the EUT.


30MHz-1GHz:

The EUT is placed on a turntable 0.8 meters above the ground in the chamber, 3 meter away from the antenna. The maximal emission value is acquired by adjusting the antenna height, polarisation and turntable azimuth. Normally, the height range of antenna is 1 m to 4 m, the azimuth range of turntable is 0° to 360°, and the receive antenna has two polarizations Vertical (V) and Horizontal (H).

Above 1GHz:


The EUT is placed on a turntable 1.5 meters above the ground in the chamber, 3 meter away from the antenna. The maximal emission value is acquired by adjusting the antenna height, polarisation and turntable azimuth. Normally, the height range of antenna is 1 m to 4 m, the azimuth range of turntable is 0° to 360°, and the receive antenna has two polarizations Vertical (V) and Horizontal (H).

(a) Radiated Emission Test Set-Up, Frequency Below 30MHz






(b) Radiated Emission Test Set-Up, Frequency Below 1000MHz



(c) Radiated Emission Test Set-Up, Frequency above 1000MHz






7.3 CONDUCTED EMISSION TEST SETUP


The mains cable of the EUT (maybe per AC/DC Adapter) must be connected to LISN. The LISN shall be placed 0.8 m from the boundary of EUT and bonded to a ground reference plane for LISN mounted on top of the ground reference plane. This distance is between the closest points of the LISN and the EUT. All other units of the EUT and associated equipment shall be at least 0.8m from the LISN.

Ground connections, where required for safety purposes, shall be connected to the reference ground point of the LISN and, where not otherwise provided or specified by the manufacturer, shall be of same length as the mains cable and run parallel to the mains connection at a separation distance of not more than 0.1 m. According to the requirements in Section 13.1.4.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-Peak and average detector mode.

The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.

Set to the maximum power setting and enable the EUT transmit continuously

Set RBW ≥ 1% of the 20 dB bandwidth(30KHz)

Set the video bandwidth (VBW) ≥ RBW(100KHz).

Set Span= approximately 2 to 3 times the 20 dB bandwidth

Set Detector = Peak.




20dB Occupied Bandwidth & 99% Occupied Bandwidth Test Model GFSK

Channel: 2440MHz






20dB Occupied Bandwidth & 99% Occupied Bandwidth

8.2.4 Test Procedure

This test is required for any spurious emission that falls in a Restricted Band, as defined in Section 15.205. It must be performed with the highest gain of each type of antenna proposed for use with the EUT. Use the following spectrum analyzer settings:

Peak power measurement procedures for Above 1GHz:

The EUT was placed on a turn table which is 1.5m above ground plane.

Maximum procedure was performed on the highest emissions to ensure EUT compliance.

Span = wide enough to fully capture the emission being measured

RBW = 1 MHz

VBW ≥ [3 × RBW]

Sweep = auto

Detector function = peak

Trace = max hold

Average power measurement procedures for Above 1GHz:

- a) The EUT shall be configured to operate at the maximum achievable duty cycle
- b) Measure the duty cycle D of the transmitter output signal.
- c) RBW = 1 MHz.
- d) VBW \geq [3 × RBW].
- e) Detector = RMS (power averaging), if span / (# of points in sweep) \leq (RBW / 2). Satisfying this condition may require increasing the number of points in the sweep or reducing the span. If this condition cannot be satisfied, then the detector mode shall be set to peak.
- f) Averaging type = power (i.e., rms):
- g) Sweep time = auto.
- h) Perform a trace average of at least 100 traces.
- i) A correction factor shall be added to the measurement results prior to comparing with the emission limit to compute the emission level that would have been measured had the test been performed at 100% duty cycle. The correction factor is computed as follows:



- 1) If power averaging (rms) mode was used in step f), then the applicable correction factor is $[10 \log (1 / D)]$, where D is the duty cycle.
- 2) If linear voltage averaging mode was used in step f), then the applicable correction factor is [20 log (1 / D)], where D is the duty cycle.
- 3) If a specific emission is demonstrated to be continuous (D ≥ 98%) rather than turning ON and OFF with the transmit cycle, then no duty cycle correction is required for that emission.

Reduction of the measured emission amplitude levels to account for operational duty cycle is not permitted. Determining compliance is based on emission levels occurring during transmission; it is not based on an average across ON and OFF times of the transmitter.
