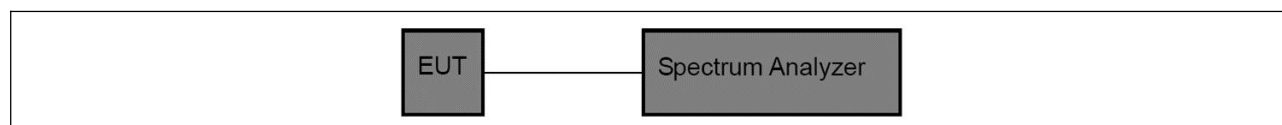
6. Channel Separation
