When the speaker is low on power, a tone(du du) will be heard indicating that it needs to be recharged.</p> <p><b>BUTTON FUNCTIONS</b></p> <ol style="list-style-type: none"><li>1. Long Press the  button to turn on/off the speaker.</li><li>2. Press the  button to play/pause playback, answer an incoming phone call/end call.</li><li>3. Long press the  button to reject a phone call</li><li>4. Press the  button to skip to the previous track. Long press the  button to decrease volume.</li><li>5. Press the  button to skip to the next track. Long press  button to increase volume.</li><li>6. Press the  button to control LED light.</li></ol> <p><b>BLUETOOTH PAIRING</b></p> <ol style="list-style-type: none"><li>1. Power the speaker ON. A tone will be heard and the speaker will enter Bluetooth pairing mode. The LED indicator will flash Blue</li><li>2. Set your mobile device to search for Bluetooth devices. When it appears, select <b>ARCYBR100</b> from the list of found devices.</li><li>3. After a successful pairing, a tone will be heard, and LED indicator will turn Solid Blue.
