

- 1 Scan the QR code or download the **Nexxt Home** app from Google Play or Apple App Store.




- 2 Connect your mobile device to a 2.4GHz Wi-Fi network.



Note: Smart siren only supports the 2.4GHz networks.


- 3 Launch the **Nexxt Home** app and follow the in-app instructions to connect the siren first to your home network. Then add motion and door sensors and execute the same installation steps as the siren.




- 2 Conecta tu dispositivo móvil a una red Wi-Fi de 2.4GHz.
