GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The *Cubix Latin America, LLC*'s product, model number: *PQ5 (FCC ID: 2ACDEMP3G-PQ5)* or the "EUT" in this report was a *GSM and WCDMA Mobile Phone,* which was measured approximately:14.8 cm (L) x 7.5 cm (W) x 0.9 cm (H), rated with input voltage: DC 3.8 V rechargeable Li-ion battery or DC5.0 V from adapter.

Adapter Information: Model: SC050100-US Input: AC100-240V, 50/60Hz, 0.4A Output: DC 5.0V, 1000mA

Note: the product, series model QSP-500Q-S, QSP-500Q-K, QSP-500Q-B, QSP-500Q-G, QSP-500Q-W and PQ5 are identical schematics, the only difference among them is their model number due to marketing purpose. Model *PQ5* was selected for fully testing, which was explained in the attached product similarity declaration letter.

*All measurement and test data in this report was gathered from production sample serial number: 1503067 (Assigned by Shenzhen BACL). The EUT supplied by the applicant was received on 2015-03-11

Objective

This test report is prepared on behalf of *Cubix Latin America, LLC in* accordance with Part 2-Subpart J, Part 15-Subparts A, B and C of the Federal Communication Commissions rules.

The tests were performed in order to determine compliance with FCC Part 15, Subpart C, section 15.203, 15.205, 15.207, 15.209 and 15.247 rules.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4-2009, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.91 dB for 30MHz-1GHz, and 4.92 dB for above 1GHz, 1.95dB for conducted measurement.

Test Facility

The test site used by Bay Area Compliance Laboratories Corp. (Shenzhen) to collect test data is located on the 6/F, the 3rd Phase of WanLi Industrial Building, ShiHua Road, FuTian Free Trade Zone Shenzhen, Guangdong, China.

Test site at Bay Area Compliance Laboratories Corp. (Shenzhen) has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on December 06, 2010. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2009.

The Federal Communications Commission has the reports on file and is listed under FCC Registration No.: 382179. The test site has been approved by the FCC for public use and is listed in the FCC Public Access Link (PAL) database.




Measurement Uncertainty






Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR 16-4-2:2011, the expended combined standard uncertainty of radiation emissions at Bay Area Compliance Laboratories Corp. (Shenzhen) is 5.91 dB for 30MHz-1GHz, and 4.92 dB for above 1GHz. And this uncertainty will not be taken into consideration for the test data recorded in the report.



The radiated emission tests were performed in the 3 meters, using the setup accordance with the ANSI C63.4-2009. The specification used was the FCC 15.209 and FCC 15.247 limits.

The adapter was connected to a 120 VAC/60 Hz power source.

Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All final data was recorded in Quasi-peak detection mode for frequency range of 30 MHz -1 GHz and peak and Average detection modes for frequencies above 1 GHz.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain

The "**Margin**" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:





BDR (GFSK): Number of Hopping Channels

FCC §15.247(d) - BAND EDGES TESTING
