





## 4. TEST CONDITIONS AND RESULTS

#### 4.1. AC Power Conducted Emission

#### **TEST CONFIGURATION**



#### **TEST PROCEDURE**

- 1, The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10.
- 2, Support equipment, if needed, was placed as per ANSI C63.10.
- 3, All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10.
- 4, If a EUT received DC power from the USB Port of Notebook PC, the PC's adapter received power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
- 5, All support equipments received AC power from a second LISN, if any.
- 6, The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7, Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.






(A) Radiated Emission Test Set-Up, Frequency Below 30MHz




(B) Radiated Emission Test Set-Up, Frequency below 1000MHz

#### **TEST CONFIGURATION**

- 1. The EUT was placed on a turn table which is 0.8m above ground plane when testing frequency range 9 KHz –25GHz.
- Maximum procedure was performed by raising the receiving antenna from 1m to 4m and rotating the turn table from 0<sup>∞</sup> to 360<sup>∞</sup> to acquire the highest emissions from EUT.
- And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 4. Repeat above procedures until all frequency measurements have been completed.
- 5. The EUT minimum operation frequency was 26MHz and maximum operation frequency was 1910MHz.so radiated emission test frequency band from 9KHz to 25GHz.
- 6. The distance between test antenna and EUT as following table states:



- This test was performed with EUT in X, Y, Z position and the worse case was found when EUT in X position. 1.
- 2. GFSK were tested at Low, Middle, and High channel and recorded worst mode at Low Channel.
- Radiated emission test from 9 KHz to 10th harmonic of fundamental was verified, and no emission found except system noise floor in 9 KHz to 30MHz and not recorded in this report.
