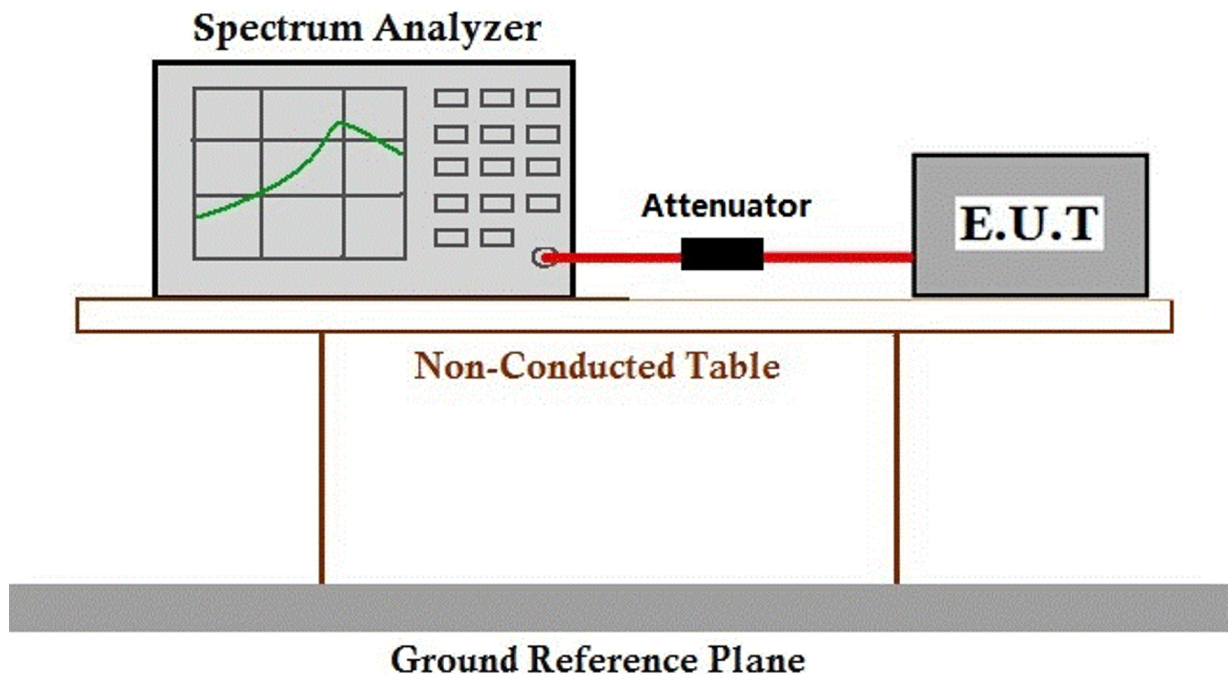

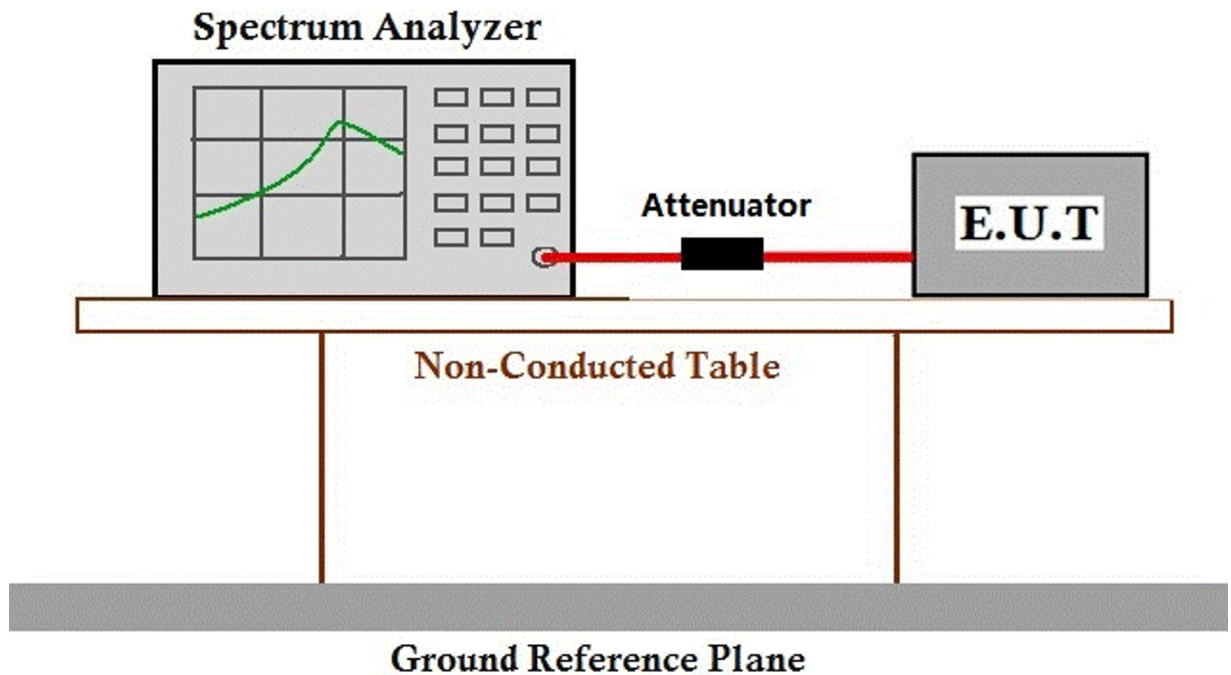

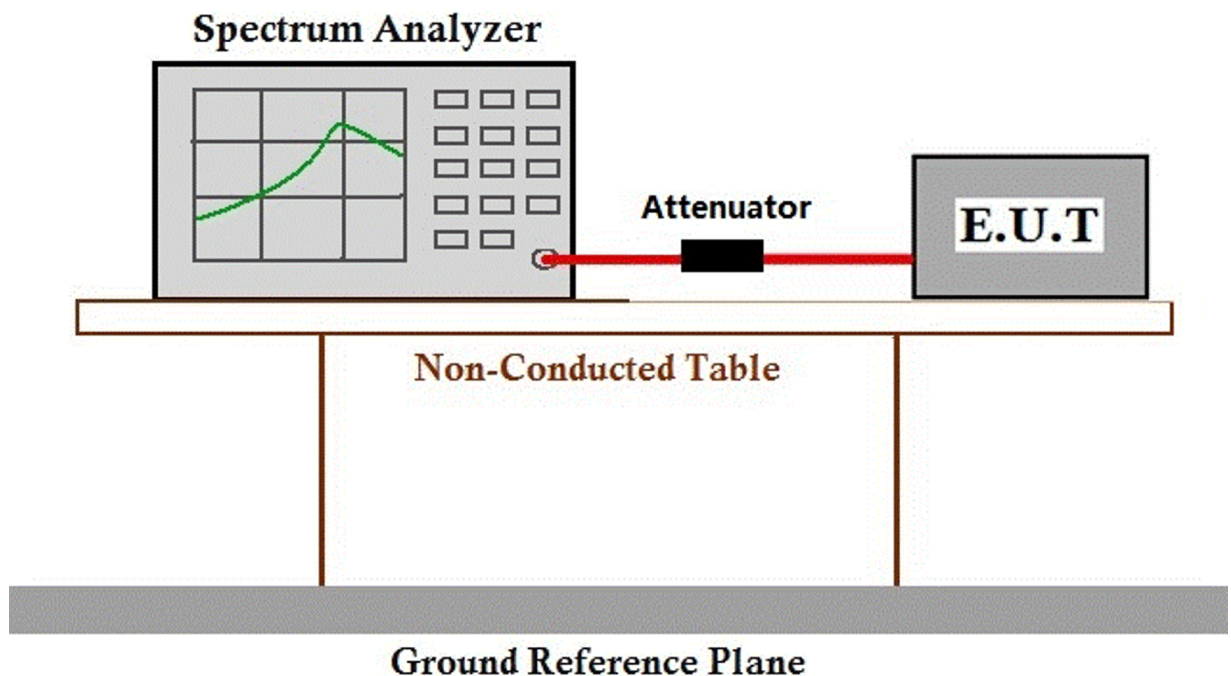

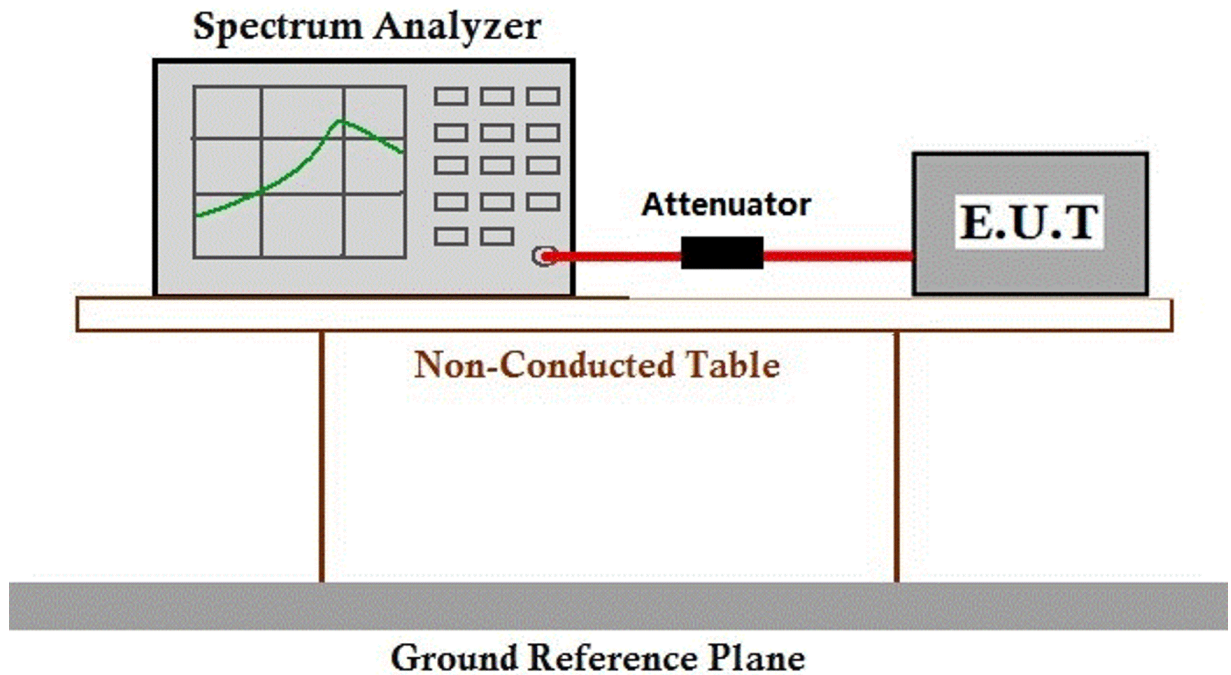

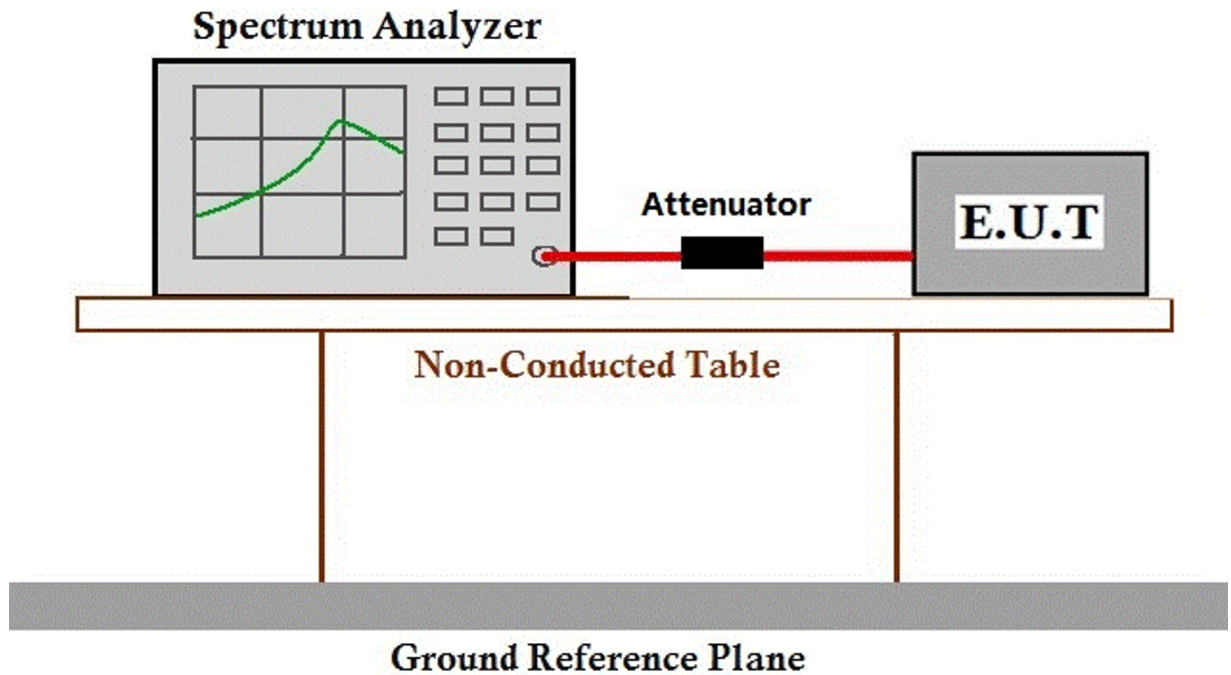

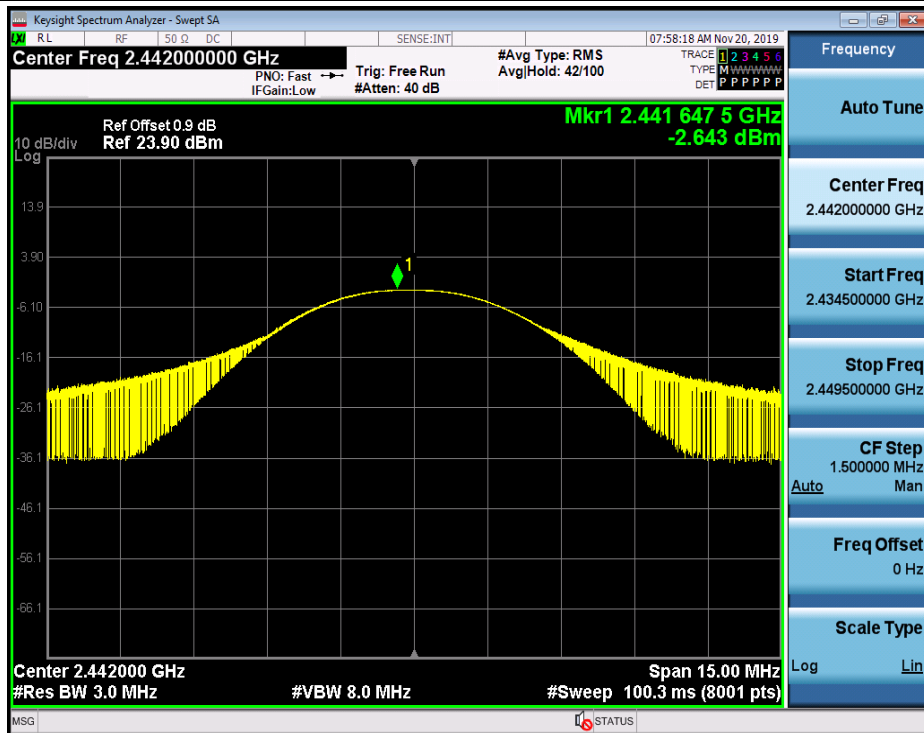

Maximum peak conducted output power_BLE_2402_Ant1



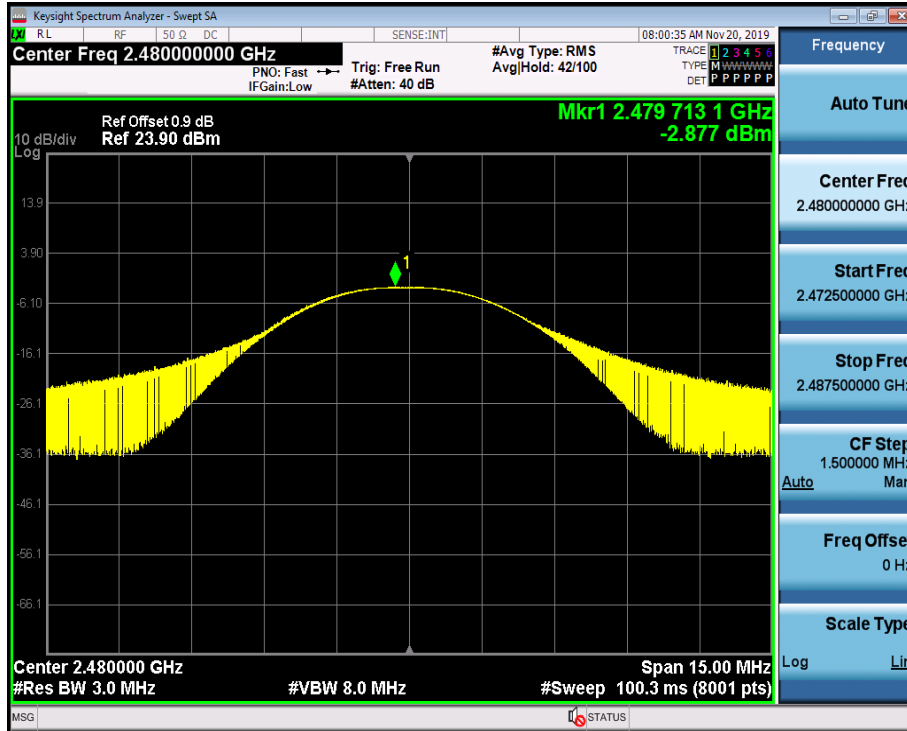
Maximum peak conducted output power_BLE_2442_Ant1

Maximum peak conducted output power_BLE_2480_Ant1

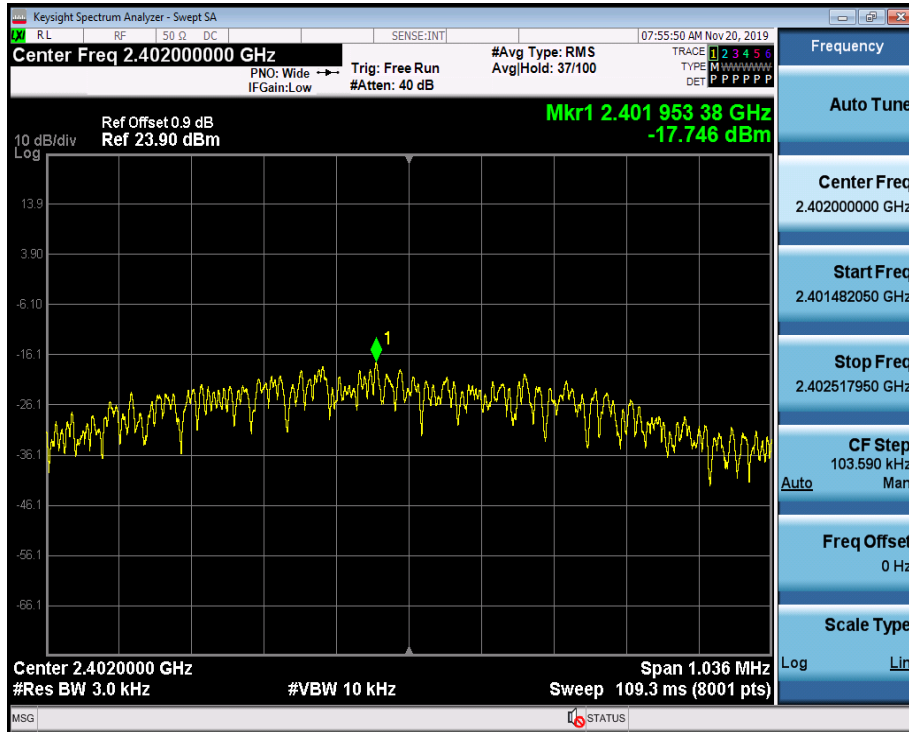

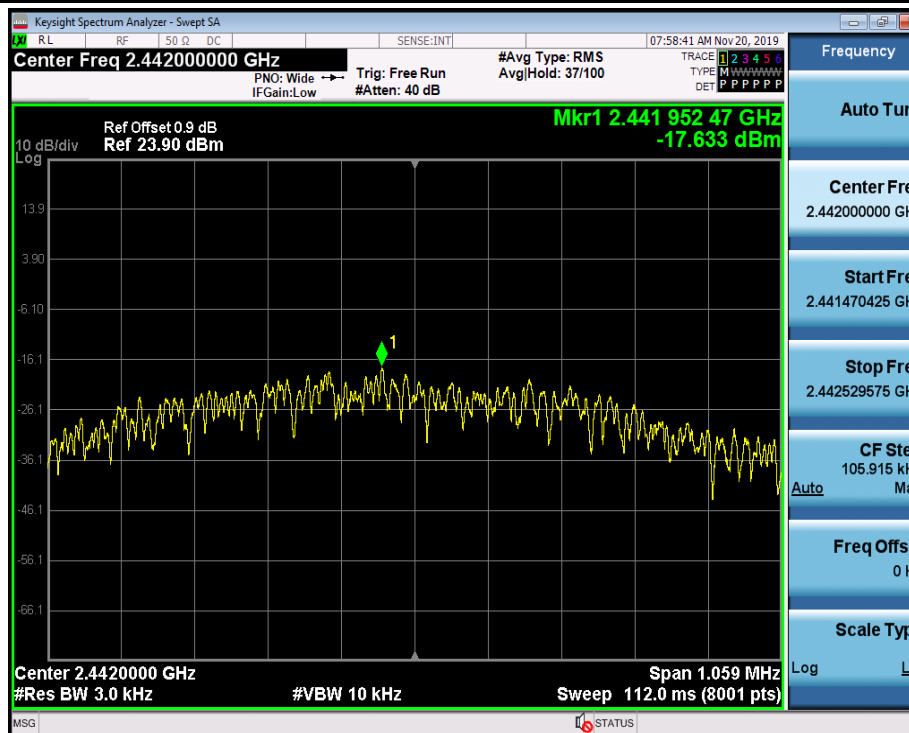

Maximum Peak power spectral density_BLE_2402_Ant1

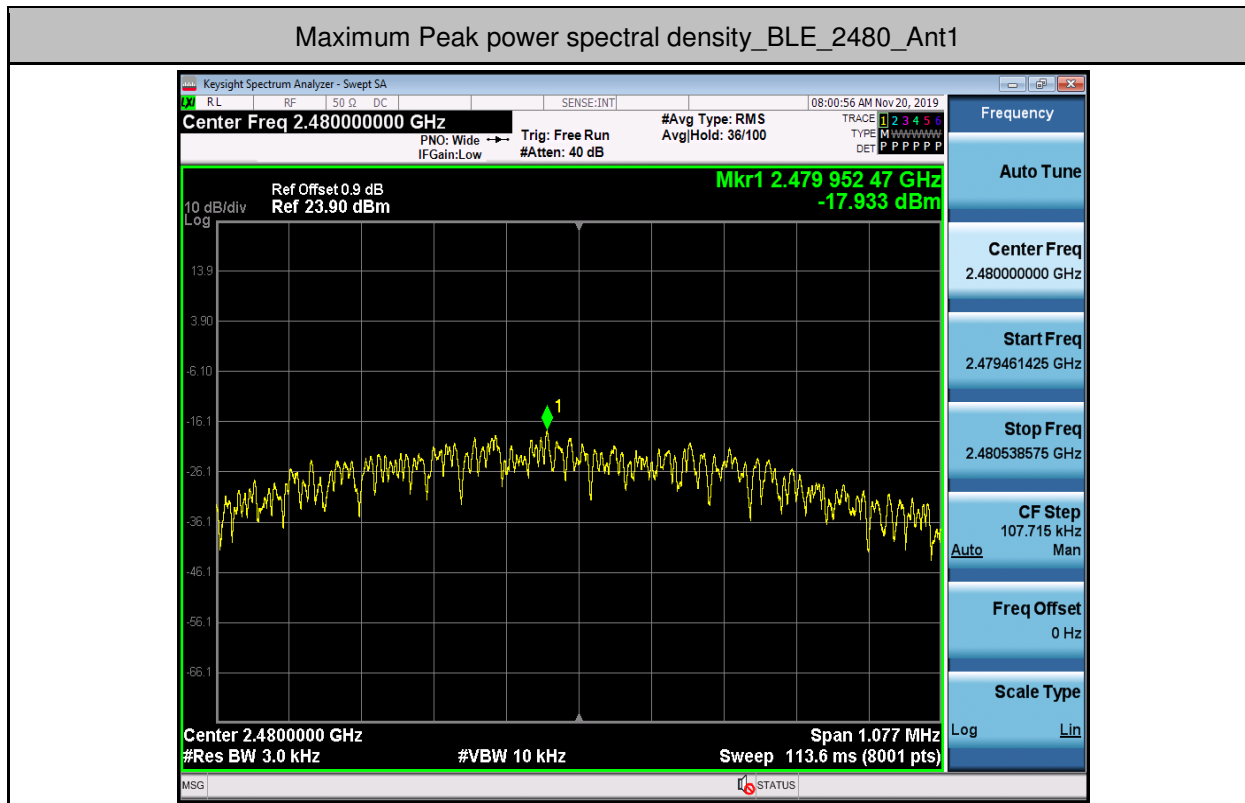


Maximum Peak power spectral density_BLE_2442_Ant1
