Band13-5MHz-QPSK-23255-1RB#0-Range3:1000~10000MHz

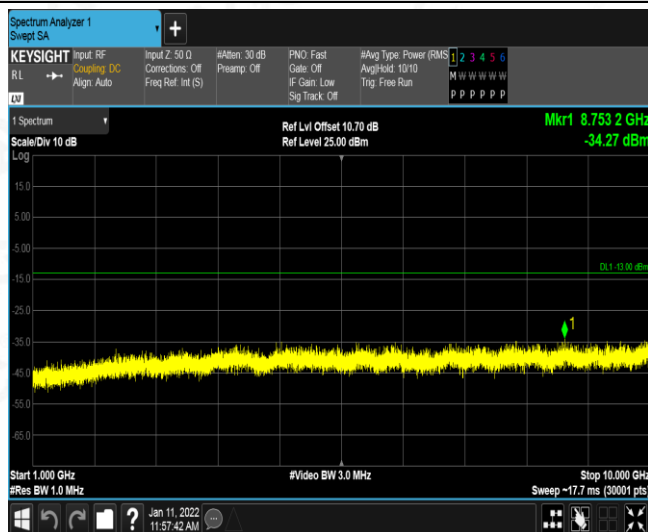

Band13-5MHz-16QAM-23205-1RB#0-Range5:1559~1610MHz

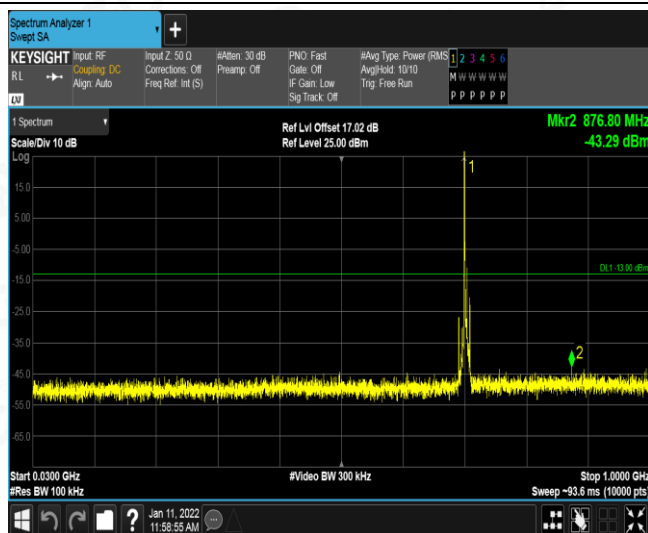

Band13-5MHz-16QAM-23230-1RB#0-Range2:1000~10000MHz

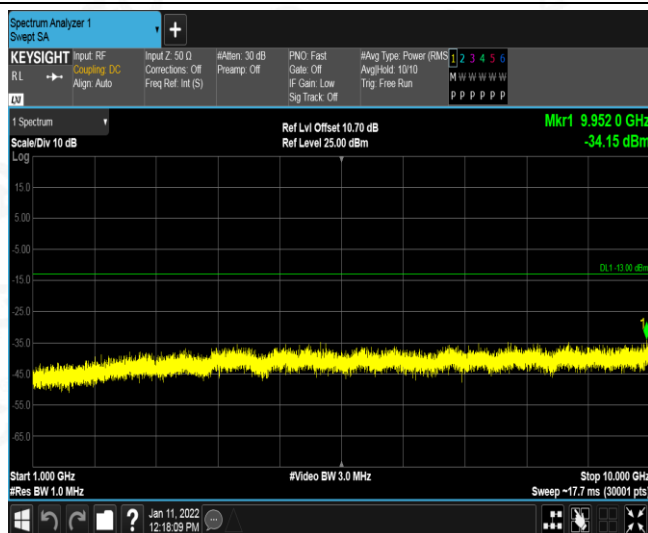

Band13-5MHz-16QAM-23255-1RB#0-Range4:793~805MHz

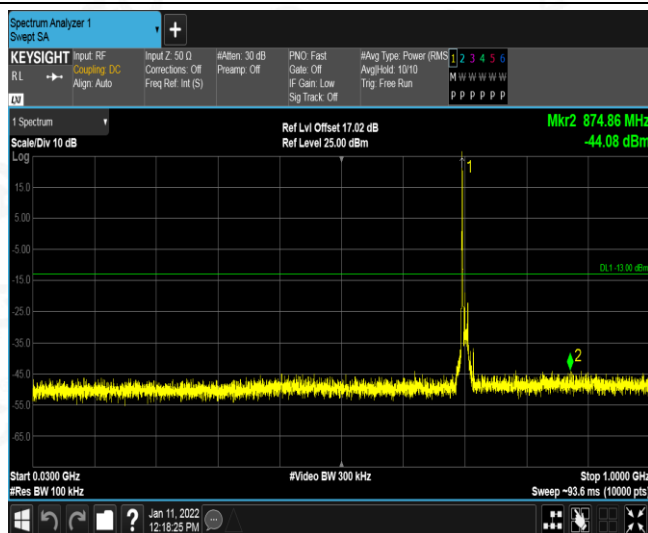

Band13-10MHz-16QAM-23230-1RB#0-Range4:793~805MHz

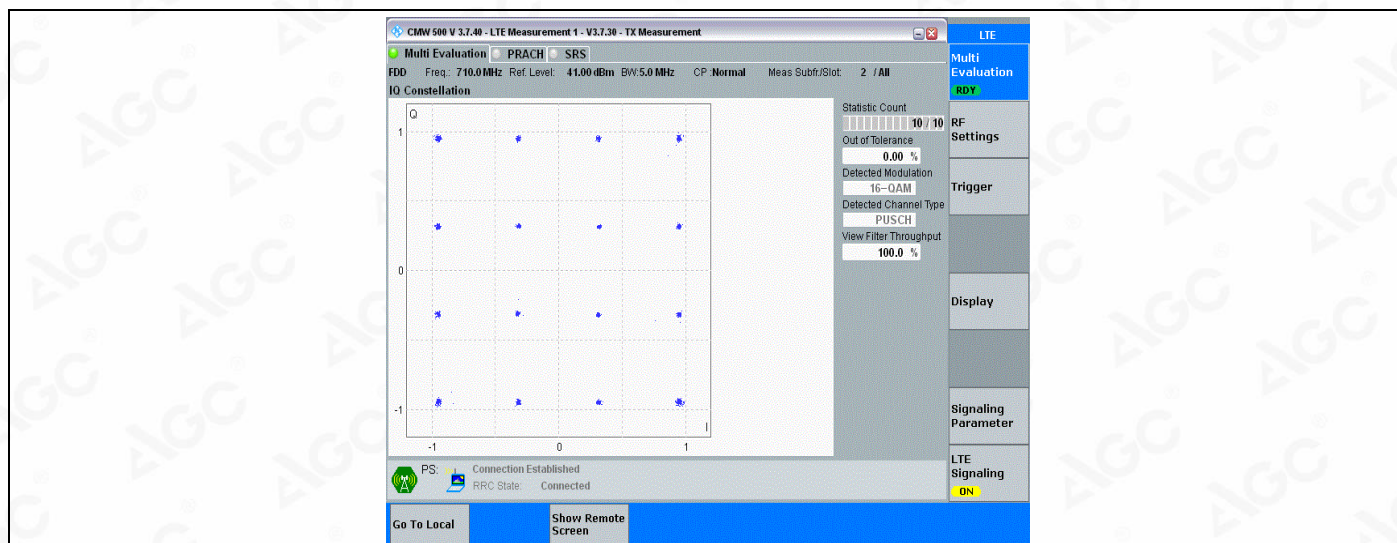

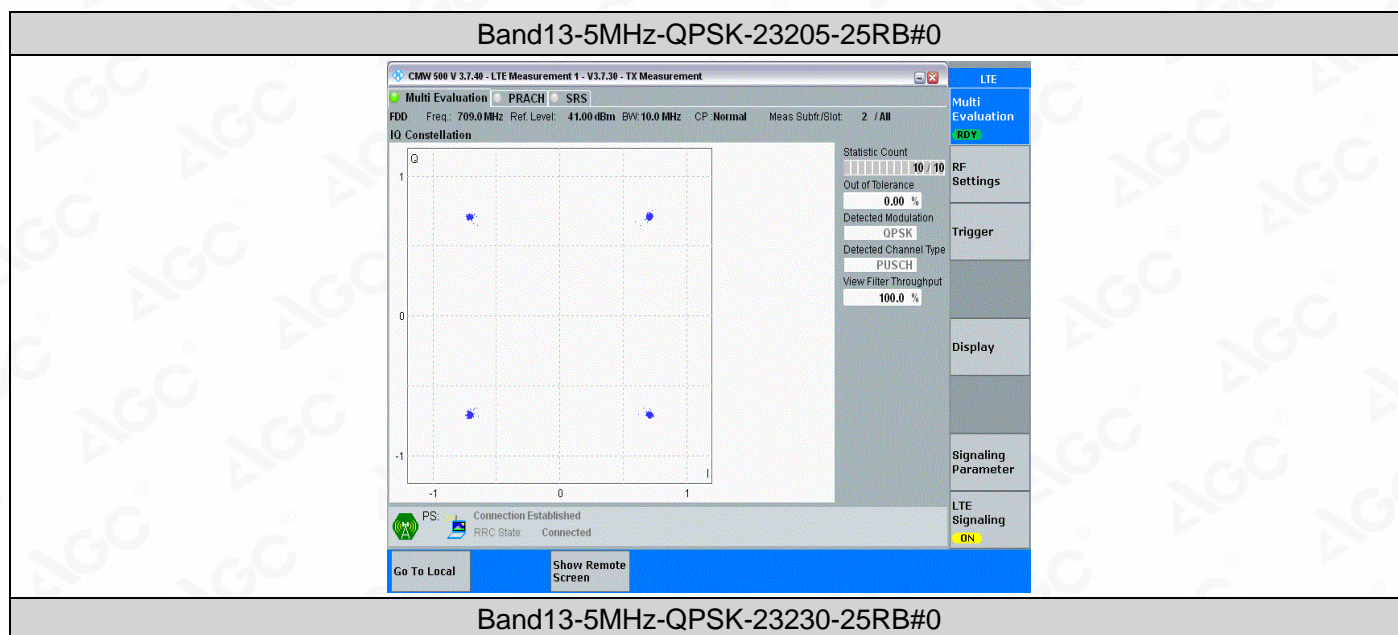

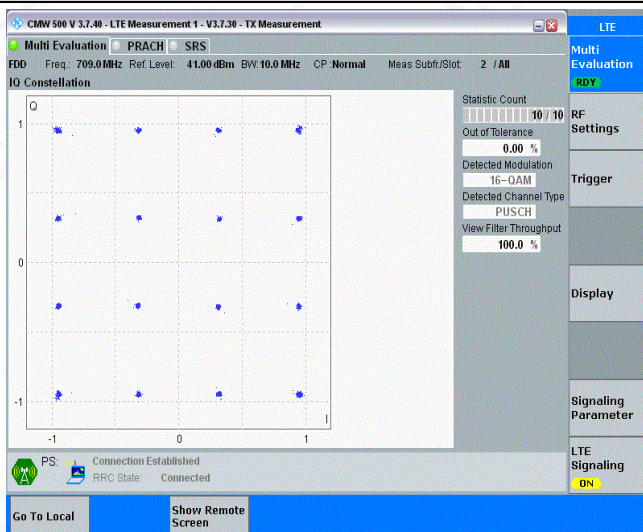




Band13-5MHz-QPSK-23255-25RB#0

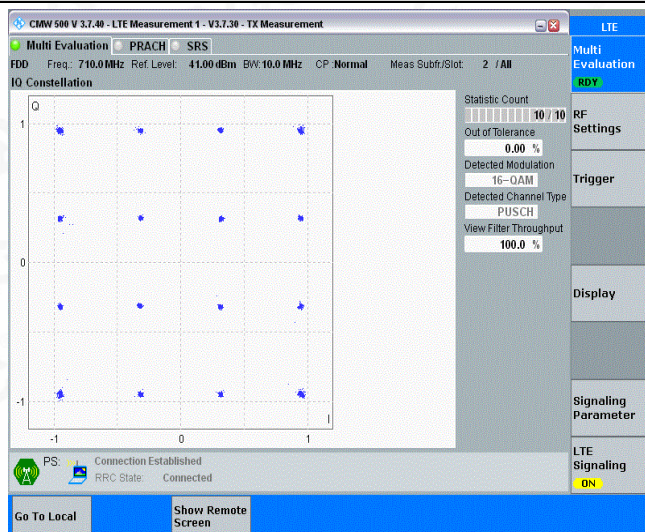

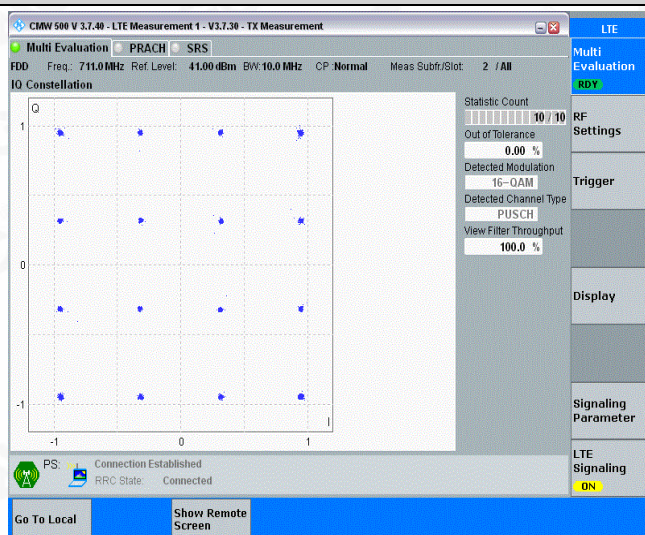
