Band41-5MHz-16QAM-39675-25RB#0

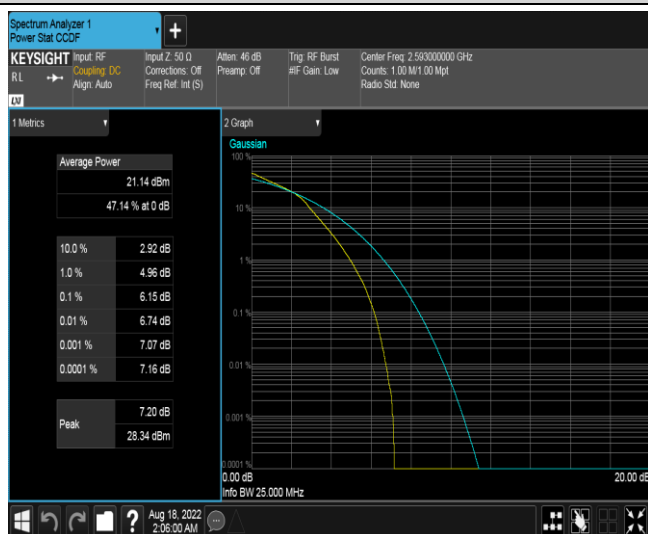


Band41-5MHz-16QAM-40620-1RB#0

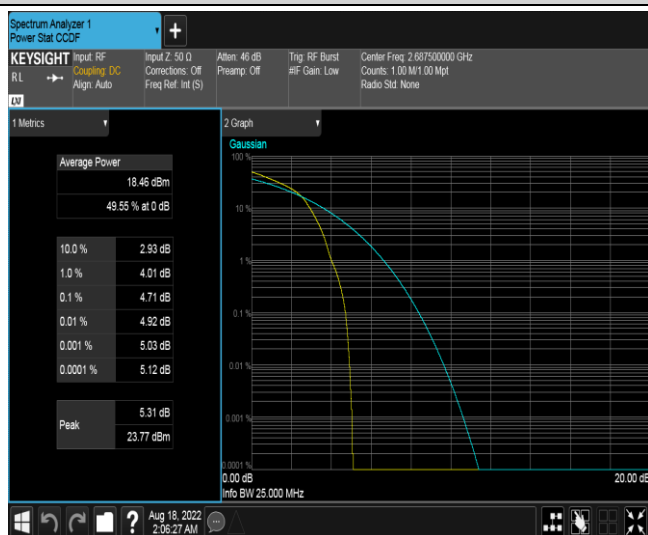

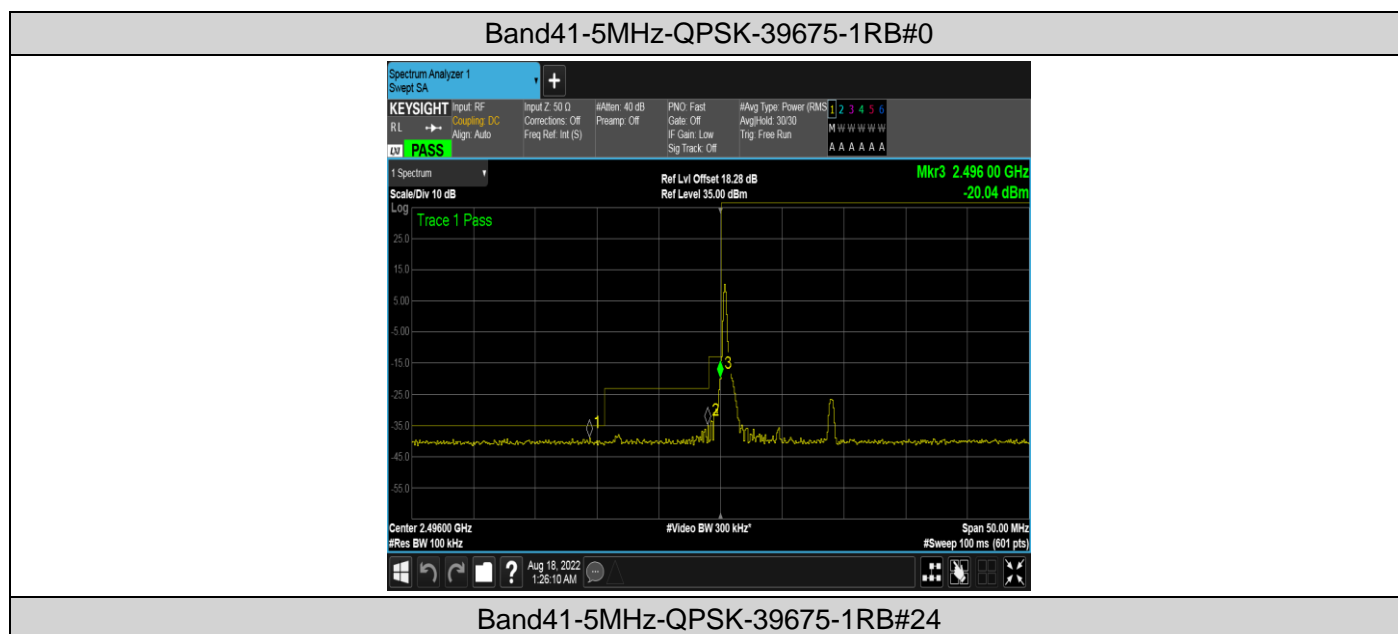
